PARAMEDIC CREW RESPONDS

The three members of the paramedic crew who were on duty this past Friday and dealt with the assistant starter who was injured prior to the start of the fifth race, came to the office to discuss possible ways to improve the response time to the patient. They were asked why they drove the ambulance from the outside rail of the main track to the inside rail rather than taking the gurney with them. They said that moving the apparatus over the synthetic track was nearly impossible and they thought it would be quicker to get the vehicle as close to the patient as they could. Other items regarding human and equine safety were also discussed.

VIDEO REVIEW

Jockeys Kayla Stra and Mario Gutierrez were in the office this morning to discuss the third race from Saturday (6 furlongs on turf), during which fellow jockey David Flores had to check sharply in the far turn while in close quarters along the rail. Mr. Flores was also in attendance. After viewing all angles, none of which were conclusive, all three had the same

opinion – no one to shoulder blame but rather an unfortunate set of circumstances created the problem.

STEWARDS' INQUIRY

The Stewards posted the inquiry sign after the fourth race to review an incident in deep stretch involving the fourth and seventh place finishers, #7 Well Lawyered(R. Bejarano) and #4 Secretsatmidnight(M. Garcia). After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the incident the Stewards unanimously voted to disqualify Well Lawyered from fourth to seventh position. Video showed the horse stepping out after being struck with the left hand whip, forcing jockey Garcia to take up for several strides in order to avoid heels. He and his mount were narrowly beaten two noses for a money position and undoubtedly were cost the opportunity for a better placing.

CLAIM VOIDED

The claim of the horse "Eight Stitches" from the sixth race this afternoon by trainer Peter Miller was declared void as the horse was off in the left front while under observation in the receiving barn. The horse was returned to the barn of Jeff Bonde.

VIDEO REVIEW

Jockey Rafael Bejarano was in the office this morning to review the fourth race from this past Monday, as his mount was disqualified for interference during the stretch run.(Ref. 11-11-13-4) He was accompanied by Darrell Haire, Western Regional Manager of the Jockeys' Guild. After review of the race and discussion with the rider, it was the unanimous decision to place blame on the horse rather than the rider as the horse ducked out from the left hand whip, giving Mr. Bejarano no time to correct before the interference took place.

RULINGS HRTH #008 & #009

Owner **LUIS ENRIQUEZ**, having failed to respond to charges alleging violation of California Horse Racing Board rule #1876 (Financial

Responsibility-Veterinarian John Araujo-\$287.50), is suspended for violation of California Horse Racing Board #1547 (Failure to Appear).

During term of suspension, all licenses and license privileges of Luis Enriquez are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Enriquez is denied access to all premises in this jurisdiction.

Owner **ANNA ARREAGA**, having failed to respond to charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility-Veterinarian Amy Seim-\$746.00), is suspended for violation of California Horse Racing Board #1547 (Failure to Appear).

During term of suspension, all licenses and license privileges of Anna Arreaga are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Ms. Arreaga is denied access to all premises in this jurisdiction.

These rulings were issued as neither licensee appeared to address allegations of violation of California Horse Racing Board rule #1876(Financial Responsibility).

NEW APPRENTICE

Nineteen-year-old Drayden VanDyke, from Louisville, KY, was approved for an apprentice jockey's license this morning and will make his debut this coming Sunday for his employer, Tom Proctor. He has galloped for Proctor for two years and can tack 105 lbs. Jockey Guild representatives Mike Smith and Aaron Gryder signed off on Drayden's card.

REFUND

A refund was ordered in the seventh race as #2 A Toast to You unseated jockey Mario Gutierrez shortly after stepping on the track and ran off the wrong way of the track. The refund amounted to \$43,836.72

Apprentice jockey Irving Orosco was excused from his mounts this afternoon due to illness, while Edwin Maldonado was excused mid-program after suffering an injury to his foot. Replacement riders were named.

RULING LATS #010 and #011

Groom **ROXANA ARREOLA**, having appeared as ordered, is restored to good standing. Ruling DMTD #020, issued at Del Mar Thoroughbred Club on August 2, 2013, is set aside. Ms. Arreola is also required to sign a testing agreement with the California Horse Racing Board, be evaluated, enter into a contract with the Winners' Foundation and abide by terms specified.

Groom **ANTULIANO QUEVEDO**, having appeared as ordered, is restored to good standing. Ruling DMTD #019, issued at Del Mar Thoroughbred Club on August 2, 2013, is set aside. Mr. Quevedo is also required to sign a testing agreement with the California Horse Racing Board, be evaluated, enter into a contract with the Winners' Foundation and abide by terms specified.

These rulings were issued after both appeared in the office in response to complaints filed against them this past August for a drug related incident . They tested negative for drugs this morning and were put in touch with Winners Foundation. Additionally, the pair have signed a testing agreement with the Board.

STEWARDS' INQUIRY-NO CHANGE

The Stewards posted the inquiry sign after the second race to review an incident near the ¼ pole which involved the last place finisher, #7 Samurai Assault (C. Nakatani). After speaking with all riders involved, taking into account reports from the Patrol Judges and reviewing video of the incident the Stewards unanimously voted to make no change to the original order of finish. The horse was dropping back at the time of the incident and the Stewards felt that his position was not compromised.
