07/10/2014

(1) DUTY STEWARD

Kim Sawyer will attend to morning office issues and record the minutes of this period.

(2) FLORES MEETING (Ref 07-03-14 (3))

Jockey Eswan Flores and his agent R.C. Ebanks met with the Stewards to discuss his test results taken last Sunday and his possibilities to rejoin the jockey colony. Mr. Flores' test was negative. It was the Stewards' decision, after conferring with Supervising Investigator Rick Amieva, that Mr. Flores could return to galloping horses in the morning. He was tested again today and directed to retest on Sunday. He will be allowed to name on horses for opening day at Del Mar. A hearing is set for Sunday July 20th, 2014 at Del Mar.

(3) INQUIRY THIRD RACE (3/4 dirt) BREAKDOWN NO CHANGE

The Inquiry sign was posted after the finish of the race to review an incident approaching the 3/8's marker. The #2 Dark Timbers (Tr. F. Meza) went wrong and was pulled up by jockey Kent Desormeaux. After conversation with the Patrol Judges it was a unanimous decision that no other horses were involved in the incident and the race was made official.

The following ruling was issued after Mr. Macias failed to make financial payments.

LATL RULING #003

OWNER MIGUEL MACIAS, IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY-\$1950.00 TO MOONLIGHT FARMS, INC AND \$463.00 TO TRAINER DANIEL AZCARATE).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF MIGUEL MACIAS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), MIGUEL MACIAS IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

(2) CHACON RULING

The following ruling was issued after Mr. Chacon did not appear for the scheduled hearing.

LATL RULING #004

OWNER PAUL CHACON, HAVING FAILED TO RESPOND TO A COMPLAINT ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY-\$527.11 TO BOB HUBBARD HORSE TRANSPORTATION), IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF PAUL CHACON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), PAUL CHACON IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

(3) SCHNEIDER RULING

The following ruling was issued after Mr. Schneider failed to appear for the scheduled hearing.

LATL RULING # 005

OWNER DAVID SCHNEIDER, HAVING FAILED TO RESPOND TO A COMPLAINT ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY-\$222.00 TO DR. AMY SEIM), IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO

APPEAR).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF DAVID SCHNEIDER ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), DAVID SCHNEIDER IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

(4) HOFMANS-FONTANA RULINGS

The following rulings were issued after both licensees were informed of their penalty. After the trainer entered the horse "Jean Edward" in the 1st race yesterday, owner Richard Fontana chose not to run his horse due to miscommunication between himself and his trainer, David Hofmans, concerning training tactics for his horse's preparation for the race.

LATL RULING # 006

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION), TRAINER DAVID HOFMANS IS FINED TWO HUNDRED DOLLARS (\$200)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE \$1698 (FAILURE TO START AND RUN), CAUSING A LATE DECLARATION FROM THE FIRST RACE ON JULY 10, 2014.

LATL RULING # 007

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION), OWNER RICH FONTANA IS FINED TWO HUNDRED DOLLARS (\$200)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE \$1698 (FAILURE TO START AND RUN), CAUSING A LATE DECLARATION FROM THE FIRST RACE ON JULY 10, 2014.

(5) FILM REVIEW

Jockey Felipe Martinez met with the Stewards to review the eighth race (5 ½ dirt) yesterday. Mr. Martinez, folding into the turn near the 3/8's marker, did not allow sufficient clearance crossing over in front of horses to his inside in a four horse spread, causing contact between those horses. In a unanimous decision, Mr. Martinez was penalized three days in the following ruling.

LATL RULING # 008

JOCKEY FELIPE MARTINEZ IS SUSPENDED FOR THREE (3) RACING DAYS (JULY 17, 18 AND 19, 2014), FOR CROSSING OVER WITHOUT SUFFICIENT CLEARANCE, CAUSING INTERFERENCE ENTERING THE FAR TURN WHILE RIDING TRUELEE SCRAPPIN IN THE EIGHTH RACE ON JULY 10, 2014. THIS CONSTITUTES A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1699 (RIDING RULES-CARELESS RIDING). PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1766 (DESIGNATED RACES) TERM OF SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES.

(1) CAL BRED REPORTS

(2) ROUTINE MORNING

All morning matters were handled with normal procedures.

(3) JOCKEY OBJECTION THIRD RACE (3/4 dirt) NO CHANGE

Following the running of the race, jockey Joe Steiner, aboard #6 Peradventure (3rd) lodged a claim of foul against #4 Story to Tell (J. Talamo 1st) and #1 Bad Read Sanchez (M. Gutierrez 2nd) near the quarter pole, into the stretch. After a conversation with the Patrol Judges, and all jockeys involved, the original order of finish was made official. In the Stewards unanimous opinion, #4 was not involved in the incident, #1 did drift into #6 making slight contact. A few strides later #1 and #6 again bumped which was initiated by both horses. The margin #6 was beat was 3 ½ lengths and in the stewards' opinion this did not effect the order of the finish.
