**Report of the Board of Stewards for the week of July 9, 2015 through July 12, 2015.**

**BEJARANO RULING**

We issued the following ruling when jockey RAFAEL BEJARANO rode the equivalent of a designated out of state while under suspension:

## LATL #12

Jockey RAFAEL BEJARANO is suspended for ONE (1) additional RACING DAY (July 11, 2015) pursuant of California Horse Racing Board rule #1766 (Designated Races – participated in a graded stake race, out of state on July 4, 2015).

**FILM REVIEW**

Jockey FELIPE VALDEZ came to the office to review his ride in seventh race Friday. We observed him using his riding crop five times in succession. He agreed with our assessment and accepted the following penalty:

## LATL #11

Jockey FELIPE VALDEZ is fined THREE HUNDRED DOLLARS (\$300.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - second offense), during the seventh race at Los Alamitos Race Course on July 3, 2015.

Jockey ESWAN FLORES came to this office to review his ride in the seventh race yesterday, during which he stood up around the sixteenth pole, and then got back down to ride after several strides. He finished in a dead heat for second. He claimed that his hamstring cramped and that he stood up briefly to stretch it out. We categorically rejected this defense, and issued the following ruling:

## LATL #13

Jockey ESWAN FLORES is suspended for THREE (3) racing days (July 11, 12 and 16, 2015) for violation of California Horse Racing Board rule #1884 (Unsatisfactory Rides – misjudged finish) while riding DELANEY'S JOY in the seventh race at Los Alamitos Race Course on July 4, 2015.

Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

07/05/15<sup>3</sup>**INQUIRY/NO CHANGE**

The inquiry sign was posted following the running of the seventh race to examine the circumstances surrounding the breakdown of #5 Fonz. Films revealed that the horse was not influenced by any other horses and therefore the race was made official with no change. See attached accident and breakdown reports.

Jockey EFRAIN HERNANDEZ came to the office to review his ride in the second race yesterday. Mr. Hernandez acknowledged that he used his crop five times in succession without giving the horse the chance to respond. He accepted the following ruling:

## LATL #15

Jockey EFRAIN HERNANDEZ is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond) (first offense), during the sixth race at Los Alamitos Race Course on July 5, 2015.

Jockey DRAYDEN VANDYKE came into the office to review his ride in the fourth race yesterday in which his mount ducked out under one left handed strike. While the move was fast, we believed he should be much faster in correcting. He agreed. Warning.

Jockey SAUL ARIAS came to the office to review his ride in the fourth yesterday during which he struck his horse four times in succession. He was issued the following ruling:

## LATL #17

Jockey SAUL ARIAS is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond) (first offense), during the first race at Los Alamitos Race Course on July 9, 2015.

07/10/15<sup>2</sup>**MARQUEZ RULING**

We met with jockey CARLOS MARQUEZ to inquire as to why he called in sick Sunday morning but then rode three horses during the evening quarter horse card. He explained that he simply came in to get his check and realized that his horse was going to be scratched, so he agreed to ride it. Then he picked up two more mounts that came open. We treated his missed mount during the afternoon as a no show and issued the following ruling:

## LATL #16

Jockey CARLOS MARQUEZ is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement), resulting in a late jockey change in the seventh race at Los Alamitos Race Track on July 5, 2015.

A complaint was filed by the CHRB for trainer Kathy Walsh against owner Judith Partridge in the amount of \$37,476.00. By the time the hearing was held the bill has increased to \$58,532.00. This occurred when Ms. Walsh chose to not release the horses until the debt was paid. Ms. Partridge feels she only owes Ms. Walsh \$21,00.00. Present for the hearing, representing the complainant, Kathy Walsh, was her counsel, Lisa J. Brown. Also in attendance was owner Judith Partridge, her bookkeeper Cassie Partridge and her counsel James Knight. After much conversation and not much headway, some suggestions were given to try and close the gap on their opinions of the amount owed. Both parties were informed the BOS would make a decision and a ruling will follow.

**NAKATANI HEARING**

Jockey Corey Nakatani met with the Stewards to discuss his overweight in the eighth race. When Mr. Nakatani weighed out he was three pounds over the assigned weight listed in the program. He stated that he called an hour before first post and told the Clerk of Scales, Charles McCaul his weight was ok. He also stated he got stuck in traffic and tried to reduce after his late arrival. Per an agreement with the jockey colony and the Jockey's Guild representative Darrell Haire at Santa Anita, they (the jockeys) agreed to be penalized this amount if they failed to report their overweight or were late for a race. The following ruling was issued.

**RULING #18**

Jockey COREY NAKATANI, is fined FIVE HUNDRED DOLLARS (\$500.00)\* for failure to report the proper riding weight for the eighth race at Los Alamitos Race Track on July11, 2015. This constitutes a violation of California Horse Racing Board rule #1682 (Weighing Out).

07/12/15<sup>2</sup>**FILM REVIEW**

Jockey Cayetano Chaparro was in to review the third race. Mr. Chaparro, entering the stretch in the third race (5/8), used the crop on his horse four consecutive times thus violating CHRB rule 1688 ( Use of Riding Crop). Mr. Chaparro was a refreshing breath of air, he admitted he made a mistake and accepted the penalty.

**RULING #19**

Jockey CAYETANO CHAPARRO is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - first offense), during the third race at Los Alamitos Race Course on July 11, 2015.

Jockey Ramon Guce met with the BOS to review the third race. Mr. Guce dropped inward leaving the gates from the ten post position to the fence while marginally clear. He stated he thought he was clear when he angled in. The stewards felt the incident was not penalty worthy and he was issued a warning. Unfortunately in the fourth race Mr. Guce used the crop more than three times consecutively leaving the gates and the following ruling was issued.

**RULING #20**

Jockey RAMON GUCE is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - first offense), during the fourth race at Los Alamitos Race Course on July 11, 2015.

Jockey Aaron Gryder in the stretch of the ninth race (5/8), whipped his mount four consecutive times. He accepted the penalty and the following ruling was issued.

**RULING #22**

Jockey AARON GRYDER is fined TWO HUNDRED DOLLARS (\$200.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond - first offense), during the ninth race at Los Alamitos Race Course on July 11, 2015.
