Report of the Board of Stewards for the week of October 14, 2008 through October 19, 2008.

**TUESDAY**  
10/14/2008

(1) DUTY STEWARD

James Dreyer will record the minutes and oversee morning situations during this reporting period.

(2) SCRATCHES

Scratch time for Thursday resulted in one scratch.

(3) CAL-BRED REPORT

The third race in the book for Friday, two year olds for a claiming price of \$5,000, was called off with three entries.

(4) THE DRAW

Ten races will be offered Friday evening including one Arabian, three Thoroughbred and six Quarter Horse races. The Los Alamitos Super Derby Trials will comprise four of the Quarter Horse races.

(1) SCRATCHES

Two scratches, one rider and one equipment change completed Friday's changes.

(2) CAL-BRED REPORT

No CAL-BRED race was offered Saturday, anticipating a full program of futurity trials.

(3) THE DRAW

Saturday evening's entire program will be encompassed by the Golden Gate Million Futurity Trials.

**THURSDAY**

10/16/2008

(1) SCRATCHES

Scratch time for Saturday resulted in one rider change.

(2) CAL-BRED REPORT

The seventh race in the book for Sunday, three year olds and up claiming \$2,000, was called off with two.

(3) THE DRAW

One Arabian, three Thoroughbred and six Quarter Horse races will be presented Sunday evening.

(4) ELOY NAVARRO RULINGRULING # 249

TRAINER ELOY NAVARRO IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1629 (PENALTY FOR LATE DECLARATION – NO FOAL PAPERS IN RACING OFFICE)) ON SUNDAY, OCTOBER 12, 2008.

Following a telephonic conversation with trainer Eloy Navarro, in which he reluctantly accepted responsibility for not having the registration papers on "Zoomin Eye Catcher" in the racing office, the foregoing ruling was issued.

(5) PAUL AGUIRRE RULINGRULING # 250

TRAINER PAUL AGUIRRE IS FINED THREE HUNDRED DOLLARS (\$300.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1581.1 (A) (ENTRIES-ENTERING AN IN TODAY HORSE IN A SUBSEQUENT RACE) ON SATURDAY, OCTOBER 11,2008.

After contacting trainer Paul Aguirre telephonically the above ruling was issued. "Atlantic Star" was on the program in Fresno on Friday and was entered at Los Alamitos on Saturday, a violation of California Horse Racing Board rule # 1581.1 (a). Mr. Aguirre explained that the horse had been given Clenbuterol and that the Friday race was too close to the administration of the drug. Although the decision to scratch on Friday was a wise move on his part, the violation still occurred and the ruling was issued.

(6) FILMS

Jockey Cody Jensen was in to review the sixth race Saturday evening in which his pickup mount "BF End Game" was disqualified from fifth and placed sixth. The films confirmed Cody's contention that he had made a valiant effort and days were not warranted.

(7) INQUIRY – 4<sup>TH</sup> RACE – REFUND

At the conclusion of the fourth race the Inquiry was posted by the Stewards to examine the start. "Olympic Moment," # 5, appeared to have his head cocked over the bar when starter Baker dispatched the field. Jockey Cesar De Alba explained the assistant starter pulled "Olympic Moment's" head into his lap. After speaking with Baker he confirmed De Alba's scenario up to that point. Baker said he then yelled to point the horses which the assistant apparently did not hear as the horse's head was still cocked when Baker dispatched the field. Under the circumstances the Stewards felt "Olympic Moment" should be declared a non-starter and all the money wagered on him should be refunded.

(8) OBJECTION – NO CHANGE

Following the fifth race jockey Dionicio Navarro on # 6 "Aspen High" lodged an objection against # 4 "Gasin The Turbo" and jockey Chris Russell. After speaking with the riders involved and reviewing the films, the Stewards felt the alleged interference going into the turn never occurred and voted unanimously to make no change.

Saturday's scratches resulted in one equipment change and four rider changes.

(2) RULINGS # 251 & # 252 (CASE#S 08LA0198 & 08LA0199)

RULING # 251

ASSISTANT STARTER EZEQUIEL VILLEGAS IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1481 (11) (OCCUPATIONAL LICENSES AND FEES – SHOING WITHOUT A LICENSE).

RULING # 252

TRAINER ROBERTO RAMIREZ IS FINED THREE HUNDRED DOLLARS (\$300.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1895 (TRAINER'S DUTY TO INSURE LICENSED PARTICIPATION – EMPLOYING AN UNLICENSED HORSESHOER).

Both of the above cases were heard simultaneously because of their relationship to one another. Assistant starter Villegas admitted he was shoeing "Hawaiian Lyon" without the proper license and assured us it would not be repeated. Trainer Roberto Ramirez accepted full responsibility as the trainer of record. At the conclusion of the informal hearing, the foregoing rulings were issued.

(3) FILMS

Jockey Jorge Cortes was in to review the first race from last Saturday evening. His mount, # 5 "Eye Can Win," broke out and Jorge's response time left a lot to be desired. Although he reacted rather slowly the Stewards felt a warning would suffice.

(4) FILMS

Jockey Ramon Sanchez was in to review the same race we had Jorge Cortes in for. Ramon's mount, # 8 "Withers," broke in adding to the problems of # 6 and # 7 created by Cortes' mount. Ramon did a commendable job and no action on our part was necessary.

(5) OBJECTION – 1<sup>ST</sup> RACE – NO CHANGE

Dionicio Navarro on # 7 "Melair" (3<sup>rd</sup>) lodged an objection against # 8 "Marsalama" (2<sup>nd</sup>) ridden by apprentice Cheryl Charlton. Dionicio contended that Cheryl's mount interfered with his mount at approximately the eighth pole. After listening to the riders' input and reviewing the films, the Stewards felt that although there was contact, the outcome of the race was not compromised. The vote to make no change was unanimous.
