OWNER JEREMY KELTON IS SUSPENDED THIRTY (30) DAYS (SEPTEMBER 24, 2009 THROUGH OCTOBER 23, 2009) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1891 (SEIZURE OF CONTRABAND) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1890 (POSSESSION OF CONTRABAND).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JEREMY KELTON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

TRAINER DEAN FREY WHO STARTED THE HORSE "BESSEMER" IN THE THIRD RACE AT THE ALAMEDA COUNTY FAIR ON JULY 18, 2009, HAVING ENTERED INTO A STIPULATED AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD, IS FINED THREE THOUSAND DOLLARS (\$3,000)* AND SUSPENDED FOR THIRTY (30) DAYS (SEPTEMBER 27, 2009 THROUGH OCTOBER 26, 2009) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A)(D) (MEDICATION, DRUGS AND OTHER SUBSTANCES - GABAPENTIN - CLASS III), #1844 (A) (AUTHORIZED MEDICATION), #1859.5 (DISQUALIFICATION UPON POSITIVE TEST FINDING), #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE), AND #1894 (DUTIES OF TRAINER).

PURSUANT TO THE TERMS OF THE STIPULATED AGREEMENT, TWENTY-FIVE (25) DAYS OF THE SUSPENSION ARE STAYED PENDING THE PASSAGE OF ONE YEAR FROM THE DATE OF THIS AGREEMENT, DURING WHICH TIME THE SUBJECT IS PLACED ON PROBATION AND SHALL NOT HAVE ANY VIOLATIONS FOR CLASS I, II, OR III SUBSTANCES. ACTUAL DAYS SUSPENSION SERVED WILL BE SEPTEMBER 27, 2009 THROUGH OCTOBER 1, 2009.

RULING #185

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE# F05190, TAKEN FROM THE HORSE "BESSEMER", THE SECOND PLACE FINISHER IN THE THIRD RACE AT ALAMEDA COUNTY FAIR RACE COURSE ON JULY 18, 2009, TESTED POSITIVE FOR GABAPENTIN (CLASS III) A PROHIBITED DRUG SUBSTANCE. IT IS ORDERED THAT "BESSEMER" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE (\$1,870) EARNED BY OWNER DEAN R. FREY, TRAINER DEAN R. FREY AND JOCKEY MODESTO LINARES BE RETURNED TO THE PAYMASTER OF PURSES AT ALAMEDA COUNTY FAIR RACE COURSE FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

RULING #186

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1900 (GROUNDS FOR SUSPENSION OR REVOCATION) GROOM JAIRO OLIVA, IS SUSPENDED THIRTY DAYS (30) (SEPTEMBER 26, 2009, THROUGH OCTOBER 25, 2009), FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (H) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE – USE OF AMPHETAMINE).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF SUBJECT ARE SUSPENDED, AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

FURTHERMORE, AS A CONDITION OF REINSTATEMENT JAIRO OLIVA SHALL SHOW PROOF OF A RECOVERY PROGRAM ACCEPTABLE TO THE STEWARDS AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD. SUBJECT IS PLACED ON PROBATION THROUGH THE TERM OF HIS LICENSE.

Jockey Alex Bautista came before the Stewards to review the fourth race on September 20, 2009 (Quarter Horse – 300 yards). Mr. Bautista rode #7 “Double Royal Miracle”. Stewards questioned him as to why a whip was carried but not used. Jockey Alex Bautista commented that as “Double Royal Miracle” has bucked in the past; jockeys do not like to use a whip on him. Upon review of “Double Royal Miracle’s” previous four races Stewards saw that riders have not used their whips. Bautista was advised to have his trainer speak to the Stewards on a solution to California Horse Racing Board rule #1688 (a).
