TUESDAY

04/06/2010 (1) DUTY STEWARD

The second race in the book for Friday, three and four year old maidens for \$2,500, was used open after failing to entice a sufficient number of Cal-Breds.

Friday evening will offer two Thoroughbred and six Quarter Horse races with the feature being the \$214,400 "El Primero De Ano Derby."

TRAINER SERGIO FISCAL IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1845 (AUTHORIZED BLEEDER MEDICATION - HORSE NOT REGISTERED AT TIME OF ENTRY) ON MARCH 18, 2010.

The foregoing ruling was issued following an informal hearing attended by Sergio Fiscal and the Board of Stewards. Sergio explained that he was under the assumption his vet had turned in the needed paperwork. He assured us that in the future he will follow the paper trail more closely.
