TUESDAY

02/22/2011

(1) DUTY STEWARD

The second race in the book failed to fill with five Cal-Breds and went open. The fourth race in the book went Cal-Bred with eight entries.

(2) DOMINGUEZ RULING

RULING #38

GROOM MARTIN G. DOMINGUEZ IS FINED TWENTY-FIVE DOLLARS (\$25.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS -UNAUTHORIZED VISITOR).

The foregoing ruling was issued after groom Martin Dominguez appeared as requested concerning his harboring an unlicensed person in his tack room overnight.

(3) CRUZ RULING

RULING #39

JOCKEY JOEL CRUZ, WHO RODE "WARREN'S CARLIE" IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, FEBRUARY 20, 2011, IS SUSPENDED THREE (3) RACING DAYS (MARCH 4TH, 5TH AND 6TH, 2011) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM THIRD TO SIXTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after jockey Cruz met with the Stewards to discuss his ride in the sixth race on Sunday February 20, 2011. The films confirmed that subject made little effort in controlling his mount.

(4) SIRIN HEARING (CASE #11LA0030)

Trainer Edwin Sirin appeared before the Board of Stewards to explain why he had a high phenylbutazone reading. Subject offered that the horse was not treated by him or his veterinarian. However, a worker laying tile in his tack room observed an unidentified person milling around the shedrow. Later a syringe was found in the area. Further investigation will be conducted before a decision will be reached.

(5) SECOND RACE – INQUIRY - ACCIDENT

The Stewards immediately posted the Inquiry during the running of the second race to review an incident which occurred shortly before the finish. #7 "Filled With Hope" (Trainer V. Zamudio – jockey C. De Alba) went wrong and unseated jockey De Alba. The human ambulance was quickly on the scene to take jockey De Alba to La Palma Hospital for observation. Track Veterinarian Tom Hackathorn reported that the horse fractured his right foreleg and was euthanized.

(2) MILLER RULING (CASE #11SA003)RULING #40

TRAINER PETER MILLER IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1689 (SAFETY HELMETS REQUIRED), #1922 (IDENTIFICATION REQUIRED), #1930 (OBEDIENCE TO SECURITY OFFICERS AND PUBLIC SAFETY OFFICERS), #1510 (KNOWLEDGE OF RULES) AND #1874 (DISORDERLY CONDUCT) ON DECEMBER 26, 2010 AND DECEMBER 28, 2010.

The foregoing ruling was issued after subject was afforded a telephonic hearing to address a complaint concerning alleged violation of California Horse Racing Board rules #1689 (Safety Helmets Required), #1930 (Obedience to Security Officer) and #1874 (Disorderly Conduct). The reason for this stiff penalty was for his defiant attitude towards authority. Subject vowed to be more cooperative and apologized for his actions.
