TUESDAY

03/29/2011

(1) **DUTY STEWARD**

(2) **ENTRIES AND DRAW**

Entries closed late (4:30 p.m.) as has been the norm for the past several weeks, however a ten race program was eventually drawn and the resulting card will consist of six Quarter Horse and four Thoroughbred events.

(1) CAL-BRED REPORT

The second race in the condition book for California-bred maiden three year olds, claiming price \$8,000 at 330 yards, failed to fill with no entries and was called off.

The eighth race, for California-bred four year olds and upward, claiming price \$12,500 at a distance of 350 yards, was called off with only one Cal-Bred entry.

(2) SECURITY VIOLATION

Groom Eddy Zoriano appeared along with Los Alamitos Security Officer Keith Hicks before the Board of Stewards to address a Security violation of California Horse Racing Board Rule #1874 (Disorderly Conduct) for intoxication while performing his duties as a groom. Mr. Zoriano said he was watering the horses when he slipped and fell, resulting in an injury to his ankle. When Los Alamitos Security arrived on the scene they reported that Eddy was smelling of alcohol and appeared quite intoxicated. Mr. Zoriano admitted to his transgression and understood that it is against the rules to drink or be intoxicated on the job. The following ruling was issued.

RULING #55

GROOM EDDY R. SORIANO IS FINED FIFTY DOLLARS (\$50.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (INTOXICATED).

(3) ACEVES RULING

The following ruling was issued to jockey Rodrigo Aceves for being late to the Jockey's

Quarters. Rodrigo said he took a nap at home and overslept, accepting full responsibility for his miscue.

JOCKEY RODRIGO ACEVES IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON SUNDAY, MARCH 27, 2011.

(4) RAMIREZ RULING

The following ruling was issued to jockey Abel Ramirez for reporting very late to the Jockey's Quarters and was therefore unable to complete his scheduled engagement aboard "Fernanda Strawfly" in the second race on Sunday evening. Mr. Ramirez stated that there was heavy traffic and that he called the Stewards saying as much. The Stewards acknowledged that they did receive this call, but that ultimately it is his responsibility to be on time.

The second race in the book was for maiden three year olds for a claiming price of \$5,000 at 350 yards, attracting only one Cal-Bred and the eighth race, which was for four year olds and upward for a claiming price of \$16,000 to be run at a distance of 350 yards, which had no entries.

(2) MENDEZ RULING

The following ruling was issued to jockey Santiago Mendez for hitting his horse twice overhanded with a cocked whip, contrary to California Horse Racing Board rules. Mr. Mendez denied his doing so, however one of the two instances was corroborated on film and the other witnessed live by the Stewards. Santiago was upset and denied doing anything wrong, leaving the Stewards' office very unhappy. Frank Quesada, his agent who was in attendance, was told the fines would increase for future occurrences.
