Report of the Board of Stewards for the week of May 24, 2011 through May 29, 2011.

TUESDAY

05/24/2011

(1) **DUTY STEWARD**

Ruben Moreno will be on duty this week, attending to morning office matters and recording the minutes during this reporting period.

(2) **ENTRIES AND DRAW**

Ten races were drawn for Friday night's card consisting of three Thoroughbred and seven Quarter Horse events. The draw was completed at 1:00 p.m.

(3) **CAL-BRED REPORT**

The fourth race in the book for Friday, California-bred maidens, two years old, going 300 yards, went open with eight entries (2 CAL-BREDS). The sixth race in the book for Friday, California-bred maidens, three year olds and upward, claiming price \$10,000, going 300 yards, failed to fill with only one entry (1 CAL-BRED).

WEDNESDAY

05/25/2011

(1) **SCRATCHES**

Scratches were taken at 9:00 a.m. resulting in the also-eligible in the third race for Friday evening's program being declared..

(2) **ENTRIES AND DRAW**

Ten races were drawn for Saturday night's card consisting of two Thoroughbred and eight Quarter Horse events.

(3) **CAL-BRED REPORT**

The second race in the book for Saturday, California-bred maidens, fillies two years old, going 300 yards, went open (4 CAL-BREDS). The seventh race in the book for Saturday, California-bred three year olds, claiming price \$6,250, going 300 yards, failed to fill with two entries (2 CAL-BREDS).

THURSDAY

05/26/2011

(1) SCRATCHES

Scratches were held at 9:00 a.m. resulting in no scratches and no rider or equipment changes for Saturday evening's program.

(2) ENTRIES AND DRAW

Ten races were drawn for Sunday night's card consisting of three Thoroughbred and seven Quarter Horse events. The draw was completed at 12:30 p.m.

(3) CAL-BRED REPORT

The third race in the book for Sunday, California-bred maidens, three years old and upward, claiming price \$2,500, going 300 yards, failed to fill with no entries (0 CAL-BREDS). The fifth race in the book for Sunday, California-bred three year olds, claiming price \$10,000, going 350 yards, also failed to fill with no entries (0 CAL-BREDS).

FRIDAY

05/27/2011

(1) SCRATCHES

Scratches were held at 9:00 a.m. resulting in no scratches, one rider change and one equipment change for Sunday evening's program.

(2) OVERLY INFORMAL HEARING

Dr. Rick Overly appeared to address California Horse Racing Board case #11LA0126, concerning a discrepancy between Billing and Confidential Reports found by the State Investigator when comparing the documents. Billing records showed Dr. Overly billed owner Dan Lucas for an injection administered to "Big City Slicker" which the Billing Report did reflect but showed a different drug than the report submitted to the Receiving Barn. Dr. Overly, after agreeing to an informal hearing, explained that the discrepancy was due to a bookkeeping error brought about by the loss of one of his associates. He further explained the day the horse was treated he had been fraught with mass confusion and he failed to amend the confidential. Dr. Overly was advised that, while the Stewards were sympathetic to his plight, an error had been made and a ruling would follow.

(3) POTTER INFORMAL HEARING

Dr. Casey Potter appeared to address California Horse Racing Board case #11LA0125, concerning a discrepancy found by the State Investigator when comparing Dr. Potter's Confidential Report with his billing records. Billing records showed Dr. Potter billed owner Rodrigo Gonzalez for an injection administered to "Hope To See Ya Zoom" but the Confidential Report did not show this injection. Dr. Potter, after agreeing to an informal hearing, explained he had been paid cash and had forgotten to record the transaction in his Confidential Report. Dr. Potter also stated he has since changed his bookkeeping practices so this type of error would not happen again. Dr. Potter was advised that, while the Stewards understood, an error had been made; the accuracy of his reports was his responsibility; and a ruling would follow.

(4) SECOND RACE – INQUIRY – ACCIDENT – NO CHANGE

After the finish of the second race (Thoroughbred – 4½ furlongs) the Stewards posted the Inquiry sign to review an accident that occurred at or about the 3/8th pole involving #7 "Musgrove Cat" who went wrong behind and bobbed, causing jockey Dominic Terry to be thrown to the track surface. Jockey Terry was immediately attended to by E.M.T.'s and transported back to the Jockey's Quarters. While shaken, Terry appeared to be uninjured. "Musgrove Cat" was caught by the outrider and led back to the Saddling Paddock where he was unsaddled and taken to the Receiving Barn. Upon examination, "Musgrove Cat" was found to have a cut to his left inner thigh. No change was necessary to the order of finish. Accident report attached.

(5) THIRD RACE – INQUIRY - DISQUALIFICATION

After the finish of the third race (Quarter Horse – 300 yards) the Inquiry sign was posted to review an incident that occurred approaching the 1/16th pole. Involved were #2 "Hi On The

List" (1st – E. Nicasio) and #3 "Jes Gone" (3rd – R. Aceves). Film review shows "Hi On The List" drift out into the path of "Jes Gone," causing "Jes Gone" to take up impeding his performance and depriving him the opportunity of a better placing. After talking with both riders involved, the Stewards unanimously decided to disqualify #2 "Hi On The List" for interference and place him third. Jockey Eduardo Nicasio was ordered to review films with the Stewards at a later date.

Official Order of Finish: 10 – 3 – (2) – 5 – 8 – 9 – 7 – 6 – 1 – 4

(6) NINTH RACE – INQUIRY - DISQUALIFICATION

After the finish of the ninth race (Quarter Horse – 350 yards) the Inquiry was posted to review the running of the ninth race where #1 "Playing Catch Up" (6th – E. Gomez) lugged out at the start and bumped #2 "Country Cartel" (8th – J. Conklin) eliminating his opportunity for a better placing. "Playing Catch Up" then repeatedly bumped #4 "Together Forever" (5th – C. De Alba) throughout the course of the race. After film review and discussion with the riders involved, the Stewards unanimously agreed to disqualify "Playing Catch Up" and place her last. Jockey Gomez was ordered to review films with the Stewards at a later date.

(1) SANDOVAL RULING

RULING #86

JOCKEY DANIEL SANDOVAL IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE

ON SUNDAY, MAY 22, 2011, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued when jockey Daniel Sandoval rode in the ninth race at Hollywood Park and failed to reach Los Alamitos in time for his mount.

(2) POTTER RULING

RULING #87

VETERINARIAN CASEY POTTER IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1842 (VETERINARIAN REPORT - INCORRECT CONFIDENTIAL FILED).

The above ruling was issued following an informal hearing on Friday, May 27, 2011 due to a discrepancy found by the State Investigator when comparing Dr. Potter's Confidential Report with his billing records. Dr. Potter admitted an error was made and has since changed his billing practices.

(3) OVERLY RULING

RULING #88

VETERINARIAN LARRY "RICKY" OVERLY IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1842 (VETERINARIAN REPORT - INCORRECT CONFIDENTIAL FILED).

The foregoing ruling was issued following an informal hearing on Friday, May 27, 2011 due to a discrepancy found by the State Investigator when comparing Dr. Overly's Confidential Report with his billing records. Dr. Overly's explanation for the mix-up was a loss of personnel, a chaotic week, and a failure to reconcile his bookkeeping records.

(4) PURSE REDISTRIBUTION - CASE #11LA0103

RULING #89

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT BLOOD AND URINE SAMPLE# LA17606, TAKEN FROM THE HORSE "DASH BEDUINO", THE FIRST PLACE FINISHER IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL 1, 2011, TESTED POSITIVE FOR CLENBUTEROL (CLASS III) IN EXCESS OF THE PERMITTED LEVEL. IT IS ORDERED THAT "DASH BEDUINO" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$6,710) EARNED BY OWNER SALVADOR RABAGO, TRAINER MIGUEL V. RODRIGUEZ AND JOCKEY JOEL CRUZ BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY JUNE 27, 2011 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS

RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

The above ruling was issued after blood and urine samples obtained from "Dash Beduino" confirmed the presence of Clenbuterol in excess of the permitted level.

(5) MELGOZA RULING

RULING #90

OWNER RAMON MELGOZA IS SUSPENDED THIRTY (30) DAYS (MAY 30, 2011 THROUGH JUNE 28, 2011) AND FINED THREE THOUSAND DOLLARS (\$3,000.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND CALIFORNIA HORSE RACING BOARD RULE #1844 (B) (E) (9) (AUTHORIZED MEDICATION - CLENBUTEROL).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF RAMON MELGOZA ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued as a result of the testimony heard at the formal hearings on Saturday, May 21, 2011 addressing the high Clenbuterol level on "Card Check." Mr. Melgoza stated he was the responsible party for administering all medications at the ranch and confirmed that he had given the injection to "Card Check."

(6) MONTES RULING

RULING #91

TRAINER DANNY MONTES IS SUSPENDED SIXTY (60) DAYS (MAY 30, 2011 THROUGH JULY 28, 2011) AND FINED THREE THOUSAND DOLLARS (\$3,000.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES), #1844 (B)(E)(9)(F) (AUTHORIZED MEDICATION – CLENBUTEROL) AND #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF DANNY MONTES ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after a formal hearing was held on Thursday, May 19, 2011 to address the high Clenbuterol on "Illegal Velocity" trained by Danny Montes. Stewards followed the recommendation of the California Horse Racing Board as to the amount of fine and length of suspension.

(7) SANCHEZ RULING

RULING #92

TRAINER SERGIO SANCHEZ IS SUSPENDED THIRTY (30) DAYS (MAY 30, 2011 THROUGH JUNE 28, 2011) AND FINED ONE THOUSAND DOLLARS (\$1,000.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES), #1844 (B)(E)(9)(F) (AUTHORIZED MEDICATION - CLENBUTEROL) AND #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF SERGIO SANCHEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued following a formal hearing on Saturday, May 21, 2011. In issuing this ruling, the Stewards felt trainer Sergio Sanchez had the following the mitigating circumstances: he had not been the administrator of the drug, had continuous camera

surveillance in his shed row and a clean prior record, but as a trainer he is ultimately responsible.

(8) NICASIO RULING

The following ruling was issued to jockey Eduardo Nicasio for failure to ride his mount in the first race at Los Alamitos on Friday, May 27, 2011. Jockey Nicasio phoned prior to the race starting that he might be late due to a flat tire at which time he was advised to bring documentation supporting his problem. Jockey Nicasio failed to bring in said supporting documentation.

RULING #93

JOCKEY EDUARDO NICASIO IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON FRIDAY, MAY, 27, 2011.

(9) GOMEZ RULING

Jockey Eulices Gomez was in as requested by the Stewards to review the film from Friday, May 27, 2011 in the eighth race where his mount, #5 "Academy Days" lugged out. Jockey Gomez was brought to task for having made very little effort to straighten his mount. Jockey Gomez stated that he had tried to straighten his mount however, this was not supported by film review. The Stewards issued the following ruling.

RULING #94

JOCKEY EULICES GOMEZ, WHO RODE "ACADEMY DAYS" IN THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, MAY 27, 2011, IS SUSPENDED THREE (3) RACING DAYS (JUNE 4TH, 5TH AND 10TH) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

(10) NICASIO RULING

Jockey Eduardo Nicasio was in to review replays of his ride in the third race at Los Alamitos on Friday, May 27, 2011 where his mount #2 "Hi On The List" drifted out at the 1/16th pole. Nicasio stated that he tried to keep his mount straight by whipping him on the right shoulder. The rider was unable to convince the Stewards he had made the maximum effort and was advised that a better tactic would have been to stand up and guide him with the reins. After deliberation the Stewards unanimously agreed to the following ruling.

RULING #95

JOCKEY EDUARDO NICASIO WHO RODE "HI ON THE LIST" IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, MAY 27, 2011, IS SUSPENDED THREE (3) RACING DAYS (JUNE 4TH, 5TH AND 10TH, 2011) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FIRST TO THIRD. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

(11) SECURITY VIOLATION – FINANCIAL DISMISSED

Groom Jose Quevedo filed a financial complaint against trainer Juan Aleman for \$9,600 in past wages. The groom testified through Interpreter Carlos Huerrera that he had worked for Aleman for three years, during which time he was paid a portion of his wages each week but not in full. Trainer Juan Aleman stated Mr. Quevedo had been paid in full and brought in a cash ledger as evidence of monies being withdrawn with the Paymaster of Purses for that

RULING #97

EXERCISE RIDER DOMINGO RAMIREZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT - FIGHTING) ON MAY 22, 2011.

(3) NINTH RACE – INQUIRY – NO CHANGE

During the running of the ninth race (Quarter Horse – 400 yards) the Stewards posted the Inquiry sign to review a bumping incident twenty yards from the starting gate. Film reviews showed #5 “JW Marshall” (7th – E. Nicasio) stumbling into and bumping #6 “Temeku Hawk” (6th – E. Flores). Steward involvement was unnecessary as “Temeku Hawk” outran “JW Marshall.” There was no change in the order of finish.
