**TUESDAY**

09/11/2012

(1) DUTY STEWARD

James Dreyer will be present to conduct morning business and shall record the minutes during this reporting period.

(2) CAL-BRED REPORT

The first race in the book for Friday, maiden two year olds for a claiming price of \$6,250, was used open (4 CAL-BREDS). Sub #5 in the book, three and up for a claiming price of \$6,250, was called off with one (0 CAL-BREDS).

(1) GOMEZ RULINGRULING #143

OWNER IVAN GOMEZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 8, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0186, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF IVAN GOMEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after owner Ivan Gomez failed to appear to address alleged charges of violation of Rule #1876 (Financial Responsibility).

(2) ACEVES RULINGRULING #144

JOCKEY RODRIGO ACEVES IS FINED THREE HUNDRED DOLLARS (\$300.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (B-1) (USE OF WHIPS - WHIPPING IN POST PARADE) ON FRIDAY, SEPTEMBER 15, 2012.

The foregoing ruling was issued after jockey Rodrigo Aceves was observed whipping his mount in the post parade prior to Friday's seventh race.

(3) FILMS

Jockey Dirk Crane reviewed last evening's fifth race with the Stewards to discuss an incident going into the turn after which he had to survive an objection lodged by jockey Cheryl Charlton. The Stewards felt that the incident did not rise to a level that required our involvement but wanted him to be reminded that he needed to be a little more aware of his position.

Saturday evening's entire night of Futurity Trials went with nothing notable occurring.
