(3) NOLAN COMPLAINT (CASE #13LA0101)RULING #68

OWNER STEVE W. NOLAN, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON APRIL 19, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0101, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF STEVE W. NOLAN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued due to Mr. Nolan's failure to contact or appear before the Stewards concerning his financial obligation.

(4) GONZALEZ RULINGRULING #69

JOCKEY LEONARDO R. GONZALEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SUNDAY, APRIL 14, 2013. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued to jockey Leonardo Gonzalez for not being on time to fulfill his riding engagement in Sunday's second race. Mr. Gonzalez was to appear tonight to answer to this charge, however, he did not appear again tonight due to not riding this evening.
