Report of the Board of Stewards for the week of July 2, 2013 through July 7, 2013.

TUESDAY

07/02/2013

(1) DUTY STEWARD

James Dreyer will be responsible for morning problems and will record the minutes during this reporting period.

(2) CAL-BRED REPORT

The third race in the book for Friday, maiden fillies two years old, was used open (4 CAL-BREDS). The sixth race in the book, maidens three and four years old for \$10,000, was also used open (1 CAL-BRED).

(3) THE DRAW

Nine races will be on tap for Friday evening consisting of one Thoroughbred and eight Quarter Horse contests.

WEDNESDAY

07/03/2013

(1) SCRATCHES

Two rider changes and one scratch completed Friday's program adjustments.

(2) CAL-BRED REPORT

The fourth race in the book, maiden two year olds, was off with three (2 CAL-BREDS). Sub #2 in the book, three and four year olds for a \$4,000 tag, was called off with one (0 CAL-BREDS).

(3) THE DRAW

Saturday evening's program will be comprised of six Thoroughbred and three Quarter Horse races.

THURSDAY

07/04/2013

(1) SCRATCHES

Scratch time resulted in one equipment and four rider changes.

(2) CAL-BRED REPORT

The second race in the book, maiden two year olds for a claiming price of \$16,000, was called off with no entries. Sub #3 in the book, three and four year olds for \$2,500, was off with one (1 CAL-BRED).

(3) THE DRAW

The \$167,900 Vessels Maturity will highlight five Quarter Horse and four Thoroughbred races Sunday evening.

FRIDAY

07/05/2013

(1) SCRATCHES

Scratch time was completed at the designated time resulting in two equipment changes.

(2) FILMS

Jockeys Gerardo Gavica, Dionicio Navarro, and Raul Valenzuela were in to review their respective races, all for failing to maintain a straight course. None of the incidents amounted to sanctions, however we wanted them to be aware that this carelessness will not be tolerated.

(3) MARQUEZ RULINGRULING #105

JOCKEY CARLOS W. MARQUEZ WHO RODE "SNOWBOUND CHAMP" IN THE FIFTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, JUNE 30, 2013, IS SUSPENDED THREE (3) RACING DAYS (JULY 19TH, 20TH, AND 21ST, 2013) FOR CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FOURTH TO SIXTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after jockey Eulices Gomez represented jockey Carlos Marquez at the films to discuss his disqualification in the fifth race Sunday. No one in the room could find any defense for his lack of effort in the race.

Friday evening's program was completed without incident.

Jockey Rodrigo Aceves represented jockey Gregorio Arriaga at the films this afternoon. Gregorio grabbed his mount after the filly broke in, however we felt he was a bit tardy reacting to the situation. Rodrigo said he would convey the message to Mr. Arriaga.

(2) HUERTA RULINGRULING #106

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1766 (DESIGNATED RACES), JOCKEY CARLOS M. HUERTA, HAVING PARTICIPATED IN TRIALS IN RUIDOSO ON FRIDAY, JULY 5, 2013 AND SATURDAY, JULY 6, 2013, SHALL SERVE TWO ADDITIONAL SUSPENSION DAYS – FRIDAY, JULY 12, 2013 AND JULY 13, 2013, IN ORDER TO SATISFY THE TERMS OF L.A.Q.H. RULING #106, DATED JULY 7, 2013.

The foregoing ruling was issued after jockey Carlos Huerta participated in more than one designated race on both Friday and Saturday at Ruidoso Downs in New Mexico.

(3) THIRD RACE – INQUIRY - DISQUALIFICATION

Following the third race the Inquiry was posted to review an incident going into the turn. #6 "Wallbanger" (1st – D. Torres) dropped over going into the far turn, causing #3 "Excessive Pride" (6th – C. Charlton) to take up to avoid his heels. After speaking with the involved riders and examining the disc replay, the vote was unanimous to disqualify "Wallbanger."
