(2) MENDOZA RULINGRULING #125

IN THE MATTER OF: SAUL MENDOZA

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER SAUL MENDOZA ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #95, DATED JULY 7, 2012, SUSPENDING SAUL MENDOZA FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE AND SAUL MENDOZA IS RESTORED TO GOOD STANDING.

The above ruling was issued after subject provided verification from Equine Sports Medicine that an agreement has been reached between both parties.

(3) THIRD RACE – LATE DECLARATION - REFUND

A refund was ordered in the third race when #5 "July Runner" (Tr. C. Treece – Jockey V. Bednar) was declared by the Stewards. Rider refused to ride mount. Refund: \$12,308.00.

(4) CLAIM VOID

The third race claim of "Country Hero" by Trainer Jose Moreno was voided after State Veterinarian Dr. Gary Beck declared the gelding unsound and placed him on the Vet's List. The horse was returned to Trainer Charles Treece.

(5) SIXTH RACE - ACCIDENT

During the running of the sixth race, first time starter #5 "Beautiful Cely" (Tr. M. Loza – Jockey G. Tapia) racing in the clear, ducks in sharply, unseating the rider and bouncing off the inside rail. Jockey Tapia was transported to Los Alamitos General Hospital for observation. No injury to the horse. However, there was a ten minute delay when track maintenance repaired the inner rail.

(2) SECOND RACE – CLAIM VOIDED

The second race claim of #8 “Royal Merigo Round” was voided after State Veterinarian Dr. Gary Beck declared the gelding unsound and placed him on the Vet’s List. The horse was returned to the original trainer, Antonio Soto.

(3) FIFTH RACE – JOCKEY OBJECTION – NO CHANGE

Following the running of the fifth race, Jockey Vinnie Bednar who rode #1 “Buckshot Bob” who finished fourth, lodged a claim of foul against #2 “Captain Camelot” (Jockey D. Navarro–3rd) for alleged interference near the ¼ pole. After a review of the film and talking with the riders involved, it was a unanimous decision to let the original order of finish stand due to the fact the films did not verify the claim of foul.

(4) FIFTH RACE – CLAIM VOIDED

A claim deposited in the fifth race by Trainer Jose Moreno for the horse “Catquest” was voided as the horse was unsound during its time the Receiving Barn. The horse was returned to the original trainer.

Following the running of the second race, the Stewards immediately posted the Inquiry sign to review an incident near the 5/16 pole. Tapes show #5 “Caught A Flyer” (Tr. D. Givens – Jockey Gerardo Gavica) while racing in the clear, broke down and fell, unseating Jockey Gavica. As no other horses were involved, the race was declared official. The jockey returned to the Jockey’s Room under his own accord. Unfortunately, #5 “Caught A Flyer” was humanely euthanized.
