(2) GODINEZ COMPLAINT – CASE #13LA0216

Trainer Jesse R. Godinez was given a telephonic hearing concerning this complaint regarding a bute overage (3.6 ug/ml) that was his first offense and under the 5.0 ug/ml limit, which qualifies for an official warning. Mr. Godinez was informed to be very careful.

(3) AMEZCUA RULINGRULING #149

TRAINER GERARDO AMEZCUA IS FINED TWENTY-FIVE DOLLARS (\$25.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – PARKING IN BARN AREA OVERNIGHT).

The foregoing ruling was issued after Mr. Amezcua was cited by Security for overnight parking in the barn area.

(4) ESPINOZA RULINGRULING #150

GROOM RAFAEL ESPINOZA IS FINED TWENTY-FIVE DOLLARS (\$25.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – SPEEDING IN BARN AREA).

The above ruling was issued after Groom Espinoza appeared before the Stewards concerning his speeding in the barn area in a golf cart.

(5) FOURTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the fourth race when Track Veterinarian Dr. Tom Hackathorn reported that #4 "Baby Choice 87" (Tr. A. Soto) failed to warm up properly. Refund: \$3,904.00.

(1) PURSE REDISTRIBUTIONRULING #151

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE# LA24262, TAKEN FROM THE HORSE "MR TR DASHER", THE SECOND PLACE FINISHER IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 22, 2013, TESTED POSITIVE FOR CLENBUTEROL (CLASS III). IT IS ORDERED THAT "MR TR DASHER" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING

BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$1,845.00) EARNED BY OWNER SANTOS MONTEMAYOR, TRAINER VALENTIN A. ZAMUDIO AND JOCKEY EDUARDO NICASIO BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY DECEMBER 2, 2013 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

The foregoing ruling was issued in compliance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test). Both trainer and owner were notified that the disqualification hearing would be conducted on this date and indicated that they would not appear.

(2) HERNANDEZ RULING

RULING #152

GROOM EDGAR HERNANDEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1530 (CASES NOT COVERED BY RULES AND REGULATIONS - RAN STOP SIGN, SPEEDING), #1874 (DISORDERLY CONDUCT – DRIVING WHILE INTOXICATED).

The above ruling was issued after subject was cited for drinking and speeding by Security.

(3) FIRST RACE – ACCIDENT – RIDER INJURED

While the horses were in the walking ring for the first race, #4 “Sacred Ghost” (Tr. R. Lucas – Jockey P. Zavelta) cow-kicked the jockey, injuring him. He was replaced by Jockey Eulices Gomez. Initial reports stated the rider was okay.

(4) VOIDED CLAIM

Trainer Roberto Dominguez’s fourth race claim for #4 “Ton Of Speed” (Tr. S. Fiscal) was voided by the Stewards after State Veterinarian Dr. Gary Beck’s examination of the four-year-old gelding found him to be unsound. The horse was placed on the Vet’s List and returned to Trainer Sergio Fiscal’s barn.

(5) VOIDED CLAIM

After the fifth race, the claim of “Regent Fan” was voided when the State Veterinarian Dr. Gary Beck placed the filly on the unsound list. The filly will return to the barn of Keith Craigmyle.
