(2) DE LA TORRE COMPLAINT (CASE #13LA0262)

Trainer Jose De La Torre appeared before the Board of Stewards as requested in regards to a complaint filed against him for an unlabeled tube of phenylbutazone paste. Jose stated the horse in question was operated on to remove a chip out of his knee. When he picked the horse up from Equine Medical Center, they gave a packet with bandages, wraps and a tube of phenylbutazone paste (unlabeled).

The Stewards conferred with Veterinarian Dr. Vince Baker who is in charge of Equine Medical Center to verify what Mr. De La Torre was given in the packet. Therefore, a warning was issued. Veterinarian Baker stated that he will order his clinic to make sure all horses that are returned to race tracks will receive properly labeled medications.

(3) ZAMORA RULINGRULING #165

TRAINER RICARDO ZAMORA. IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION – NON LASIX HORSE RECEIVED LASIX) ON NOVEMBER 22, 2013.

The foregoing ruling was issued after Mr. Zamora appeared before the Stewards as to why his horse was declared from yesterday's fifth race. Mr. Zamora stated that he assumed his veterinarian was going to handle the procedure in putting his horse on the Bleeder's List. He was informed that it is his responsibility to make sure everything is in order.

(4) VOIDED CLAIM

Trainer Charles Treece's third race claim for #5 "Lincoln Launch" (Tr. J. Cooper) was voided by the Stewards after State Veterinarian Dr. Gary Beck's examination of the four-year-old gelding found him to be unsound. The horse was placed on the Vet's List and returned to Trainer John Cooper's barn.

OWNER GUADALUPE LEON, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON NOVEMBER 23, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0259, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF GUADALUPE LEON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #167

OWNER FELIPE CARLOS, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON NOVEMBER 23, 2013, TO ANSWER A COMPLAINT REGARDING CASE #13LA0260, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF FELIPE CARLOS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The preceding two rulings were issued when both subjects failed to appear to answer complaints filed by the California Horse Racing Board for financial obligations.

(2) EIGHTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the eighth race as #7 "Beavs Wagon" (Tr. P. Jones) injured herself in the starting gate and was declared on the recommendation of Track Veterinarian Dr. Tom Hackathorn. Refund: \$14,958.00.

(3) TRIALS

Fourteen trial races were conducted this evening for the Los Alamitos Two Million Futurity Trials.


