Report of the Board of Stewards for the week of December 24, 2013 through December 29, 2013.

**NOTE:** Due to holiday scheduling, no office matters were attended to on Tuesday, December 24<sup>th</sup> or Wednesday, December 25<sup>th</sup>. All normal business conducted on these two days was moved to Saturday, December 21<sup>st</sup> and Sunday, December 22<sup>nd</sup> with the official reporting period starting as of Thursday, December 26, 2013.

**THURSDAY****12/26/2013 (1) DUTY STEWARD**

Ruben Moreno will be on duty this week attending to morning office matters and recording the minutes during this reporting period.

**(2) ENTRIES AND DRAW**

On Saturday, December 21, 2013, eight races were drawn for Friday night's card consisting of three Thoroughbred and five Quarter Horse events with the draw being completed at 2:45 p.m.

On Sunday, December 22, 2013, eight races were drawn for Saturday night's card consisting of four Thoroughbred and four Quarter Horse events with the draw being completed at 4:00 p.m.

On Thursday, December 26, 2013 eight races were drawn for Sunday night's card consisting of four Thoroughbred and four Quarter Horse events with the draw being completed at 5:45 p.m.

**(3) SCRATCHES**

Friday scratches were taken at 9:00 a.m. on Sunday, December 22, 2013 resulting in no scratches, two rider changes and no equipment changes for Friday evening's program.

Saturday scratches were taken at 9:00 a.m. on Monday, December 23, 2013 resulting in no scratches, one rider change and no equipment changes for Saturday evening's program.

**(4) CAL-BRED REPORT**

The second race in the book for Friday, California-bred maidens, two years old, claiming price \$6,250, going 300 yards, failed to fill with one entry (1 CAL-BRED). Sub #4 in the book also for Friday, California-bred fillies and mares, three years old and upward, claiming price \$2,500, going 300 yards, failed to fill with no entries (0 CAL-BREDS).

The second race in the book for Saturday, California-bred maidens, fillies two years old, going 300 yards, failed to fill with one entry (1 CAL-BRED). Sub #1 in the book also for Saturday, California-bred two year olds, claiming price \$2,500, going 300 yards, failed to fill with two entries (2 CAL-BREDS).

The fourth race in the book for Sunday, California-bred maidens, two year olds, going 330 yards, failed to fill with two entries (2 CAL-BREDS). The seventh race in the book also for Sunday, California-bred three year olds and upward, claiming price \$5,000, going 330 yards, failed to fill with no entries (0 CAL-BREDS).

**FRIDAY****12/27/2013 (1) SCRATCHES**

Scratches for Sunday were held at 9:00 a.m. resulting in no scratches, two rider changes and no equipment changes for Sunday evening's program.

**(2) TORRES FILM REVIEW**

Jockey Devan Torres appeared before the Stewards to review his ride in the fifth race on Sunday, December 22, 2013. Film review showed Jockey Torres' mount, #5 "Perfect Genius," breaking in leaving the gate and bumping into #4 "Inexcussofperfect." While Jockey Torres felt he had done an adequate job, the Stewards advised him that he must correct his horses sooner. Jockey Torres left with just a warning.

**(3) GOMEZ RULING**

Jockey Eulices Gomez appeared before the Stewards to review his ride in the third race on Sunday, December 22, 2013 in which his mount, #5 "Warren's Vanwinkle," broke in, bumping #4 "At Last A Wildcat," forcing him into #3 "Future Readings," causing him to clip heels. Jockey Gomez stated that his game plan was to let the horse run a few yards before taking a hold and was caught off guard by his horse's lugging in, admitting it was a bad call on his part. The Stewards agreed, and Jockey Gomez was issued the following ruling:

**RULING #1**

JOCKEY EULICES GOMEZ WHO RODE "WARREN'S VANWINKLE" IN THE THIRD RACE AT LOS

ALAMITOS RACE COURSE ON SUNDAY, DECEMBER 22, 2013, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 3<sup>RD</sup>, 4<sup>TH</sup> AND 5<sup>TH</sup>, 2014) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO SEVENTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

(4) ROBLES HEARING

An informal hearing was conducted to address case #13LA0273. Present were Pony Rider Heliodoro Robles, his wife, Elena Carrillo, witnesses Florentino Figueroa and Adalberto Aceves, Supervising Investigator Tom Blake, Safety Steward Tom McCarthy, the Board of Stewards, and Investigator Dennis Drulias, who presented the case. At issue were the conditions in which Mr. Robles' pony horse was being kept; namely: no feed, water, or bedding, and muddy, uneven ground. Mr. Robles admitted to ownership of the horse in question but insisted that the horse was only in the pen for a few hours while his barn was in the process of being relocated. Citing the importance of any animal's humane treatment and the fact that the horse in question was under his care, Mr. Robles was informed a decision would be forthcoming.

(5) VALLEJO HEARING

An informal hearing was conducted to address case #13LA0249. Present were Trainer Francisco Vallejo, his daughter and interpreter Adriana Aceves, Supervising Investigator Tom Blake, Investigator Kevin Kitashima, who presented the case, Safety Steward Tom McCarthy, and the Board of Stewards. On October 24, 2013, California Horse Racing Board investigators conducted a barn inspection of Trainer Vallejo's barn and found two unmarked bottles containing unknown substances. Testing at Davis Laboratories confirmed one bottle contained Albuterol. Trainer Vallejo testified that the contents of the bottles were olive oil and Albuterol and that his groom had changed these substances from their original containers to other bottles for easier administration. Trainer Vallejo was informed that unlabeled medications were a violation of California Horse Racing Board rules, and a ruling would be issued.

(6) STEWARDS' CONCERN – TEMPORARY RAIL

Prior to the running of the first race, Safety Steward Tom McCarthy brought to the Stewards' attention that the inside rail from the 440 yard pole to the 550 pole had been replaced with a temporary cyclone fence railing due to track construction. Track Surface Superintendent Rick Hughes and Director of Racing Ron Church met with the Board of Stewards to address the change. All parties were in agreement that the situation was temporary and posed no discernible safety issue. However, in order to ensure track safety, the Board of Stewards were assured that no races would be run at a distance where the temporary rail would be a factor. Assistant Executive California Horse Racing Board Director Jackie Wagner was notified by phone of the concern and ensuing discussion. Permission was given to allow racing. A follow-up email was sent.

12/28/2013(1) LOSS OF A GOOD FRIEND TO RACING

This evening the Stewards were informed of a long time friend of racing, Dr. Robert Goodbary's passing. For many years, Dr. Goodbary was a practicing veterinarian at Los Alamitos and later served as track veterinarian at Los Alamitos, Cal-Expo, and several California fair meets. Always a character and friend, he will be missed by all.

(2) ROBLES RULINGRULING #2

PONY RIDER HELIODORO ROBLES IS FINED THREE HUNDRED DOLLARS (\$300.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1902.5 (ANIMAL WELFARE - NEGLIGENCE).

The Stewards want it completely understood that the mistreatment, neglect or abuse of any animal will not be tolerated regardless of the extenuating circumstances. With this in mind, Mr. Robles as the responsible party was given the above fine.

(3) VALLEJO RULINGRULING #3

TRAINER FRANCISCO VALLEJO IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843 (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND #1890 (POSSESSION OF CONTRABAND – UNLABELED MEDICATION).

The foregoing ruling was issued to conclude case #13LA0249 in which Trainer Francisco Vallejo was found to have unlabeled bottles of suspected medications in his barn.

(4) SECOND RACE – VOIDED CLAIM

Trainer Miguel Gonzalez's second race \$5,000 claim on "Mad Loot" was voided when the four year old gelding expired on the track after the running of the race. Dr. Thomas Hackathorn diagnosed internal injuries as the cause of death.

(5) SIXTH RACE – INQUIRY – DISQUALIFICATION

After the running of the sixth race (Quarter Horse – 330 yards), the Inquiry sign was posted to review an incident that occurred approximately fifty yards from the starting gate. Involved were #6 "Wild Corona" (4<sup>th</sup> – V. Bednar) and #5 "BW Prettyquickchick" (6<sup>th</sup> – R. Hernandez). Film review showed "Wild Corona" lugging in and crossing over on "BW Prettyquickchick," impeding her performance and depriving her of the opportunity of a better placing. After discussion with both riders involved, the Stewards unanimously agreed to disqualify "Wild Corona" for interference. Jockey Bednar was ordered to review films with the Stewards at a later date.

12/29/2013 (1) BEDNAR RULING

Jockey Vinnie Bednar was in as requested by the Stewards to review the film of his ride in the sixth race on Saturday, December 28, 2013 in which his mount, #6 "Wild Corona" drifted in fifty yards from the gate, resulting in his disqualification from fourth to sixth place. Jockey Bednar was brought to task for having made very little effort to straighten his mount. The Stewards unanimously agreed to the following ruling:

RULING #4

JOCKEY VINNIE BEDNAR WHO RODE "WILD CORONA" IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, DECEMBER 28, 2013, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 5<sup>TH</sup>, 10<sup>TH</sup> AND 11<sup>TH</sup>, 2014) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FOURTH TO SIXTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

(2) RAMIREZ RULING

RULING #5

JOCKEY ABEL RAMIREZ IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1680 (JOCKEYS AND DRIVERS TO REPORT – LATE TO JOCKEYS ROOM).

The above ruling was issued for Jockey Abel Ramirez's late arrival and failure to contact the Stewards prior to the second race on Saturday, December 28, 2013. Jockey Ramirez did fulfill his riding engagement in the second race but failed to appear before the Stewards as requested.

(3) SEVENTH RACE – TRAINER OBJECTION – NO CHANGE

Following the running of the seventh race (Quarter Horse – 300 yards), Trainer Scott Willoughby called the Stewards to voice an objection against #5 "Fall For This Guy" (1<sup>st</sup> – R. Valenzuela). At issue was "Fall For This Guy's" bumping of the stumbling #4 "Texcoco" (3<sup>rd</sup> – F. Rubio) approximately ten yards from the gate, who then bumped Trainer Scott Willoughby's #3 horse "Mrs Pickens" (2<sup>nd</sup> – C. De Alba). Film replays showed "Texcoco" bobbling as the ground broke out from under him as he left the gates and then again stumbling on his own accord becoming both the bumped by "Fall For This Guy" and the bumpee of "Mrs Pickens." After speaking with all riders involved and thorough film review, the Stewards unanimously agreed the incident in question did not cost "Mrs Pickens" the opportunity of a better placing.
