CHRISTENSEN FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND SAMUEL CHRISTENSEN IS RESTORED TO GOOD STANDING.

RULING #38

IN THE MATTER OF: FERNANDO LISEA

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER FERNANDO LISEA ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #177, DATED DECEMBER 14, 2013, SUSPENDING MR. LISEA FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND FERNANDO LISEA IS RESTORED TO GOOD STANDING.

RULING #39

IN THE MATTER OF: TERESA GONZALEZ

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER TERESA GONZALEZ ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #149, DATED JULY 30, 2011, SUSPENDING MS. GONZALEZ FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND TERESA GONZALEZ IS RESTORED TO GOOD STANDING.

The above rulings were issued after the Stewards were in receipt of documentation from Sports Equine Medicine that the above subjects paid in full.

(3) BLAKE RULING

RULING #40

OWNER LES BLAKE, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON MARCH 7, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0032, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF LES BLAKE ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after Owner Les Blake failed to appear to answer a financial complaint in the amount of \$1,373.47.

(4) DOMINGUEZ RULING

RULING #41

TRAINER ROBERTO DOMINGUEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – WORKING UNLICENSED PERSONNEL).

The preceding ruling was issued after subject appeared before the Stewards concerning working an unlicensed person in his barn. Mr. Dominguez stated that he was just trying to help her make a few dollars.

(5) THIRD RACE – CLAIM VOIDED

The third race claim of "Big G's Dance" by Trainer Guillermo Morales was voided after being advised by D.V.M. Gary Beck he was placing the horse on the Vet's List. The horse was returned to Trainer Chris O'Dell.

HANSON WHO STARTED THE HORSE "MEMBER OF THE TRIBE" IN THE FIRST RACE ON JUNE 15, 2013 AT LOS ALAMITOS RACE COURSE IS FINED FOUR THOUSAND DOLLARS (\$4,000.00)* AND SUSPENDED NINETY (90) DAYS (MARCH 10, 2014 THROUGH JUNE 7, 2014) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) AND RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS

AND OTHER SUBSTANCES) (CLENBUTEROL - CLASS III).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JAMES G. HANSON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JAMES G. HANSON IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #43

TRAINER JAMES G. HANSON WHO STARTED THE HORSE "I TOLD YOU TWICE" IN THE FIFTH RACE ON JUNE 22, 2013 AT LOS ALAMITOS RACE COURSE IS FINED FIVE THOUSAND DOLLARS (\$5,000.00)* AND SUSPENDED ONE HUNDRED AND TWENTY (120) DAYS (JUNE 8, 2014 THROUGH OCTOBER 5, 2014) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) AND RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) (CLENBUTEROL - CLASS III).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JAMES G. HANSON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JAMES G. HANSON IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

After receiving notification of the Daniel Q. Shiffer decision regarding the two Hanson cases, the foregoing rulings were issued.

(2) MONTEMAYOR RULING

RULING #44

OWNER SANTOS N. MONTEMAYOR IS SUSPENDED FOR THIRTY (30) DAYS (MARCH 10, 2014 THROUGH APRIL 8, 2014) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843.3 (A,B&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES).

IN ADDITION, OWNER MONTEMAYOR'S HORSE, "MR TR DASHER," MUST PASS A BOARD APPROVED EXAMINATION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1846 BEFORE BECOMING ELIGIBLE TO BE ENTERED AND BE SUBJECT TO DRUG TESTING AT THE OWNER'S EXPENSE AND BE NEGATIVE FOR PROHIBITED DRUG SUBSTANCES AS DEFINED IN CALIFORNIA HORSE RACING BOARD RULE #1843.1.

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF SANTOS MONTEMAYOR ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS), SUBJECT IS DENIED ACCESS TO PREMISES IN THIS JURISDICTION.

The above ruling was issued after the California Horse Racing Board accepted the Stewards' proposed decision regarding Mr. Montemayor.

(3) WARREN RULING

RULING #45

IN THE MATTER OF: CLARK WARREN

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER CLARK WARREN ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #115, DATED AUGUST 9, 2013, SUSPENDING MR. WARREN FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND CLARK WARREN IS RESTORED TO GOOD STANDING.

The preceding ruling was issued after receiving confirmation from Sports Equine Medicine

that Mr. Warren's debt to them had been satisfied.

(4) INFORMAL MEETING

The Stewards met with Equine Medical Director Rick Arthur, State Veterinarian Dr. Gary Beck, Investigator Tom Blake, and Safety Steward Randy Winick. At issue was implementing new procedures involving the use of Clenbuterol in out competition testing and forms which must be filled out properly by the practicing veterinarians.
