Report of the Board of Stewards for the week of April 8, 2014 through April 13, 2014.

TUESDAY

04/08/2014

- (1) DUTY STEWARD
Ruben Moreno will be on duty this week attending to morning office matters and recording the minutes during this reporting period.
- (2) ENTRIES AND DRAW
Eight races were drawn for Friday night's card consisting of two Thoroughbred and six Quarter Horse events. The draw was completed at 4:15 p.m.
- (3) CAL-BRED REPORT
The third race in the book for Friday, California-bred maidens, three year olds, claiming price \$2,500, going 300 yards, failed to fill with one entry (1 CAL-BRED).

- (2) ENTRIES AND DRAW
Eight races were drawn for Sunday night's card consisting of four Thoroughbred and four

Quarter Horse events. The draw was completed at 4:30 p.m.

(3) CAL-BRED REPORT

The sixth race in the book for Sunday, California-bred four years old and upwards, claiming price \$5,000, going 350 yards, failed to fill with one entry (1 CAL-BRED). Sub #2 in the book also for Sunday, California-bred three year olds, claiming price \$4,000, going 330 yards, also failed to fill with no entries (0 CAL-BREDS).

FRIDAY

04/11/2014

(1) SCRATCHES

Scratches for Sunday were held at 9:00 a.m. resulting in no scratches, rider changes, or equipment changes for Sunday evening's program.

(2) SAFETY STEWARD ABSENT

Safety Steward Randy Winick was absent for the evening.

(3) HUERTA FILM REVIEW

Jockey Carlos Huerta appeared before the Stewards to review his ride in the sixth race on Sunday, April 6, 2014 aboard #4 "Serenity." Leaving the gate, "Serenity" broke out, bumping #5 "Speights Girl." Jockey Huerta offered the explanation that his horse was light in the mouth, which prevented him from taking a better hold of her. Jockey Huerta was cautioned that he needed to do a better job in the future of keeping his mounts on the straight and narrow. No penalty was assessed.

(4) TREECE HEARING

Trainer Charles Treece was in as requested by the Stewards to address Case #14LA0059, in which an official blood sample taken from "Linsecum" on Sunday, March 9, 2014 was found to contain Phenylbutazone in excess of the authorized limit. Mr. Treece was the trainer of record. After reviewing Trainer Treece's medication record, which is clear of any Phenylbutazone violations since March 23, 2008, a warning was issued.

(5) SAYLER RULING

RULING #68

TRAINER JAMES F. SAYLER IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – AGGRESSIVE BEHAVIOR).

The above ruling was issued to address Trainer Sayler's security violation on April 4, 2014 for which he was cited for a physical altercation with Trainer Shaun Morrow in the Los Alamitos stable area.

(6) FIRST RACE – CLAIM VOIDED

Trainer Kristen Watanabe's first race \$5,000 claim on #4 "Beautiful Spirit" (Tr. M. Puype) was voided by the Stewards after Track Veterinarian Dr. Gary Beck's examination of the five-year-old mare at the Receiving Barn post-race found her to be unsound. "Beautiful Spirit" was placed on the Vet's List and returned to Trainer Mike Puype's barn.

(7) EIGHTH RACE – INQUIRY - DISQUALIFICATION

After the finish of the eighth race (Quarter Horse – 330 yards), the Inquiry was posted to review the start of the race, where #5 "Look Of A Dasher" (2nd – C. Huerta) caused a chain reaction by bumping #4 "Just So Happens" (3rd – C. Mendez), who in turn bumped #3 "Tell Of The Past" (4th – E. Nicasio), who then impeded #2 "Husker Cartel" (5th – R. Valenzuela), causing him to also clip heels. After watching the replays, the Stewards unanimously agreed to disqualify #5 "Look Of A Dasher" and place him last.

(1) HUERTA FILM REVIEW

Jockey Carlos Huerta appeared before the Stewards to review his ride on #5 "Look Of A Dasher" in the eighth race on Friday, April 11, 2014 in which he was disqualified. Of concern to the Stewards was Jockey Huerta's inability to keep his mount straight at the start. Jockey Huerta presented that "Look Of A Dasher" was a big, stout "son-of-a-gun," and he had his hands full. The Stewards countered that Jockey Huerta nonetheless had to do a better job of keeping his mounts straight not to place the majority of the blame on the horse. No penalty was issued.

(2) GODINEZ RULING

RULING #69

TRAINER JESSE GODINEZ IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION – HORSE NOT ON GROUNDS) ON APRIL 12, 2014.

The above ruling was issued to address the late declaration of #5 "JDF Check" in tonight's eighth race. Trainer Godinez explained in a telephone conversation that "JDF Check" had been injured at the ranch, and he had forgotten to notify officials.

(3) FIRST RACE – VOIDED CLAIM

Trainer Chris O'Dell's first race \$3,200 claim on #5 "Unstoppablesteve" (Tr. M. Loza) was voided by the Stewards after Track Veterinarian Dr. Gary Beck's examination of the four-year-old gelding at the Receiving Barn post-race found him to be unsound. "Unstoppablesteve" was placed on the Vet's List and returned to Trainer Loza's barn.

(1) CHARLTON FILM REVIEW

Jockey Cheryl Charlton was in to review her ride in the first race on Saturday, April 12, 2014 aboard #6 "Top Torero" where, in an effort to save ground, she aggressively maneuvered her mount to the inside, putting pressure on #3 "Mark's Cat" and #4 "Ambassy." The reason the Stewards requested Jockey Charlton to review the films with them was to highlight the need for safety at all times. It was pointed out to Jockey Charlton that she should picture herself in the position she had put these riders in and that she would most likely be irate. The Stewards dismissed Jockey Charlton with a warning to ride safer in the future.

(2) MACIAS FILM REVIEW

Jockey Osvaldo Macias appeared before the Stewards as requested to review his wild ride in the second race on Saturday, April 12, 2014 where his mount #7 "Whoopia" broke to the outside and then suddenly veered inward in the last fifty yards, almost colliding with #5 "Larry Hill." Of concern to the Stewards was the lack of control demonstrated in Jockey Macias' hair-raising ride. The Stewards emphasized that the reins are the most effective way to control a mount and to make better use of them in the future.

(3) TILLEMANS VS. VISSCHER COMPLAINTS

Owners Mike and Carol Tillemans and Trainer Patricia Visscher appeared before the Stewards to present their respective positions on perceived payments owed for training. Through ensuing conversations in the Stewards' Office, the issues involved amounted to misunderstanding between the parties and were cleared up to everyone's satisfaction. Both parties dropped their complaints.
