(2) HERNANDEZ RULING

RULING #105

OWNER JORGE HERNANDEZ IS FINED TWENTY-FIVE DOLLARS (\$25.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS).

The above ruling was issued after Owner Hernandez admitted he parked overnight in the barn area.

(3) SALLY RIVERA HEARING

After much bantering, owner Sally Rivera and horse hauler Celeste McPeak negotiated Sally's bills down to \$3,500 to be paid within two months.

(4) FILMS

Jockey Brandon Boulanger reviewed Sunday's first race with the Stewards this afternoon. We felt he had made a rather weak effort to keep his horse on the fence while rounding the turn. He was given a warning.

(5) BARN AREA ALTERCATION

Three riders, Salomon Salguero, Dihigi Gladney, and Eulices Gomez, had words in the barn area this morning, culminating in blows being thrown. It began on the track and concluded at Art Sherman's barn, where Gladney pulled Salguero off his mount. At that point, Gomez stepped in, punching Salguero after Salguero had hit him with his whip. Further research will be required before rendering a decision.

(6) NO PROBLEMS

Friday evening's program was completed with nothing of significance to report.

(1) GARCIA RULING

RULING #106

HORSE IDENTIFIER JUAN M. GARCIA IS FINED FIVE HUNDRED DOLLARS (\$500.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1554 (DUTIES OF HORSE IDENTIFIER) AND #1853 (EXAMINATION REQUIRED) FOR FAILURE TO PROPERLY IDENTIFY THE FILLY "I'M INDY KNOW."

The above ruling was issued after an informal hearing to address Case #14LA114. On April 11, 2014, a horse Identifier Juan Garcia thought was the Quarter Horse "Granich" ran in the fourth race, finishing last. In reality, the Thoroughbred "I'm Indy Know" was the horse that ran. Garcia had tattooed "Granich" in March, when the filly was brought in to qualify. When the filly was brought to the Receiving Barn, and he checked her lip, she had no tattoo. As it

had been some time since he had seen her, he assumed he had simply forgotten to tattoo "Granich." After the race, he tattooed her before allowing the filly to leave the grounds.

He discovered his mistake when Trainer Felix Gonzalez asked him to check the tattoo numbers of some Thoroughbreds he was going to run at Santa Anita. When he looked at "I'm Indy Know," he realized she had the same tattoo number as the Quarter Horse "Granich," which was also in Gonzalez's barn. He immediately notified the Stewards, resulting in the foregoing proceedings.

(2) HORSE DISQUALIFICATION (REFER 6/7/14<sup>1</sup>)

RULING #107

A FORMAL HEARING HAVING BEEN HELD, IT IS NOW DETERMINED THAT THE HORSE "I'M INDY KNOW" WAS INELIGIBLE TO START IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL 11, 2014, DUE TO A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1588 (F) (HORSE INELIGIBLE TO START IN A RACE) IN THAT THE IDENTIFICATION MARKINGS OF SAID HORSE DID NOT AGREE WITH THE IDENTIFICATION MARKINGS ON THE CERTIFICATE OF REGISTRATION.

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1592 (INELIGIBLE HORSE TO BE DISQUALIFIED) "I'M INDY KNOW" IS DISQUALIFIED FROM SEVENTH PLACE.

ALL RECORDS ARE ORDERED CHANGED TO REFLECT THIS RULING.

IT IS FURTHER ORDERED THAT PURSE MONEY IN THE AMOUNT OF THREE HUNDRED DOLLARS (\$300.00) EARNED BY OWNER JESUS RENDON FROM THE FOURTH RACE BE RETURNED TO THE PAYMASTER OF PURSES BY JUNE 17, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITHHELD).

The above ruling was issued after being informed by Identifier Juan Garcia that the Quarter Horse "Granich," which supposedly ran in the fourth race on April 11, 2014 was in fact the Thoroughbred "I'm Indy Know."

RULING #108

JOCKEY SALOMON SALGUERO IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – ALTERCATION IN STABLE AREA).

RULING #109

JOCKEY DIHIGI GLADNEY IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – ALTERCATION IN STABLE AREA).

RULING #110

JOCKEY EULICES GOMEZ IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – ALTERCATION IN STABLE AREA).

The above rulings were issued after the Stewards determined that all three individuals shared culpability for the incident.

(4) PURSE REDISTRIBUTION

RULING #111

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE #LA25650, TAKEN FROM THE HORSE "ERNIE OWL," THE FIRST PLACE FINISHER IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL

13, 2014, TESTED POSITIVE FOR 2-(1-HYDOXYETHYL), A METABOLITE OF ACEPROMAZINE (CLASS III). IT IS ORDERED THAT "ERNIE OWL" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$4,035.00) EARNED BY OWNER LAURA R. BAILEY, TRAINER DOMINIC FAMA AND JOCKEY JUAN GALLARDO BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY JULY 5, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

The foregoing ruling was issued after receiving confirmation from the Maddy Equine Lab that urine sample #LA25650 taken from "Ernie Owl" contained a Class III prohibited drug.
