(1) SANTOS RULING

RULING #133

HOT WALKER SANDY SANTOS IS HEREBY SUSPENDED FOR FIFTEEN (15) DAYS COMMENCING JULY 19, 2014 THROUGH AUGUST 2, 2014 FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1890 (POSSESSION OF CONTRABAND – GLASS DRUG PIPE WHILE ON THE PREMISES OF LOS ALAMITOS RACE COURSE).

FURTHERMORE, SANDY SANTOS SHALL SHOW PROOF OF A RECOVERY PROGRAM ACCEPTABLE TO THE STEWARDS AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF SANDY SANTOS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after an informal hearing was conducted concerning complaint #14LA0167.

(2) RULINGS #134-135

RULING #134

OWNER BEN DAVIS, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 19, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0168, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF BEN DAVIS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #135

OWNER KAYLEETA ROBINSON, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 19, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0169, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF KAYLEETA ROBINSON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above rulings were issued when the individuals named in the complaints failed to appear. These two complaints are actually one. The two subjects, although showing different last names, are in reality man and wife.

(3) FIRST RACE – OBJECTION – NO CHANGE

Following the first race, Jockey Gerardo Gavica lodged a claim of foul against Ramon Guce on the winner. After a thorough review of the 4½ furlong race, the Stewards could find no evidence to support Gavica's contention that he had been hindered throughout the race. No change was warranted.

(4) FIRST RACE – CLAIM VOIDED

The first race claim of "Paratito" (Ire.) by Trainer Charles Treece was voided after Dr. Beck notified the Stewards he was placing the gelding on the Vet's List as unsound. The horse was returned to Trainer Herbert Ho.

(5) NINTH RACE - REVIEW

Following the ninth race, the Stewards instructed Ed Burgart to announce the Stewards were reviewing an incident at the start. "Thirty Six Belles," racing in a flipping halter, pulled back just as Starter Slender dispatched the field, momentarily holding the doors shut. She was declared a starter as the problem was of her own doing.
