Report of the Board of Stewards for the week of July 22, 2014 through July 27, 2014.

TUESDAY

07/22/2014

(1) DUTY STEWARD

Ruben Moreno will be on duty this week attending to morning office matters and recording the minutes during this reporting period.

(2) ENTRIES AND DRAW

Nine races were drawn for Friday night's card consisting of three Thoroughbred and six Quarter Horse events. The draw was completed at 7:00 p.m.

(3) CAL-BRED REPORT

The seventh race in the book for Friday, California-bred three year olds and upward, claiming price \$6,250, going 330 yards, failed to fill with no entries (0 CAL-BREDS).

WEDNESDAY

07/23/2014

(1) SCRATCHES

Friday scratches were taken at 9:00 a.m. resulting in no scratches, one rider change, and no equipment changes for Friday evening's program.

(2) ENTRIES AND DRAW

Fourteen California-bred races were drawn for Saturday night's card consisting of fourteen Quarter Horse events. The draw was completed at 1:00 p.m.

(3) CAL-BRED REPORT

Nine races were drawn for Sunday night's card consisting of two Thoroughbred and seven Quarter Horse events. The draw was completed at 2:00 p.m.

(3) CAL-BRED REPORT

The seventh race in the book for Sunday, California-bred maidens, three years old and upward, going 330 yards, failed to fill with one entry (1 CAL-BRED).

FRIDAY

07/25/2014

(1) SCRATCHES

Scratches for Sunday were held at 9:00 a.m. resulting in no scratches, one rider change, and no equipment changes for Sunday evening's program.

(2) ALBERTO FILM REVIEW

Jockey Antonio Alberto appeared to review his ride in the eighth race on Sunday, July 20, 2014 in which his mount, #4 "Santa Daniela," broke out and bumped #5 "Finding Valentine." Film review showed Jockey Alberto attempting to correct his mount. The Stewards were satisfied with the effort that was made, and no sanction was given.

(3) BOULANGER INFORMAL HEARING

Jockey Brandon Boulanger appeared before the Stewards as requested to discuss his failure to maintain a proper riding weight. Of concern to the Stewards was Boulanger's propensity to gain weight. Jockey Boulanger assured the Stewards that he had started a new diet plan, and his weight would not be an issue in the future. Jockey Boulanger was advised a ruling would follow.

(4) DOMINGUEZ RULING

RULING #136

TRAINER ROBERTO DOMINGUEZ WHO STARTED THE HORSE "WEATHER WOMAN" IN THE FOURTH RACE ON MARCH 28, 2014 AT LOS ALAMITOS RACE COURSE IS FINED FIVE HUNDRED DOLLARS (\$500.00)* AND SUSPENDED THIRTY (30) DAYS (JULY 27, 2014 THROUGH AUGUST 25, 2014) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE) AND RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) (CLENBUTEROL - CLASS III).

THIRTY (30) OF THE DAYS OF SUSPENSION ARE STAYED. ROBERTO DOMINGUEZ IS PLACED ON PROBATION AND SHALL NOT HAVE ANY VIOLATIONS FOR ANY SUBSTANCE PROHIBITED UNDER RULE 1843 FOR A PERIOD OF THREE (3) YEARS FROM THE DATE OF THIS RULING. IF PROBATION IS VIOLATED SUBJECT SHALL SERVE THE THIRTY (30) STAYED DAYS.

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF ROBERTO DOMINGUEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) ROBERTO DOMINGUEZ IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Trainer Roberto Dominguez was notified of the Final Decision from the California Horse Racing Board. The results of that decision are reflected in the above ruling.

(5) GODINEZ RULING

RULING #137

TRAINER JESSE R. GODINEZ WHO STARTED THE HORSE "PAINT ME CHROME" IN THE FIFTH RACE ON MARCH 8, 2014 AT LOS ALAMITOS RACE COURSE IS FINED TEN THOUSAND DOLLARS (\$10,000.00)* AND SUSPENDED SIXTY (60) DAYS (JULY 27, 2014 THROUGH SEPTEMBER 24, 2014) PURSUANT TO CALIFORNIA HORSE RACING

BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) AND RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) (RACTOPAMINE – CLASS III) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JESSE GODINEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JESSE R. GODINEZ IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Trainer Jesse Godinez was notified of the Final Decision from the California Horse Racing Board. The results of that decision are reflected in the above ruling.

(6) CAMACHO RULING

RULING #138

OWNER JOSE CAMACHO WHO STARTED THE HORSE "WEATHER WOMAN" IN THE FOURTH RACE ON MARCH 28, 2014 AT LOS ALAMITOS RACE COURSE IS FINED TWO THOUSAND DOLLARS (\$2,000.00)* AND SUSPENDED THIRTY (30) DAYS) (JULY 27, 2014 THROUGH AUGUST 25, 2014) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843 (a,b&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES) (CLENBUTEROL - CLASS III).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE CAMACHO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JOSE CAMACHO IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Owner Jose Camacho was notified of the Final Decision from the California Horse Racing Board. The results of that decision are reflected in the above ruling.

(7) OLIVAS RULING

RULING #139

OWNER JOSE OLIVAS WHO STARTED THE HORSE "TR SPECIALTY" IN THE SECOND RACE ON DECEMBER 1, 2013 AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND DOLLARS (\$1,000.00)* AND SUSPENDED THIRTY (30) DAYS) (JULY 27, 2014 THROUGH AUGUST 25, 2014) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) (CETRIZINE – CLASS IV AND HYDROXYZINE – CLASS II) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING).

IN ADDITION, OWNER JOSE OLIVAS' HORSE, "TR SPECIALTY," MUST PASS A BOARD APPROVED EXAMINATION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1846 BEFORE BECOMING ELIGIBLE TO BE ENTERED AND BE SUBJECT TO DRUG TESTING AT THE OWNER'S EXPENSE AND BE NEGATIVE FOR PROHIBITED DRUG SUBSTANCES AS DEFINED IN CALIFORNIA HORSE RACING BOARD RULE #1843.1.

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE OLIVAS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JOSE OLIVAS IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Owner Jose Olivas was notified of the Final Decision from the California Horse Racing Board. The results of that decision are reflected in the above ruling.

(8) VALENZUELA RULING

RULING #140

OWNER FERNANDO VALENZUELA, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 25, 2014, TO ANSWER A COMPLAINT REGARDING CASE #14LA0174, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF FERNANDO VALENZUELA ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Owner Fernando Valenzuela failed to appear to address financial complaints alleging money owed to Equine Sports Medicine.

(9) FIRST RACE – VOIDED CLAIM

Trainer Lorenzo Campuzano's first race \$2,500 claim on #2 "Hill Of Tara" was voided by the Stewards after Veterinarian Dr. Gary Beck declared the six-year-old mare had injured her right front knee during the running of the race. "Hill Of Tara" was placed on the Vet's List and returned to Trainer Elmer January's barn.

(1) GARCIA FILM REVIEW

Jockey Eddie Garcia appeared before the Stewards to review his Friday night ride in the sixth race aboard #5 "Joy Of Corona" who broke in, bumping #4 "RV Valentin." Jockey Garcia stated that his mount is heavy headed and that he was making an all-out effort, adding that the horse was sporting a prong bit for this reason. After film review, the Stewards agreed to attribute the blame to "Joy Of Corona" but still cautioned Jockey Garcia to react a little quicker to straighten his mount.

(2) AQUINO FORMAL HEARING – CASE #14LA0148

A formal hearing was conducted to address a positive finding of clenbuterol in the horse "Gracies Girl," the winner of the second race at Los Alamitos on June 15, 2014. Present at the hearing was the respondent, Trainer Angela Aquino, Special Investigator Kevin Kitashima presenting the case for the California Horse Racing Board, Court Reporter

Michelle Derieg recording the proceedings, Stewards George Slender, Ruben Moreno, James Dreyer, and Safety Steward Randy Winick.

Trainer Aquino, expressing great remorse for the bad test, testified that "Gracies Girl" had been a ship-in, arriving one day prior to racing and that she really did not know the owner of the horse very well. The Stewards reminded Trainer Aquino that, as the trainer of record, she was therefore responsible for the condition of the horse at race time. Trainer Aquino was advised a decision would be forthcoming, and the hearing was adjourned.

(3) ROBINSON AND DAVIS FINANCIAL HEARING – CASE DISMISSED

A complaint filed by Trainer Robert Lucas against Owners Kayleeta Robinson and Ben Davis for training bills amounting to \$18,558.00 was to be heard today as a continuation of a prior hearing. Argument from both parties escalated from the start. Owners Robinson and Davis stated Lucas' invoices were incorrect and that Lucas actually owed them money. Trainer Lucas stated too many untruths were being told, and he was dropping the case before the Stewards and would pursue the matter in civil court. A perplexed Board of Stewards said, "So be it," and the case was dismissed.

(4) BOULANGER RULING

RULING #141

JOCKEY BRANDON C. BOULANGER IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SUNDAY, JULY 20, 2014. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The foregoing ruling was issued as a follow-up to the Stewards' Friday night meeting with Jockey Brandon Boulanger.

(5) SMITH RULING

RULING #142

TRAINER VINCE SMITH IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION) ON FRIDAY, JULY 25, 2014

The above ruling was issued for Trainer Vince Smith's late arrival of the horse "JDF Peew," necessitating a Stewards' scratch.

(6) FIRST RACE – INQUIRY – NO CHANGE

The Stewards posted the Inquiry sign following the running of the first race (Quarter Horse – 400 yards) to review an incident at the start involving #10 "JDF Choice" (DNF – L. Gonzalez). Replays showed #10 rearing and losing his rider. The Stewards unanimously agreed that #10 "JDF Choice" caused his own problems as the gate opened and was declared a starter.

(7) SECOND RACE – INQUIRY – DISQUALIFICATION

After the finish of the second race (Quarter Horse – 350 yards), the Stewards posted the Inquiry sign to review an incident that occurred approaching the 1/8th pole. Involved in the incident were #7 "Kiddychan" (5th – G. Tapia) and #6 "Babys Walking" (9th – C. DeAlba). Film review showed #7 "Kiddychan" lugging in and shutting off #6 "Babys Walking," costing the latter an opportunity of better placing. The Stewards unanimously agreed to disqualify #7 from fifth and place him last.

(8) THIRD RACE – INQUIRY – DISQUALIFICATION

The Inquiry sign was again posted after the running of the third race (Quarter Horse – 350 yards) to review an incident that occurred before the 1/8th pole involving #4 "Off Beat" (4th – R. Sanchez) and #5 "Vacheron" (8th – C. Huerta). Replays show the inside horse, #4 "Off Beat," lugging out into the path of #5 "Vacheron," causing him to almost clip heels. After

talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify #4 "Off Beat" from fourth and place him last.

Original Order of Finish: 2 – 3 – 8 – (4) – 1 – 7 – 6 – 5

Official Order of Finish: 2 – 3 – 8 – 1 – 7 – 6 – 5 – (4)

(9) SIXTH RACE – TRAINER OBJECTION – NO CHANGE

After the finish of the sixth race (Quarter Horse – 550 yards), the Stewards posted the Objection sign at the request of Trainer Santos Perez. Trainer Perez alleged a claim of foul against #3 "Sadie Sis" (1st – A. Alberto), who made contact with Perez's horse, #4 "Cash Colt" (7th – R. Lozano), at the start of the race. After film review, the Stewards unanimously agreed to make no change in the order of finish, finding that "Cash Colt" had caused his own problems by having broken slowly, and the incident had no bearing on the final outcome of the race.

(2) VALENZUELA RULING

RULING #143

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1766 (DESIGNATED RACES), JOCKEY RAUL A. VALENZUELA, HAVING PARTICIPATED IN MORE THAN ONE RACE AT LOS ALAMITOS RACE COURSE ON STAURDAY, JULY 26, 2014, SHALL SERVE ONE ADDITIONAL SUSPENSION DAY (SATURDAY, AUGUST 2, 2014) IN ORDER TO SATISFY THE TERMS OF LOS ALAMITOS QUARTER HORSE RACING ASSOCIATION RULING #132, DATED JUNE 13, 2014.

This ruling was issued after Jockey Raul Valenzuela participated in more than one designated race during a term of suspension he was already serving.

(3) PURSE REDISTRIBUTION

RULING #144

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE #LA26069, TAKEN FROM THE HORSE "GRACIES GIRL" THE FIRST PLACE FINISHER IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON JUNE

15, 2014, TESTED POSITIVE FOR CLENBUTEROL (CLASS III). IT IS ORDERED THAT "GRACIES. GIRL" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$3,300.00) EARNED BY OWNER FERNANDO VALENZUELA, TRAINER ANGELA AQUINO AND JOCKEY VINNIE BEDNAR BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY AUGUST 26, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

The foregoing ruling was issued in compliance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test). Trainer Angela Aquino had been notified of the imminent disqualification ruling at her Friday hearing.

(4) TAPIA RULING

RULING #145

JOCKEY GENARO TAPIA WHO RODE "KIDDYCHAN" IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, JULY 26, 2014, IS SUSPENDED THREE (3) RACING DAYS (AUGUST 3RD, 8TH, AND 9TH, 2014) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FIFTH TO NINTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after reviewing Saturday's second race with Jockey Genaro Tapia. Films confirmed that Jockey Tapia failed to make an adequate effort to keep his mount straight. The rider had very little to say to exonerate himself.

(5) ALBERTO RULING

RULING #146

JOCKEY ANTONIO ALBERTO WHO RODE "SADIE SIS" IN THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, JULY 26, 2014, IS SUSPENDED THREE (3) RACING DAYS (AUGUST 3RD, 8TH AND 9TH, 2014) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

Jockey Antonio Alberto was in to review his ride from the previous evening's sixth race in which he allowed his mount to drift at the start. Jockey Alberto mentioned that he tried to straighten his mount but was hit from behind, which tipped his horse sideways. After reviewing films, the Stewards failed to concur with Jockey Alberto's explanation, feeling more effort was needed. The above ruling was issued.

(6) SANCHEZ RULING

RULING #147

JOCKEY RAMON SANCHEZ WHO RODE "OFF BEAT" IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, JULY 26, 2014, IS SUSPENDED THREE (3) RACING DAYS (AUGUST 3RD, 8TH, AND 9TH, 2014) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FOURTH TO LAST POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

Jockey Ramon Sanchez appeared before the Stewards to review his ride in Saturday night's third race aboard #4 "Off Beat." After reviewing films with the Stewards, Jockey Sanchez contentiously expressed that he had been bumped by the inside horse, which he felt was the catalyst for his mount lugging outward. The Stewards felt it was a flimsy excuse, and Jockey Sanchez was reminded to keep a straighter course in the future. The above sanction was given.

(7) SIXTH RACE – VOIDED CLAIM

Trainer Jose Moreno's \$16,000 claim on #3 "Als Big Hit" (Tr. M. Casselman) was voided by the Stewards after Veterinarian Dr. Gary Beck's examination of the four-year-old gelding at the Receiving Barn post-race found the horse to be unsound. "Als Big Hit" was placed on the Vet's List and returned to Trainer Mike Casselman's barn.
