Report of the Board of Stewards for the week of September 17, 2014 through September 21, 2014.

**WEDNESDAY**

09/17/2014

(1) DUTY STEWARD

James Dreyer will preside over entries and morning questions and shall author the minutes during this reporting period.

(2) CAL-BRED REPORT

The fourth race in the book, maidens three and up for a claim of \$12,500, was off with no entries.

(3) THE DRAW

Saturday's nine race program will be comprised of one Arabian, one Thoroughbred, and seven Quarter Horse races. The evening's feature will be the \$100,000 Go Man Go Handicap for Quarter Horses.

**THURSDAY**

09/18/2014

(1) SCRATCHES

Two scratches and one rider switch completed Saturday's program changes.

(2) CAL-BRED REPORT

The third race in the book, allowance two year olds, was called off with three (1 CAL-BRED).

(3) THE DRAW

Sunday's card will consist of one Arabian, two Thoroughbred, and six Quarter Horse events.

**FRIDAY**

09/19/2014

(1) NO RACING

There will be no Quarter Horse racing this evening. Racing will resume Saturday evening.

(2) SCRATCHES

Scratch time was completed at 9:00 a.m. resulting in seven rider changes.

**SATURDAY**

09/20/2014

(1) PURSE REDISTRIBUTION

RULING #169

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE #LA26496, TAKEN FROM THE HORSE "IMA FIRE LOVER," THE SECOND PLACE FINISHER IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON AUGUST 16, 2014, TESTED POSITIVE FOR ZILPATEROL (CLASS III). IT IS ORDERED THAT "IMA FIRE LOVER" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$1,822.00) EARNED BY OWNER GEORGE A. VILLALOBOS, TRAINER JORGE FARIAS AND JOCKEY GUILLERMO SUAREZ BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY OCTOBER 19, 2014 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)

REVISED ORDER OF FINISH IS AS FOLLOWS:

ALL RECORDS ARE ORDERED TO REFLECT THIS RULING IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1956 (RACE DECLARED OFFICIAL), THIS RULING SHALL NOT AFFECT THE PARI-MUTUEL PAYOFFS.

Having notified Trainer Farias and Owner Villalobos, both declined to attend, and in accordance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test), the foregoing ruling was issued.

(2) LANDA RULING

RULING #170

EXERCISE RIDER PABLO M. LANDA IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION FOR ONE YEAR FROM THE DATE OF THIS RULING FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (h) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE - MARIJUANA).

FURTHERMORE, PABLO M. LANDA SHALL SUBMIT TO EVALUATION BY THE WINNERS FOUNDATION AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

After an informal hearing, the above ruling was issued. Mr. Landa was warned that getting on horses while under the influence of any drugs will not be tolerated.

(3) WILLIAMS RULING

RULING #171

JOCKEY DAWN "DEE DEE" WILLIAMS IS HEREBY SUSPENDED FOR THIRTY (30) DAYS COMMENCING SEPTEMBER 20, 2014 THROUGH OCTOBER 19, 2014 FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – ABUSIVE BEHAVIOR)

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF DAWN "DEE DEE" WILLIAMS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

After an informal meeting with Jockey Dee Dee Williams, the foregoing ruling was issued. Ms. Williams was very remorseful about her actions and verbal attack on Jockey Kayla Stra.

(4) FILMS

Jockey Carlos Huerta was in to review Sunday's sixth race. Carlos let his mount drift in at the wire, causing the horse next to him to steady. The outcome of the race was unaffected, however, we felt Jockey Huerta should see it.

(5) DIXON RULING

RULING #172

GROOM TYLER DIXON IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION FOR ONE YEAR FROM THE DATE OF THIS RULING FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1489 (h) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE - MARIJUANA) AND #1890 (POSSESSION OF CONTRABAND).

FURTHERMORE, TYLER DIXON SHALL SUBMIT TO EVALUATION BY THE WINNERS FOUNDATION AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

After an informal hearing with Groom Tyler Dixon, the above ruling was issued. Mr. Dixon accepted full responsibility for his actions, stating he simply got caught up in his surroundings.

(6) EASLEY RULING

RULING #173

GROOM TATE EASLEY IS FINED ONE HUNDRED DOLLARS (\$100.00)\* AND PLACED ON PROBATION FOR ONE YEAR FROM THE DATE OF THIS RULING FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1489 (h) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE - MARIJUANA) AND #1890 (POSSESSION OF CONTRABAND).

FURTHERMORE, TATE EASLEY SHALL SUBMIT TO EVALUATION BY THE WINNERS FOUNDATION AND SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD.

As with Mr. Dixon, Groom Easley essentially had the same explanation for his actions resulting in the above ruling.

(7) SANCHEZ RULING

RULING #174

JOCKEY RAMON SANCHEZ WHO RODE "CAPTAIN ON TAKEOFF" IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, SEPTEMBER 14, 2014, IS SUSPENDED THREE (3) RACING DAYS (SEPTEMBER 27<sup>TH</sup>, 28<sup>TH</sup>, AND OCTOBER 3<sup>RD</sup>, 2014) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM A DEAD HEAT FOR THIRD TO BEING UNPLACED. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

After reviewing the third race with Jockey Ramon Sanchez, the above ruling was issued. Mr. Sanchez was unable to persuade us he had made an adequate effort to keep his mount straight, causing Rodrigo Aceves' mount to fall.

(8) WARNING ISSUED

After meeting with Exercise Rider Pablo Landa concerning Case #14LA0207, a warning was issued. Mr. Landa was instructed that unless he is invited by the trainer into his shedrow, he is not to enter the area.

(9) SIXTH RACE - INCIDENT

Prior to the break, three horses, #4 "Front And Center, #6 "Paint Your Attraction," and #7 "Minor Sam," broke through the gate. Two were caught immediately; however, "Paint Your Attraction" ran off and jumped the outside fence. Fortunately, he appeared to be uninjured.

(1) FILMS

Jockey Antonio Alberto was in to review last evening's eighth race. His mount was drifting in, and the Stewards felt he was rather lazy in his attempt to correct the situation. The outcome of the race was not compromised; however, we felt he should watch the replay.

(2) DANYLUK RULING

RULING #175

TRAINER KEN DANYLUK IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT) AND CALIFORNIA HORSE RACING BOARD RULE #1902.5 (ANIMAL WELFARE).

The foregoing ruling was issued after conducting an informal hearing with Trainer Ken Danyluk. Mr. Danyluk felt that Dr. Fitzgerald had a personal vendetta against him from an earlier incident but admitted to and accepted responsibility for his improper actions and language.

(3) FOURTH RACE – CLAIM VOIDED

The fourth race claim of "Titanic Had It" by Trainer Yanet Rodriguez was voided after Dr. Beck placed the horse on the Vet's List as unsound. The horse was returned to Trainer Ryan Hanson.
