(2) BOULANGER RULING

RULING #179

APPRENTICE JOCKEY BRANDON BOULANGER IS SUSPENDED FIFTEEN (15) DAYS (OCTOBER 4, 2014 THROUGH OCTOBER 18, 2014) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1500.1 (RANDOM DRUG TESTING – POSITIVE TEST FOR MARIJUANA), #1489 (H) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE) AND #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

IN ADDITION, SUBJECT WILL SIGN A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD, WILL SUBMIT TO AN EVALUATION BY THE WINNERS FOUNDATION, AND ABIDE BY ANY RECOMMENDATIONS MADE BY THAT ORGANIZATION.

DURING THE TERM OF SUSPENSION, ALL LICENSE AND LICENSE PRIVILEGES OF BRANDON BOULANGER ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES WITHIN THIS JURISDICTION.

The above ruling was issued after Jockey Boulanger appeared before the Stewards as requested when the test results from Quest Laboratories came back positive for marijuana. Jockey Boulanger was removed from the evening's mount.

(3) WILLOUGHBY RULING

RULING #180

TRAINER SCOTT WILLOUGHBY WHO STARTED THE HORSE "JOY OF CORONA" IN THE SIXTH RACE ON AUGUST 22, 2014, AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND DOLLARS (\$1,000.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE), #1844 (c) (AUTHORIZED MEDICATION) AND #1843 (a&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES – PHENYLBUTAZONE (2.68 ug/ml) – CLASS IV).

An informal hearing was conducted to address California Horse Racing Board Case #14LA0210. Present were Trainer Scott Willoughby, Investigator Dennis Drulias, and the three Stewards: James Dreyer, Ruben Moreno and George Slender. Trainer Willoughby stated after doing a lot of research that the company he was doing business with changed the strength of the bute paste to a higher level. This is subject's third offense.

(4) GUY RULING

RULING #181

AGENT SCOTT GUY IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT).

The preceding ruling was issued due to the jockey agent pleading guilty to creating a disturbance and his attitude towards officers. He apologized for his actions.

(2) HIGH BUTE

Trainer Lorenzo Campuzano appeared for an informal hearing concerning a bute overage. This is the trainer's first bute violation, which was 3.11 ug/ml. Therefore, a warning was issued.

(3) CASTANEDA RULING

RULING #182

TRAINER KELLY CASTANEDA WHO WORKED THE HORSE "PRIMISTAL PEAK" ON AUGUST 23, 2014, AT LOS ALAMITOS RACE COURSE IS FINED FIVE HUNDRED DOLLARS (\$500.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE) AND #1866 (VETERINARIAN'S LIST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1844 (c-1) (AUTHORIZED MEDICATION) AND #1843 (a&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES - PHENYLBUTAZONE) (6.65 ug/ml) (CLASS IV).

The above ruling was issued after this Board gave Mr. Castaneda an informal hearing concerning his bute overage of 6.65 ug/ml. His excuse was that his groom medicated the horse the same day he worked to get off the Vet's List. Subject was informed to take a more hands-on approach in taking care of his business.

(4) THIRD RACE - LATE DECLARATION - REFUND

A refund was ordered in the third race as #4 "Oinkus" (Tr. F. Gonzalez) was off in the left front during the warm up and was declared on recommendation of Track Veterinarian Dr. Fitzgerald. Refund: \$6,894.00.

(5) FIFTH RACE - LATE DECLARATION - REFUND

A refund was ordered in the fifth race when State Veterinarian Dr. Gary Beck reported that #3 "Time For A.J." (Tr. R. J. Lucas) was unsound. Declared by the Stewards. Refund: \$1,568.00.

(6) SEVENTH RACE - VOIDED CLAIM

A claim submitted for #2 "Max The Cash" in the seventh race was voided after the horse was placed on the Veterinarian's List due to unsoundness following the race. The horse was returned to the barn of Trainer C. Treece.

CALIFORNIA HORSE RACING BOARD COMPLAINT #14LA0089 HAVING BEEN WITHDRAWN, OWNER ERNESTO DUKES' LICENSE PRIVILEGES ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #84 DATED APRIL 26. 2014, SUSPENDING MR. DUKES FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1489 (H) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING) IS HEREBY SET ASIDE AND ERNESTO DUKES IS RESTORED TO GOOD STANDING.

The foregoing ruling was issued after the Stewards were informed that all charges that were filed against him were withdrawn. Therefore, subject was restored to good standing.
