Following the running of the third race (Quarter Horse – 870 yards), the Stewards immediately posted the Inquiry sign to review an incident going into the turn, which involved #3 “Overwhelmer” (Jockey O. Macias) who clipped the heels of #4 “Sir Kip” (1<sup>st</sup> – Jockey G. Gavica) and fell. While trailing the field, #1 “Cammazes” (5<sup>th</sup> – Jockey R. Guce) stumbled over the fallen horse. Jockey Macias was transported to Los Alamitos General Hospital complaining of his shoulder. The horse galloped off and appeared to be okay. No action by the Stewards was warranted.
