Report of the Board of Stewards for the week of December 30, 2014 through January 4, 2015.

**TUESDAY**  
12/30/2014**(1) DUTY STEWARD**

Steward Randy Winick will fill in for Steward James Dreyer for four days this week (December 30<sup>th</sup>-January 2<sup>nd</sup>) as Mr. Dreyer is taking a short break for the New Years holidays. Steward Winick will write the minutes and supervise the morning activities as well as one day of racing action until Mr. Dreyer returns.

**(2) CAL-BRED REPORT**

The fourth race in the book for Friday, maiden CAL-BREDS for a claiming price of \$4,000, at three hundred yards, was off without a single entry, and the sub #1 for CAL-BREDS, claiming \$25,000 open, at three hundred and thirty yards, was off with one.

**(3) ENTRIES AND DRAW**

Racing entries are back to a normal Tuesday, Wednesday, and Thursday schedule as the extended time between the draw and actual racing program did not pan out for various reasons. Los Alamitos will go with eight-race cards for the near future until the horse ready population improves.

Today's draw for Friday commenced at 3:00 p.m., resulting in an eight-race program consisting of five Thoroughbred and three Quarter Horse contests.

**WEDNESDAY**  
12/31/2014**(1) SCRATCHES**

This morning's scratch deadline produced only one declaration and two rider changes.

**(2) CAL-BRED REPORT**

The first race in the book for CAL-BREDS, maiden three year olds for \$5,000 claiming at three hundred yards, went open with six (4 CAL-BREDS). The sixth in the book, CAL-BRED four year olds and upward at three hundred and fifty yards, drew no entries and was called off.

**(3) ENTRIES AND DRAW**

The entries for Saturday were drawn at 5:00 p.m., and the resulting card will feature eight races composed of six Quarter Horse and two Thoroughbred affairs.

**THURSDAY**

01/01/2015

(1) SCRATCHES

There were two rider adjustments at the regular 9:00 a.m. scratch time.

(2) CAL-BRED REPORT

Both CAL-BRED races offered in the condition book were off without an entry in either. The fourth race was for CAL-BRED three year olds for a \$20,000 claim, and the sub #1 was for CAL-BRED maidens, four years old and upward for a claiming price of \$5,000.

(3) ENTRIES AND DRAW

The entries for Sunday were closed and drawn at 3:00 p.m., and a program of eight races was carded consisting of six Quarter Horse and two Thoroughbred events.

**FRIDAY**

01/02/2015

(1) SCRATCHES

This morning's 9:00 a.m. scratch call yielded only one rider adjustment.

(2) FOURTH RACE – DOUBLE INQUIRY – SINGLE DISQUALIFICATION

Following the running of the fourth race (Quarter Horse – 300 yards), the Stewards called for the Inquiry sign to be posted for an incident involving two separate incidents. The first was concerning #1 "Lummis Dash" (2<sup>nd</sup> – A. Alberto) who came over from the #1 post position to cross in front of #3 "My Inner Goddess" (6<sup>th</sup> - G. Suarez) who took up sharply. The second incident involved #6 "One Roadshow" (1<sup>st</sup> – C. Marquez) who came inward late, just about thirty yards from the finish, causing the jockey on #4 "Moreno Guapo" (3<sup>rd</sup> – A. Luna) to pause his push just slightly and raise the question of a possible foul.

After reviewing the replay numerous times, the Stewards decided unanimously to disqualify #1 from second to sixth place in the first incident for interference and to leave stand the winner #6 as that horse appeared to be just clear and not costing a #4 a better placing. However, both riders will be in to see the Stewards tomorrow afternoon for less than stellar riding.

**SATURDAY**  
01/03/2015

(1) FILMS

Apprentice Omar Santos reviewed last evening's fourth race with the Stewards. His mount broke in, and although the incident was rather minor, we felt since he was fairly new on the scene he should be made aware of the ground rules.

(2) FILMS

Jockey Carlos Marquez reviewed Friday's fourth race with the Stewards. Approaching the finish, he allowed his mount to drift in. We did not feel the outcome of the race was affected but felt he should see the film.

(3) ALBERTO RULING

RULING #4

JOCKEY ANTONIO ALBERTO WHO RODE "LUMMIS DASH" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, JANUARY 2, 2015, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 10TH, 11TH, AND 16TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO SIXTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after Jockey Alberto was unable to convince the Stewards that his best effort had been made to straighten his mount resulting in his disqualification.

(4) FIRST RACE – INQUIRY - DISQUALIFICATION

The Stewards posted the Inquiry following the first race to examine an incident shortly after the break in the 870 yard event. #8 "Best By Far" (1<sup>st</sup> – V. Bednar) came in, pushing #7 "Justamitch" (2<sup>nd</sup> – O. Santos) in. "Best By Far" corrected while "Justamitch" continued in, causing #6 "Snowlucky" (8<sup>th</sup> – C. Chaparro) to take up. After speaking to the involved riders and a thorough review of the film, the Stewards in a majority vote elected to disqualify "Justamitch." Steward Dreyer dissented, feeling both horses should have come down.

(1) SANTOS RULING

RULING #5

APPRENTICE JOCKEY OMAR HERRERA SANTOS WHO RODE "JUSTAMITCH" IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, JANUARY 3, 2015, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 11TH, 16TH, AND 17TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM SECOND TO SEVENTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD

RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after Apprentice Omar Santos was unable to convince the Stewards he had made an adequate effort to straighten his mount in the first race, resulting in his disqualification.

(2) BEDNAR RULING

RULING #6

JOCKEY VINNIE BEDNAR WHO RODE “BEST BY FAR” IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, JANUARY 3, 2015, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 11TH, 16TH, AND 17TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

After reviewing last evening’s first race with the Stewards, Jockey Vinnie Bednar was given a three day suspension having made a dismal effort during the first one hundred yards of the race to maintain a straight course.
