(2) COBB RULING

RULING #22

OWNER CODY COBB, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JANUARY 30, 2015, TO ANSWER A COMPLAINT REGARDING CASE #15LA0004, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF CODY COBB ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Owner Cody Cobb failed to appear to address an alleged debt owed to Equine Sports Medicine in the amount of \$2,128.49.

(3) FINANCIAL HEARING

An informal hearing was conducted to address Equine Sports Medicine's claim of an unpaid balance of \$505.00 owed to them by Owner Ray Jamison. Mr. Jamison admitted to not paying the balance owed because he felt he was overcharged for the services rendered. After hearing Mr. Jamison's testimony, the Stewards agreed to a settlement of \$340.00.

SATURDAY

(1) WARNING ISSUED

Trainer Jim Bumgardner spoke with the Stewards telephonically regarding Case #15LA0001. At issue was the high Phenylbutazone count (2.56 ug/ml) found in the test taken on "Summer Pad" who finished second in the second race at Los Alamitos on December 20, 2014. Mr. Bumgardner was the trainer of record. Since it was Trainer Bumgardner's first offense, a warning was issued.

(2) CERVANTES FORMAL HEARING

Veterinarian Carlos Cervantes appeared to address complaint #15LA0005 alleging violation of California Horse Racing Board Rule #1842 (Veterinarian Report). Also present at the

hearing were Supervising Special Investigator Tom Blake, Special Investigator Kevin Kitashima who presented the case for the California Horse Racing Board, Court Reporter Michelle Derieg who recorded the proceedings, Stewards George Slender, James Dreyer and Ruben Moreno, and Safety Steward Randy Winick.

At issue was Dr. Cervantes' failure to file a confidential report with California Horse Racing Board State Veterinarian Dr. Gary Beck disclosing his September 2014 treatment of the horse "Your My Lady" who later died in December 2014. While Dr. Cervantes originally could not provide copies of his confidential reports for his five-day treatment of "Your My Lady," he submitted to the Stewards a copy of a confidential he subsequently found. Dr. Cervantes testified that at the time of his treatment, "Your My Lady" was running a temperature of 105 and showed signs of discomfort in her two front feet. He further stated that after treating "Your My Lady" for five days, her temperature was back to normal, and he never saw her again. Dr. Cervantes concluded that, in his opinion, the horse was okay and going to be shipped home.

Dr. Cervantes was advised a decision would follow.

(3) SIXTH RACE – INQUIRY - DISQUALIFICATION

After the finish of the sixth race, Los Alamitos Maiden Stakes Trial (Quarter Horse – 350 yards), the Stewards posted the Inquiry sign to review the start. Involved were #7 "Rocknandrollin" (5th – Suarez), #6 "Vomvos" (7th – Sanchez) and #5 "Funny Munny" (9th – Bautista). After talking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #7 for breaking sharply in at the start and bumping #6, who in turn shut off #5, costing both a chance at a better placing.

(4) DE ALBA RULING

RULING #23

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1766 (DESIGNATED RACES), JOCKEY CESAR DE ALBA, HAVING PARTICIPATED IN MORE THAN ONE DESIGNATED RACE WHILE UNDER SUSPENSION, SHALL SERVE ONE ADDITIONAL SUSPENSION DAY (SUNDAY, FEBRUARY 15, 2015) IN ORDER TO SATISFY THE TERMS OF L.A.Q.H. RULING #19, DATED JANUARY 24, 2015.

The foregoing ruling was issued after Jockey Cesar De Alba rode in multiple races at Los Alamitos Race Course on Saturday, January 31, 2015.
