Report of the Board of Stewards for the week of March 24, 2015 through March 29, 2015.

**TUESDAY**

03/24/2015

**(1) DUTY STEWARD**

Responsible for morning activities will be James Dreyer who will also author the minutes during this reporting period.

**(2) CAL-BRED REPORT**

The second race in the book, maiden fillies and mares three and up, was off with three (2 CAL-BREDS).

**(3) THE DRAW**

An early evening draw produced six Thoroughbred and two Quarter Horse races.

**WEDNESDAY**

03/25/2015

**(1) SCRATCHES**

Three rider switches and one declaration completed Friday's program changes.

**(2) CAL-BRED REPORT**

Sub #2 in the book, three and up for a \$2,500 claim, was off with no entries.

**(3) THE DRAW**

A 2:00 p.m. draw resulted in four Thoroughbred and an equal number of Quarter Horse races.

**THURSDAY**

03/26/2015

**(1) SCRATCHES**

Two jockey switches completed Saturday's program changes.

**(2) CAL-BRED REPORT**

The first race in the book, maidens three and up for a \$16,000 tag, was called off with one (0 CAL-BREDS).

**(3) THE DRAW**

Sunday will be a repeat of Saturday with the races being divided equally between Quarter Horses and Thoroughbreds.

(1) SCRATCHES

Scratch time resulted in two rider changes.

(2) FILMS

Jockey Carlos Huerta reviewed Sunday's second race with the Stewards today. His mount broke in, and we felt he was a bit tardy reacting. He was warned a better effort will be expected from him in the future.

(3) MORENO RULING – CASE #15LA0031

RULING #54

TRAINER JOSE A. MORENO WHO STARTED THE HORSE "YACHT CLUBBER" IN THE SEVENTH RACE ON JANUARY 23, 2015, AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00)\* AND SUSPENDED TEN (10) DAYS (APRIL 3, 2015 THROUGH APRIL 12, 2015) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS & OTHER SUBSTANCES) AND #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1844 (F10) (AUTHORIZED MEDICATION – METHYLPREDNISOLONE – CLASS IV).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE A. MORENO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JOSE A. MORENO IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Following an informal hearing with Trainer Jose Moreno concerning Case #15LA0031, the above ruling was issued. Mr. Moreno could not explain how methylprednisolone got in the horse's system. Again, it was another case of a horse being shipped in from a ranch. In this case, however, the ranch belongs to Moreno. The vet doing his ranch work does not practice on the track and may not have been aware of medication changes.

(4) MORENO RULING – CASE #15LA0055

RULING #55

TRAINER JOSE A. MORENO WHO STARTED THE HORSE "YACHT CLUBBER" IN THE EIGHTH RACE ON FEBRUARY 21, 2015, AT LOS ALAMITOS RACE COURSE IS FINED THREE THOUSAND DOLLARS (\$3,000.00)\* AND SUSPENDED TWENTY (20) DAYS (APRIL 13, 2015 THROUGH MAY 2, 2015) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS & OTHER SUBSTANCES), #1843.1 (A) (PROHIBITED DRUG SUBSTANCES – ISOFLUPREDONE) AND #1887 (A) (TRAINER TO INSURE CONDITION OF HORSE).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE A. MORENO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) JOSE A. MORENO IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after an informal hearing concerning the same horse that was addressed in Case #15LA0031. In this instance, the medication was Isoflupredone. Again, Mr. Moreno had no explanation. Not being on top of his operation has become very costly.

(5) ALVAREZ RULING

RULING #56

GROOM MARCIAL ALVAREZ IS FINED TWENTY-FIVE DOLLARS (\$25.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – WASHING DOWN PAVEMENT).

The above ruling was issued after groom Marcial Alvarez was cited for excessive water use.

(6) FILMS

Jockey Gary Boag was in to discuss his ride in Sunday's fourth race, an 870-yard event. Going into the turn, his mount appeared to drop in a bit sharply. As to the degree of interference that occurred, the films were inconclusive, and no change was made.

(7) STARRY SKIES

Friday evening's eight race program was completed without incident.

(1) FISCAL RULING

RULING #57

TRAINER SERGIO FISCAL WHO STARTED THE HORSE "LOOKING FOR GIRLS" IN THE SIXTH RACE ON FEBRUARY 13, 2015, AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND TWO HUNDRED AND FIFTY DOLLARS (\$1,250.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULES #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE), #1844 (c) 1 (AUTHORIZED MEDICATION), #1843 (a&d) MEDICATION, DRUGS & OTHER SUBSTANCES – PHENYLBUTAZONE (2.31 ug/ml) AND FLUNIXIN (16.2 ng/ml – CLASS IV), AND #1843.1 (b) (PROHIBITED DRUG SUBSTANCES).

Following an informal hearing with Trainer Sergio Fiscal, the above ruling was issued. Sergio accepted responsibility but could not understand how it happened, explaining that all of his medication is handled by his vet.

(2) FILMS

Jockey Genaro Tapia reviewed last Sunday's second race with the Stewards this afternoon. His mount broke in, and his effort to correct the gelding was very weak. He was let off with a warning.

(3) TREECE RULING

RULING #58

TRAINER CHARLES TREECE WHO STARTED THE HORSE "NOW YOU'RE IT" IN THE THIRD RACE ON FEBRUARY 13, 2015, AT LOS ALAMITOS RACE COURSE IS FINED TWO HUNDRED AND FIFTY DOLLARS (\$250.00)\* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULES #1887 (a) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1843 (a&d) (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND #1844 (C-1) (AUTHORIZED MEDICATION – PHENYLBUTAZONE IN EXCESS OF PERMITTED LEVEL (3.40 ug/ml – CLASS IV).

The foregoing ruling was issued after an informal meeting with Chuck Treece. He said he did nothing out of the ordinary with the horse. An interesting note, the previous trainer had a high bute with the same horse. We informed Chuck of that and suggested he may want to change his dosage on "Now You're It."

(4) FIRST RACE – BREAK DOWN

Shortly after the break in the 4½ furlong first race, #3 "Hot Rock Hallie" appeared to break down. She was racing in the clear, and no other horses were involved. Accident report included.

(5) FIFTH RACE – INQUIRY – ACCIDENT – NO CHANGE

The Stewards posted the Inquiry following the fifth race to review an accident shortly after the break in the 4½ furlong race. #4 "Onagadori" (fell – C. Charlton) was attempting to angle towards the rail when she bumped into #3 "Indian Proof" (1<sup>st</sup> – C. Chaparro), losing her footing and unseating Charlton. The incident was entirely the fault of Charlton, and no change was warranted.

(6) CLAIM VOIDED

The fourth race claim of "Stel Just Me" by Trainer Adriana Aceves was voided after State Vet Dr. Beck placed the horse on the Vet's List as lame. The horse was returned to Trainer Roberto Dominguez.

(7) EIGHTH RACE – OBJECTION – NO CHANGE

Following the eighth race, the trainer of #4 "Barrel Babe" (5<sup>th</sup> – S. Mendez), Danny Montes, lodged an Objection against #5 "Bring Me Home" (2<sup>nd</sup> – M. Arana). After speaking to the riders and reviewing the tape, the Stewards felt the claim had no merit, and no change was made.
