RULING #118

JOCKEY AGENT NEIL BRICKS IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – FAILURE TO CONDUCT BUSINESS IN PROPER MANNER).

The above ruling was issued after Agent Neil Bricks accepted full responsibility for entering the wrong horse, causing a five horse field when the horse had to be declared.

The only locales affected were the California sites. As soon as the error was discovered, inserts were printed out and distributed to the various locations.

(4) SEVENTH RACE – INQUIRY

The Stewards posted the Inquiry following the seventh race to examine the break. #4 "Sepindinero" false broke simultaneously with starter Brinson dispatching the field. The assistant starter failed to release the filly, however, prompting the Stewards to declare the horse a non-starter.
