09/29/2015

(1) DUTY STEWARD

(2) CAL-BRED REPORT

The second race in the book for Friday, maiden fillies two years old, was used open (1 CAL-BRED).

(3) THE DRAW

The Blane Schvaneveldt Handicap will be the feature event on Friday's nine-race program.

(1) SCRATCHES

Five weight corrections, the declaration of two also-eligibles, and one rider change completed Friday's program changes.

(2) CAL-BRED REPORT

The fourth race in the book, maidens two years old, was used open (1 CAL-BRED).

(3) THE DRAW

Nine races were on tap Saturday evening with the feature being the \$385,000 PCQHRA Breeders Futurity.

(2) CAL-BRED REPORT

The sixth race in the book, three and up for a \$3,200 tag, was off with two (1 CAL-BRED).

Scratch time resulted in seven rider changes.

(2) SIRIN RULING

RULING #157

IN THE MATTER OF: EDWIN SIRIN

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF TRAINER EDWIN SIRIN ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #98, DATED JULY 3, 2015, SUSPENDING MR. SIRIN FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND EDWIN SIRIN IS RESTORED TO GOOD STANDING.

Having now satisfied his outstanding debt to Equine Sports Medicine, the above ruling was issued.

(3) FILMS

After reviewing Sunday's fourth race with Eduardo Nicasio, we felt that he was blameless when his mount ducked out, causing a disqualification.

(4) MENDEZ RULING

RULING #158

JOCKEY CRUZ MENDEZ WHO RODE "KING DDAVID" IN THE THIRD RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, SEPTEMBER 27, 2015, IS SUSPENDED THREE (3) RACING DAYS (OCTOBER 9TH, 10TH, AND 11TH, 2015) FOR FAILURE TO MAINTAIN A STRAIGHT COURSE AND CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after a majority vote, Dreyer dissenting, for days when Cruz Mendez made a weak effort to straighten his mount leaving the gate in the third race.

(5) GREG THOMPSON VISITS

Greg Thompson with Stallion Esearch was in to get permission for Cody Jensen to use his helmet cam in this evening's sixth race. The request was granted, provided both rider and trainer have no reservations with it.

(6) NINTH RACE – INQUIRY - DISQUALIFICATION

The Stewards posted the Inquiry following the ninth race to examine an incident approximately 100 yards out of the gate. #5 "Off Beat" (5<sup>th</sup> – O. Peinado) drifted in, causing #4 "Hot Shot" (7<sup>th</sup> – A. Luna), #3 "Personal High" (8<sup>th</sup> – E. Gomez) and #2 "Old Girl" (9<sup>th</sup> – C. Mendez) all to steady and definitely affecting their possible placing. After speaking to the riders involved and a thorough review of the tape, the Stewards voted unanimously to disqualify "Off Beat."

(1) PEINADO RULING

RULING #159

JOCKEY OSCAR PEINADO WHO RODE "OFF BEAT" IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, OCTOBER 2, 2015, IS SUSPENDED THREE (3) RACING DAYS (OCTOBER 10TH, 11TH, AND 16TH, 2015) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FIFTH TO NINTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after reviewing last evening's ninth race with Jockey Peinado and being unable to find any effort on his part to straighten his mount, resulting in his disqualification.

(2) SIXTH RACE – OBJECTION – NO CHANGE

Following the sixth race, Ricardo Guillen, trainer of #1 "First Down Clem" (6<sup>th</sup> – M. Arana), claimed an objection against #2 "Loves Two Coronas" (2<sup>nd</sup> – S. Mendez). After reviewing the incident leaving the gate, the Stewards felt the outcome of the race was not affected, and no change was made.
