HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER EDDY BUJANDA ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #38, DATED FEBRUARY 27, 2015, SUSPENDING EDDY BUJANDA FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND EDDY BUJANDA IS RESTORED TO GOOD STANDING.

The above ruling was issued after being notified by Equine Sports Medicine that owner Bujanda's debt to them had been satisfied.

OWNER JAIME CASILLAS HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON APRIL 8, 2016, TO ANSWER A COMPLAINT REGARDING CASE #16LA0101, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JAIME CASILLAS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after owner Casillas failed to appear to address complaint #16LA0101.

JOCKEY RAMON SANCHEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP – MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND - FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL 3RD, 2016.

The foregoing ruling was issued after Jockey Sanchez was guilty of violating rule #1688(b)(6).

He told me that with the information she produced they felt she was ineligible for an apprentice license. With that information and before stepping on any toes this board told her she needed to go back to the Stewards that had initially denied her the apprentice license and readdress the situation.

Jockey Omar Santos was in to review last Saturdays second race with the Stewards. His mount broke in very sharply and his effort to remedy the situation was minimal at best. He was warned that another lack luster effort would result in days.

Jockey Christian Aragon reviewed last Sundays first race with the Stewards. After reviewing the run to the turn several times all agreed the films were inconclusive and no action was taken.

(4) 1st RACE ACCIDENT-NO CHANGE

In mid turn of the 4 ½ furlong race #4 Tiz The Season went bad unseating Jockey Marcial Ramirez. Preliminary assessment was that the gelding fractured his left foreleg. The inquiry was not hung as Tiz The Season was running last and was in the clear when the accident occurred.
