This ruling was issued as Mr. ESPINOZA accepted responsibility for failing to register his horse as a bleeder at the proper time.

09/16/07³**RULING - #018**

Trainer BRIAN KORINER is fined THREE HUNDRED DOLLARS (\$300.00) for violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse – Failure to Report Gelding), on Sunday, August 26, 2007.

The foregoing ruling was issued after a telephonic hearing with the trainer into his failure to report a first-time gelding. KORINER was candid, stating the horse had been gelded at a ranch and that he was aware of the fact but forgot to note the change on the entry card.

09/16/07⁴**REFUND**

A refund was ordered in the first race (mules) as #8 LUCY IAM HOME unseated jockey DIHIGI GLADNEY and ran off into the stable area. The refund amounted to \$4,915.10.

09/16/07⁵**MINUS POOL**

A MINUS POOL OF \$32,997.58 was created in the fourth race as #7 LIVE FREE, the prohibitive favorite at odds of 1/5, finished in the “Show” position.

This ruling was issued after the Stewards received word that Mr. Hawkins had satisfied his debt to Dr. SKIP PARK in full.

RULING - #020

Owner RAFAEL DOMINGUEZ, having failed to appear before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of RAFAEL DOMINGUEZ are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine) subject is denied access to all premises within this jurisdiction.

This ruling was issued after Mr. DOMINGUEZ failed to appear to address charges alleging violation of the financial responsibility rule.

RULING – #021

Groom DAVID PAUL YOUNG is suspended for FIFTEEN DAYS (September 26 through October 11, 2007) for violation of California Horse Racing Board rule #1874 (Disorderly Conduct), as his actions constituted a violation of the terms of ruling #062, issued at Los Angeles Turf Club on February 18, 2007.

Additionally, subject must sign a testing agreement with the California Horse Racing Board and attend anger management counseling sessions as determined by Winners' Foundation. Failure to comply with the above stipulations shall result in the immediate suspension of his license.

During the term of suspension, all licenses and license privileges of DAVID YOUNG are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), he is denied access to all premises in this jurisdiction.

The preceding ruling was issued to finalize the complaint against YOUNG for violation of the terms of his ruling at Santa Anita and for an incident at Fairplex which mirrored the incident that occurred this past winter.

09/17/07⁵**OBJECTIONS – DISMISSED and UPHELD**

The Objection sign was posted after the first race as RAMON GUCE (4th, #4 Ds OKEY) lodged a claim of foul against SERGIO RUIZ (2nd, #2 CELEBRITY FLIGHT) for interference throughout the race. Additionally, jockey ANTHONY AYALA (3rd, #5 DEBS BOOT) claimed foul against NORBERTO ACEVES (1st, #6 MAKING FRIENDS) for interference shortly after the start.

After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing tapes of the incidents, the Stewards voted unanimously to dismiss the Objection lodged by GUCE as tapes showed that CELEBRITY FLIGHT was clear of him during the entire race. However, the Stewards upheld the Objection lodged by AYALA as tapes showed that MAKING FRIENDS drifted in to take the path of AYALA's mount and forced him to steady for several strides. The incident cost ANTHONY and his mount a better placing.

09/17/07⁶**REFUND**

A refund was ordered in the second race as #3 BCR TAKIN A RIDE was off in the left foreleg during warm up and was declared on the recommendation of Racing Veterinarian HOYME. The refund amounted to \$2,406.98.

09/17/07⁷**REFUND**

The Stewards ordered a refund in the fourth race as #5 PARADISE flipped and injured itself shortly after coming on the track and was declared on the advice of Racing Veterinarian HOYME. The refund totaled \$2,991.26.

09/17/07⁸**ACCIDENT/INQUIRY/DISQUALIFICATION**

The Inquiry sign was posted after the fourth race as the Stewards reviewed the circumstances which resulted in jockey JORGE HERRERA being unseated from his mount, #7 STORMLYN in the far turn.

After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing tapes of the incident, the Stewards voted unanimously to disqualify the third place finisher, #2 ON DUTY (T. Baze) from third to unplaced. Tapes show the horse bearing out in the turn causing STORMLYN to clip heels and stumble sharply, unseating HERRERA. Fortunately, the rider did not suffer any injuries and completed his remaining engagements.

HOLLYWOOD PARK RACING ASSOCIATION is fined THREE HUNDRED DOLLARS (\$300.00) for violation of California Horse Racing Board rule #1865 (Altering of Sex of Horse – Failure to note first-time gelding in official program) on July 6, 2007.

This ruling was issued after a telephonic hearing with Racing Secretary MARTIN PANZA over his crew's failure to properly note a first-time gelding in the program after it had been properly reported by the trainer. PANZA made no excuse other than it was the American Oaks weekend and the program went to print immediately after the races were drawn. Consequently, there was no chance to make corrections.

09/19/07³ **JOCKEYS EXCUSED**

JEFF WILLIAMS was replaced in the second race as he called and said that he could not make his assigned weight. JUAN ARIAS substituted for WILLIAMS.

ANTONIO CASTANON was excused from his final mount of the day after being examined by the track physician. His shoulder was hurting after he was hit by several dirt clods. A replacement rider was named.

#024 Owner SANDRA THOMASON, having failed to appear before the Board of Stewards to answer a complaint alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of SANDRA THOMASON are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine) subject is denied access to all premises within this jurisdiction.

These rulings were issued as both failed to appear to address financial complaints filed against them; MASRY for a veterinarian bill, and THOMASON for delinquent training fees.

Jockey JEFF WILLIAMS is fined the sum of ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) on Wednesday, September 19, 2007.

RULING – #026

Owner SCOTT STRANGIO, having appeared as ordered, is restored to good standing. Ruling OTTS #030 issued at Oak Tree at Santa Anita on October 19, 2005, is set aside.

The ruling was issued after STRANGIO appeared to address a security complaint filed against him in October of 2005.

RIDER REPLACED

ALONSO QUIÑONEZ was replaced in the third race as he failed to arrive at the room in time to fulfill his engagement. KYRA STRA replaced QUIÑONEZ.

09/20/07⁶

REFUND

A refund was ordered in the third race as #4 SPAREDBYTHESTORM was off in the left front during warm up and was declared on the recommendation of Racing Veterinarian HOYME. The refund totaled \$10,121.98.

09/20/07⁷**ACCIDENT/INQUIRY/RACE CANCELLED**

The Stewards posted the Inquiry sign after the sixth race to review an accident passing the 1/8 pole the first time around, which resulted in JOSE DOMINGUEZ, aboard #6 IRISH HONOR, being unseated. The ambulance crew was on the scene immediately, but was unable to move DOMINGUEZ to safety before the field entered the far turn. The Stewards notified outrider CURLY ORTIZ, who was positioned in the turn, to wave the riders off due to the crew and rider on the track. A review of the video tape confirmed that all riders eased their mounts to a gallop for the remainder of the race.

The Stewards were of the opinion that the situation met the criteria needed to cancel a race, in that riders did not persevere due to the unforeseen situation which occurred early in the event.

All straight wagers, Exacta, Trifecta, and Superfecta wagers were refunded. The Daily Double on races 6/7 was refunded. Other multiple race wagers became an "All" for race #6. Public address commentator TREVOR DENMAN informed the fans of the situation.

The refund from the cancellation amounted to \$441,364.40.

09/20/07⁸**STEWARDS' INQUIRY and DISQUALIFICATION**

The Stewards posted the Inquiry sign after the eighth race to review an incident in the far turn involving the second and fifth place finishers, #7 STITCHIT (A. Quiñonez), and #5 CATCH CANDY (T. Baze). BAZE also lodged an Objection.

After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing tapes of the incident, the Stewards – WARD dissenting – voted to disqualify STITCHIT from second to fifth position. The majority felt that QUIÑONEZ' mount came in to place BAZE in tight quarters and force him to take up sharply. The minority felt that QUIÑONEZ had his mount's hind end tipped by a shift from the inside.

This ruling was issued after QUIÑONEZ failed to offer an acceptable excuse for being late to the room, causing a late change of riders.

Jockey JUAN ARIAS is fined the sum of FIFTY DOLLARS (\$50.00) for reporting late to the jockeys' room on Friday, September 21, 2007, which is a violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report).

This ruling was issued after ARIAS had no excuse for reporting late to the room.

RULING - #030

Having reached a financial agreement with Dr. Skip Parks, owner LOUIS MASRY is restored to good standing. Ruling #023 issued at Fairplex Park on September 20, 2007, is set aside.

This ruling was issued after Dr. PARK called and stated that he was withdrawing his complaint as an agreement had been reached regarding the delinquency.

STEWARDS' INQUIRY – NO CHANGE

The Stewards posted the Inquiry sign after the twelfth race to review an incident in deep stretch involving the first and third place finishers, #8 FRANK THE BARBER (M. Pedroza) and #2 MR. NIGHTLINGER (A. Quñonez). Observation indicated that QUIÑONEZ steadied and that the winner was possibly involved.

After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing tapes of the incident, the Stewards voted unanimously to make no change in the placings. Tapes show that both horses contributed to the interference suffered by MR. NIGHTLINGER. The winner drifted in, while the third place horse

came out. Additionally, the interference was such that it did not cost QUIÑONEZ and his mount a placing.

Trainer JACK VAN BERG is fined THREE HUNDRED DOLLARS (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration), for violation of California Horse Racing Board rule #1843.5 (Horse Improperly Medicated), necessitating the late declaration of THE GOLDEN NOODLE from the ninth race on Monday, September 3, 2007.

This ruling was issued after a telephonic hearing with the trainer into the late declaration of his horse THE GOLDEN NOODLE from the Del Mar Debutante on September 3, 2007. Shortly before race time, the horse was seen being given what turned out to be a mixture of peppermint and glycerin, in contravention of the rules. VAN BERG said he has used the preparation throughout his career, just as his father had done. He said that he was not aware that such usage constituted a violation of the Race Day Medication rule. While he may not have known it was a violation, it does not relieve him of the responsibility to be cognizant of what can and cannot be administered.

Two minus pools were created in the first race when #6 BAR JF HOT TICKET and #4 SARAH NELSON, the two best mules on the circuit, finished first and second, respectively. There was a minus pool of \$19,607.16 in the Place pool, while there was a very unusual minus pool in the Quinella pool of \$1,199.27.

A refund was ordered in the fifth race as #1 BEARS WIN unseated the rider and ran off into the stable area. The refund totaled \$22,680.64.

During the term of suspension, all licenses and license privileges of JACK BENTLEY are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine) subject is denied access to all premises within this jurisdiction.

This ruling was issued after the Stewards received word from Dr. SKIP PARK that the trainer had not complied with a financial agreement he signed at Del Mar.

09/24/07³**RULING - #033**

Jockey RAMON SANCHEZ is fined the sum of ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) on Sunday, September 23, 2007.

This ruling was issued after SANCHEZ failed to fulfill his engagement in the second race on #6 FLASHIN BRUMMEL STRAWFLY.

SANCHEZ called during the card to say that the owner told him that he was going to be replaced and not to come to the room. A subsequent call to the owner proved enlightening as he said SANCHEZ called him and said he would not be able to ride as he had another engagement.

09/24/07⁴**RULING - #034**

Jockey DAVID FLORES is fined THREE HUNDRED DOLLARS (\$300.00) for leaving the Jockeys' Room without permission on Sunday, September 23, 2007, which is a violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report).

The preceding ruling was issued after a conversation with the rider over his leaving the Jockeys' Room without permission.

FLORES was observed standing in the starting gate when the horses broke for the sixth race. He had been warned during the first week of racing when he was seen riding on a tractor during the races. He came up with several excuses, none of which held water.

09/24/07⁵**RULING - #035**

Jockey JUAN ARIAS is fined the sum of FIFTY DOLLARS (\$50.00) for reporting late to the jockeys' room on Sunday, September 23, 2007, which is a violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report).

This ruling was issued after ARIAS failed to come up with an acceptable excuse for reporting late to the Jockeys' Room for the first race yesterday.

09/24/07⁶**REFUND**

A refund was ordered in the third race as #9 LADY KAMALA was off in the left foreleg during warm up and was declared on the advice of Racing Veterinarian HOYME. There was a refund due to the scratch but the figure is not available at this time.

09/24/07⁷**REFUND**

The Stewards ordered a refund in the sixth race as #10 IRISH HONOR went wrong in the left front leg during warm up and was declared after examination by Racing Veterinarian HOYME. There was a refund due to the declaration but the figure is not available at this time.

09/24/07⁸**LATE SCRATCH**

A late declaration occurred in the eleventh race as no rider was available to pick up the mount on #2 COLE DANCER. The originally scheduled rider, ADAN FUENTES, had called earlier in the card to say that he had just been informed that he was named to ride. He said he had suffered an injury a couple of months previously and today was his first day back working horse. Although there was a refund, the figure is not available at this time.

09/24/07⁹ MINUS POOL

A minus pool of \$22,165.85 was created in the eleventh race as #1 SELVATICA, the prohibitive choice at 1/5, proved the easiest of winners.

09/24/07¹⁰ MEET ENDING

The 2007 Pomona meeting closed out in style as there was a dead heat for Win in the last race between #8 EXCESS HEAT and #10 IT'S ME JONES.
