**ENTRY DAY**

One (1) mule, one (1) Arabian and eight (8) thoroughbred races will make up the card. Eighty-three (83) horses/mules are scheduled to go postward.

**SCRATCH DAY / ENTRY DAY**

Scratch time for opening day (June 18) was held this morning in the racing office. Clerk of Scales Gary Lawless handled the scratch board. One (1) scratch and three (3) jockey changes took place at the 9:00 a.m. deadline.

Ten (10) races were drawn today for Friday, June 19. One (1) Arabian, one(1) mule and eight (8) thoroughbred races make up the card. A total of ninety-two (92) horse/mules are scheduled to face Starter Robert Mooneyhan.

**Wednesday**06-17-09<sup>1</sup>**MANUEL CALVARIO MEETING**

Suspended trainer **MANUEL CALVARIO** appeared in the stewards' office this morning with a check for \$2,000 to pay **Jose O. Garcia** for farrier services. Horseshoer Garcia obtained a court judgment against trainer Calvario on April 24, 2009 in Alameda County Superior Court in Berkeley, California. A hearing (Ref: Case#09GG216) for this matter was scheduled for June 13, 2009 at the Golden Gate Fields stewards' office. Trainer Calvario failed to appear for the hearing and was subsequently suspended. (Ref: GGF Ruling #105)

Trainer Calvario appeared with a personal check made out for \$2,000 for Jose Garcia. The stewards refused to take the check and told trainer Calvario to bring cash or a cashier's check. More to follow.

06-17-09<sup>2</sup> **PATRICK GLEASON MATTER**

Supervising Investigator Anne Glasscock appeared in the stewards' office to talk about the '**PATRICK GLEASON** matter'. Mr. Gleason last trained horses in California during the fall of 2006. Recently he has trained horses in the states of Nebraska and Arizona. Mr. Gleason was refused a trainer's license July 2008 at the Solano County Fair in Vallejo by CHRB investigators.

Stewards Grant Baker and Will Meyers signed off on Mr. Gleason's license card following discussion with Supervising Investigator Anne Glasscock. Mr. Gleason then traveled to CHRB headquarters in Sacramento to meet with CHRB Chief Investigator Rad Coulter to finish his process of getting re-licensed.

06-17-09<sup>3</sup> **ENTRIES FOR SATURDAY / JUNE 20**

Entries were taken today in the racing office for Saturday, June 20. A total of twelve (12) races were filled. One (1) mule, one (1) Arabia, one (1) Quarter Horse and nine (9) thoroughbred races are slated. One hundred twenty-one (121) horses/mules are scheduled to start.

**Thursday**

06-18-09<sup>1</sup> **ENTRY DAY**

Entries were taken this morning for Sunday, June 21<sup>st</sup>. Eleven (11) races were filled and they are made up of one (1) mule, one (1) Quarter Horse and nine (9) thoroughbred events. Ninety-five (95) horses/mules are scheduled to start.

06-18-09<sup>2</sup> **CALVARIO REINSTATEMENT – RULING NO. 1**

In the matter of:

Owner/Trainer **MANUEL CALVARIO**

Owner/Trainer MANUEL CALVARIO, having now resolved the outstanding financial obligation to **Jose O. Garcia**, is hereby restored to good standing and Pacific Racing Association ruling #105, dated June 14, 2009, suspending Mr. Calvario for violation of California Horse Racing Board rule #1547 (Failure to Appear) is set aside.

Any further violation of California Horse Racing Board rule #1876 (Financial Responsibility) during the term of his license shall result in the suspension of all licenses of MANUEL CALVARIO.

The foregoing ruling was issued after suspended trainer **MANUEL CALVARIO** appeared in the stewards' office with a cashier's check for horseshoeing services performed by Jose O. Garcia. This check satisfies the terms of Ruling #105, issued by Golden Gate Fields stewards last Sunday, June 14<sup>th</sup>.

The bottom paragraph of this ruling adds additional language that addresses any future violations of CHRB rule #1876 (Financial Responsibility) with regards to Manuel Calvario.

In an additional matter, Manuel Calvario was detained by CHRB investigators in their office this morning at Stockton and later arrested by officers from the Stockton Police Department. Stockton police were acting upon a warrant out of San Mateo County (CA) in a matter involving delinquent child support payments. (Ref: GGF minutes – 02-26-09<sup>3</sup> & 04-09-09<sup>3</sup>)

06-18-09<sup>3</sup> **ANISETE LEON FILM REVIEW**

Jockey **ANISETE LEON** appeared in the stewards' office this morning with an interpreter (Owner/Trainer Art Riesgo). Jockey Leon appeared to view the tenth race that ran Sunday, June 14, 2009 at Golden Gate Fields. (Refer: 06-14-09<sup>8</sup>) Jockey Leon rode **MUQS QUEST**, who was disqualified from second to sixth in this race.

After receiving a DVD of the race this morning, San Joaquin stewards reviewed all angles of the race with jockey Leon. Race replays show #7 MUQS QUEST drifted in at 3/16<sup>th</sup> pole and make contact with the unofficial sixth place finisher #2 PROUD CAJUN (Russell Baze) forcing that rival to steady.

The stewards felt jockey Leon was slow to correct his mount after the initial drifting. His last riding suspension was six (6) weeks ago at Golden Gate Fields. This is borderline as far as what Stockton stewards would consider for a stiffer riding suspension. The stewards unanimously ruled to issue the following ruling:

**RULING NO. 2**

Jockey **ANISETE LEON**, who rode **MUQS QUEST** in the tenth race at Golden Gate Fields on Sunday, June 14, 2009, is suspended three (3) racing days (June 25, 26 and 27, 2009) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from second to sixth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

06-18-09<sup>4</sup> **JOCKEYS' ROOM MEETING**

The stewards met with the Stockton jockey colony to go over procedures for this two (2) week portion of the summer Fair Circuit. The importance of communication between the jockey's room and other officials was reviewed. Starting gate, the turns and stretch portions of the racetrack were reviewed with regards to riding in the race itself.

Whipping rules, jockey film review, jockey room security and jockey objection procedures were also reviewed.

06-18-09<sup>5</sup> **ACCIDENT / DELAY – Third Race**

Just prior to the start of the third race, jockey Chad Schvaneveldt (#1 ROSIANA) was thrown out the back of the starting gate just prior to dispatch. The human ambulance crew attended to jockey Schvaneveldt, who lay prone on the racetrack.

Track Veterinarian Robert Connolly recommended the late scratch of #1 ROSIANA after an examination of the horse. This incident led to a twelve (12) minute delay in the day's race card. An accident report of this incident is attached to these minutes.

**Friday**06-19-09<sup>1</sup> **ENTRIES FOR JUNE 24**

Entries were taken today for racing on Wednesday, June 24<sup>th</sup>. Ten (10) races filled for this card. One (1) mule, two (2) Arabian, and seven (7) thoroughbred races will be contested. Sixty-five (65) horses/mules are scheduled to start.

06-19-09<sup>2</sup> **DAVID LOPEZ FILM REVIEW – RULING NO. 3**

Jockey **David Lopez** appeared in the stewards' office to review replays from the fifth race on Sunday, June 14 at Golden Gate Fields (closing day). Lopez appeared here (Stockton) yesterday but film review was cancelled after the DVD of this race failed to surface.

Jockey Lopez rode original third place finisher **#7 QUANTUM THEORY** who was disqualified (Ref: 06-14-09 ) and placed fourth after drifting out at the 1/8 pole. Film review shows jockey Lopez whipping his mount several times left handed while drifting out into the path of fourth place finisher **#2 SUSPECT** (Jockey Francisco Duran). Jockey Lopez was candid stating that he should have stopped whipping after the drifting started. For this ride the stewards unanimously voted to issued the following ruling:

Jockey **DAVID LOPEZ**, who rode **QUANTUM THEORY** in the fifth race at Golden Gate Fields on Sunday, June 14, 2009, is suspended three (3) racing days (June 25, 26, and 27, 2009) for altering course without sufficient clearance in the stretch and causing interference resulting in the disqualification of his mount from third to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The terms of this suspension shall not prohibit participation in designated races in California.

06-19-09<sup>3</sup> **LARGE SHOW WAGER**

Large show wagers were made in the first (mule) race today. Over \$32,000 was wagered on winner **#3 BAR JF CYA** (Anthony Ayala) who went off at odds of 1/2.

Mutuel Coordinator Annette Snezek reported that a twenty thousand dollar (\$20,000) wager was made at Santa Anita and a ten thousand (\$10,000) wager was made at the Surfside Wagering Complex at Del Mar.

06-19-09<sup>4</sup> **INQUIRY – NO CHANGE – Ninth Race**

The stewards posted the inquiry sign after viewing post time favorite (odds 2/1) **#2 SHESOURKINDAGAL** (Modesto Linares) break six (6) or seven (7) lengths behind the field. In this general inquiry, race replays show this horse rear at the start causing her own problems.

In a unanimous vote, no change was made in the order of finish.

#### 06-20-09<sup>1</sup> **ENTRY DAY**

Entries were taken in the racing office this morning for Thursday, June 25. A total of ten (10) races are slated to be contested. A total of eighty-one (81) horses are scheduled to start.

#### 06-20-09<sup>2</sup> **MICHAEL MARTINEZ FILM REVIEW**

Jockey **Michael Martinez** appeared in the stewards' office to review the start of yesterday's (June 19) third race. Jockey Martinez was aboard #4 GIOVANNI (NZ) who finished second in this five (5) furlong race.

Race replays show that jockey Martinez was very slow to straighten his mount after breaking outwards.

The stewards told jockey Martinez a similar incident will lead to a riding suspension.

#### 06-20-09<sup>3</sup> **MEETING WITH STARTER**

The stewards called Starter **Robert Mooneyhan** into their office after an incident in yesterday's fifth race involving #8 NITA'S GAL (Trainer Willie Whitehouse / Jockey Modesto Linares). This horse flipped in the starting gate and was a late scratch. The stewards were addressing an informal complaint made via telephone following the race.

Starter Mooneyhan said this horse will be handled differently next start.

#### 06-20-09<sup>4</sup> **JAMEY THOMAS HEARING (Case No. 09GG224)**

Vendor **TODD STEPHENS** (COTT, Inc. dba Todd's Tack Shop) appeared in the stewards' office to address a complaint that he filed against trainer JAMEY THOMAS. The complaint packet on this matter was prepared by CHRB Senior Special Investigator Barbara Chimero.

Todd Stephens obtained a judgment against Mr. Thomas in Alameda County Small Claims Court in Berkeley, California, on February 13, 2009.

Mr. Thomas was not present for this hearing but was available via telephone. Trainer Thomas will sign a financial agreement with the agreement to pay vendor Stephens two hundred fifty (\$250.00) dollars a month until the amount of two thousand eight hundred twenty three dollars and five cents (\$2,823.05) is paid in full.

06-20-09<sup>5</sup> **RAMON A. MARAVILLA – RULING NO. 4**

Owner **RAMON A. MARAVILLA**, having now satisfied his financial obligation to San Francisco Equine in the amount of \$864.20, is hereby restored to good standing. Ruling #31, issued November 14, 2008 at Pacific Racing Association is set aside.

CHRB investigators were contacted by the veterinarian clinic, San Francisco Equine, with regards to an outstanding debt that was past due from owner **Ramon A. Maravilla**. They stated that all bills have been paid in full. This ruling restores Mr. Maravilla’s owner’s license to good standing.

06-20-09<sup>6</sup> **INQUIRY/DISQUALIFICATION/ACCIDENT – Third Race**

Jockey **Genaro Tapia** was unseated prior to the start of this third race (Quarter Horse maiden – 350 yards) and was attended to by track paramedics. His mount, #10 SARA TOGA, was subsequently scratched by the stewards upon the recommendation of track veterinarian Robert Connolly. An accident report is attached to these minutes.

The stewards posted the inquiry sign to observe an incident at the start. Second place finisher, #3 NO JOHNY COME LATELY (Gregorio Arriaga) broke in sharply, bumping fourth place finisher, #4 HAWKIN WALLY (Barrington Harvey). HAWKIN WALLY was beaten a nose for third position.

The stewards spoke with both riders involved. Jockey Gregorio Arriaga was ordered to film review. In a majority vote (Steward Moreno dissenting) #3 NO JOHNY COME LATELY was disqualified and placed fourth.

06-20-09<sup>7</sup> **JOCKEY OBJECTION – NO CHANGE – Fourth Race**

Following this fourth race jockey **KAYLA STRA**, who was aboard fourth place finisher #6 PADOLIN MUD, lodged a claim of foul. This objection was filed against third place finisher #3 ISABELQUA (Chad Schvaneveldt) for alleged interference at the 1/8<sup>th</sup> pole.

#3 ISABELQUA drifted in very slightly at the 1/8<sup>th</sup> pole. This incident was minor. The stewards ruled unanimously to make no change in the order of finish.

**Sunday**06-21-09<sup>1</sup> **ENTRY DAY**

The racing office was open today accepting entries for Friday, June 26<sup>th</sup>. One (1) mule, one (1) Arabian and eight (8) thoroughbred races were filled. Eighty-two (82) horses are scheduled to start.

06-21-09<sup>2</sup> **GREGORIO ARRIAGA FILM REVIEW**

Jockey **Gregorio Arriaga** appeared as ordered this morning for film review of the third race, Saturday, June 20, 2009. (Ref: 06-20-09<sup>6</sup>) Jockey Arriaga's mount, #5 NO JOHNY COME LATELY finished second but was disqualified and placed fourth in this race.

In this three hundred and fifty (350) yard quarter horse race, #5 NO JOHNY COME LATELY breaks in sharply making contact with original fourth place finisher #4 HAWKIN WALLY (Barrington Harvey). Race replays show jockey Gregorio Arriaga make a good effort to straighten his horse at the break. The stewards placed the blame in this incident on the horse itself, #5 NO JOHNY COME LATELY. The stewards unanimously voted to issue no penalty in this matter.

06-21-09<sup>3</sup> **OFFICIAL CHANGE**

Clerk of Scales Gary Lawless went home sick today at mid-morning. Official Ken Sjoldal filled in for the afternoon's racing card.

06-21-09<sup>4</sup> **ACCIDENT – Seventh Race**

Following the start of this one mile and one sixteenth race an accident took place as the starting gate began to go off the track, following the one mile and one sixteenth race.

Assistant Starter (rakeman) **David Fowler-Wright** was being attended to immediately by human ambulance personnel as this seventh race was being run. Preliminary reports were that David Fowler-Wright was either struck or run over by the wheels of the starting gate and/or tractor. Starter Robert Mooneyhan was present as David Fowler-Wright was being attended to on the track. This incident took place along the outside rail and did not affect the running of the race itself.

David Fowler-Wright was immediately transported to San Joaquin County General Hospital in Stockton. The California Horse Racing Board investigative staff was contacted. Also, CHRB Executive Director Kirk Breed was contacted at his home.
