09-16-14¹

ENTRY DAY

The racing office was open today accepting entries for the first day of racing at Stockton which is Friday, September 19th. There is not a county fair being held concurrently with the horse racing here. There is a three (3) day event being held here on the San Joaquin County Fairgrounds during this race meets first weekend (September 19, 20 & 21). This event is called 'Central Valley's Country BBQ Fest'. This event features a truck show, BBQ cook-off, fireworks and performances by 'Pablo Cruise' on September 19th and 'The Little River Band' on September 20th.

Racing official Dede Robinson drew the races for opening day. There will be a total of seventy-four (74) horses/mules scheduled to start in the nine (9) races carded for the Friday opener.

Wednesday

09-17-14¹

SCRATCH/ENTRY DAY

Scratches and changes for Friday, September 19th were taken in the racing office this morning. There was one (1) scratch and four (4) jockey changes submitted. All changes were activated after today's 9:00 a.m. deadline.

Entries for Saturday, September 20th were taken this morning in the racing office. Nine (9) races were drawn. Fifty-five (55) horses/mules are scheduled to face Starter Robert Mooneyhan.

Thursday

09-18-14¹ **SCRATCH/ENTRY DAY**

Scratches and changes for Saturday, September 20th were taken in the racing office this morning. There were four (4) jockey changes submitted. All changes were activated after today's 9:00 a.m. deadline. Nine (9) races were drawn for Sunday, September 21st. Fifty nine (59) horses/mules are scheduled to start.

Friday

09-19-14¹ **SCRATCH DAY**

Scratches and changes for Sunday, September 21st were accepted this morning in the racing office. There were no scratches. One jockey change was activated after today's 9:00 a.m. deadline.

09-19-14² **TIMER PROBLEMS**

Today's first three (3) races, which should have been electronically timed, were all hand timed due to a failure with the electronic timing system. The first three (3) races on today's opening card were:

- 1st Race – Quarter Horse – 350 yards
- 2nd Race – Quarter Horse – 350 yards
- 3rd Race – Mules – 400 yards

The American Quarter Horse Association (AQHA) determines the guidelines in which Quarter Horse speed indexes are calculated. These speed indexes are printed in the Daily Racing Form as a tool for horseplayers to use before placing wagers. Hand times should not be used as official times. Stockton Director of Racing Larry Swartzlander will be notified. More to follow.

09-19-14³ **ANOTHER TIMING ISSUE**

The fractional and final times were not displayed on the infield tote board today. Pegasus Communications employee Frank Matthews told the stewards that his company, which oversees the timing and video system here at Stockton, is working on the problem. More to follow.

09-19-14⁴ **RACE #4 - DELAY**

There was an eight (8) minute delay prior to the start of today's fourth race. The backup starting gate tractor was inoperable prior to the running of this one (1) mile event. After this tractor was removed from the racetrack it was discovered that an empty fuel tank was the reason for the problem with the tractor and the subsequent race delay.

09-19-14⁵ **RACE #4 – INQUIRY – NO CHANGE**

The stewards posted the Inquiry sign after viewing an incident as the field raced into the first turn of this one (1) mile event. The stewards were looking at the actions of third place finisher #1 TAKIN A DIP (Pedro Terrero) and fourth place finisher #2 KOOS IS LOOSE (Brayan Pena). #2 KOOS IS LOOSE bobbled while racing between horses on the first turn. The stewards wanted to determine if the actions of #1 TAKIN A DIP, who was clearly drifting out on the first turn, contributed to this occurrence.

After reviewing all replay angles and speaking to both jockeys involved the steward, in a unanimous decision, made no change to the order of finish. Jockey Pedro Terrero was ordered to film review with the stewards.

Saturday09-20-14¹ **PEDRO TERRERO FILM REVIEW (REF: 09-20-14⁵)**

Jockey Pedro Terrero appeared in the steward's office in order to review his ride in yesterday's (September 19th) fourth race. Terrero, who was aboard fourth place finisher #1 TAKIN A DIP, drifted out slightly while rounding the first turn in this one (1) mile event. The stewards all felt that Jockey Terrero could have alleviated pressure to a horse on his outside by keeping a straight course. The stewards unanimously felt this ride fell short of warranting a penalty but is worth memorializing in these minutes.

The stewards also reviewed the stretch run replays of yesterday's 5th race with Jockey Terrero. The purpose of this was to review Terrero's use of his riding crop while aboard #4 COUNTRY COUNTESS who finished fourth.

09-20-14² **TIMING SYSTEM ISSUES (REF: 09-19-14²)**

The electronic timer for today's three hundred fifty (350) yard race did not work. Clocker/Timer Melody Truitt hand timed the race. She caught the winning mule in 21.53 seconds. More to follow.

09-20-14³ **HOT JOCKEY**

Jockey Juan Hernandez had a good day as he finished first on four (4) out of his six (6) mounts on this Saturday card.

09-20-14⁴ **GOOD RACING**

Today's nine (9) races went well as they were free of steward's inquiries and/or jockey objections.

Sunday09-21-14¹ **RULING NO. 1 – ALEJANDRO GOMEZ INFORMAL MEETING**

Jockey Alejandro Gomez appeared in the steward's office accompanied by Jockey/Interpreter Juan Sanchez. Jockey Gomez reported to the jockey's room ninety (90) minutes late yesterday (September 20th). He said he didn't have the stewards' phone number which he could have used to request permission to be late. Jockey Gomez now has the stewards' phone number. He was fined fifty (\$50) dollars by California State Fair stewards (REF: Ruling #4 – July 12, 2014) for the same violation. The stewards issued the following ruling.

Jockey **ALEJANDRO GOMEZ** is hereby fined fifty dollars (\$50)* for violation of California Horse Racing Board Rule #1680 (Reporting to Jockey's Room – Late to Report) on Saturday, September 20, 2014 at the San Joaquin County Fair (Stockton).

09-21-14² **RACE #2 – TIMER GOOD (REF: 09-19-14² & 9-20-14²)**
 Today's timing system worked properly for this three hundred and fifty (350) yard mule event. Safety Steward David Nuesch has been working with the track electrician in order to fix the problem that has been prevalent this meet. Hopefully the timing problems for these short distance races have been fixed permanently.

09-21-14³ **RACE #3 – CAMERA PROBLEMS**
 The camera at the 3/8ths tower location failed to send a video signal to the judges' stand for today's third race. The stewards were unable to view a 'head on' shot of this five (5) furlong race as the field was dispatched and racing down the backstretch. Frank Matthews (Pegasus Communications) reported a 'cable problem' as the reason for the problem. The 3/8ths camera shot for the remainder of today's card was back to normal.

09-21-14⁴ **RACE #4 – STEWARDS' REVIEW**
 The stewards announced that a 'stewards' review' was taking place in order to take a look at the start of this race. First place finisher #4 WALLOPING LULA (Silvio Amador) broke outward in this 5 1/2 furlong event. Third place finisher #5 JILL'S JOY (Alejandro Gomez) broke very slowly. The stewards unanimously determined that there was no reason to conduct a stewards' inquiry.

09-21-14⁵ **RACE #4 – CLAIM VOIDED**
 Two (2) claims (different owners) were dropped by Trainer John F. Martin for \$25,000 on the horse #4 WALLOPING LULA who finished first in this race. Clerk of Scales Ken Sjordal reported that both 'Agreement to Claim' (CHRB-11) slips had this filly's name spelled as 'Walloping Lulu'. Both claims were voided by the stewards as both claim slips were misspelled.
