RULING #01

Jockey Martin Garcia appeared to review the eighth race from Hollywood Park run on December 22, 2007. The rider's mount was disqualified from the win for interference inside the sixteenth pole. Although Garcia was whipping his lugging-in mount left handed, this Board of Stewards were of the opinion that the rider could have prevented the interference by grabbing the outside rein.

LATS #01

Jockey MARTIN GARCIA, who rode WISE ONE in the eighth race at Hollywood Park on Saturday, December 22, 2007, is suspended THREE (3) racing days (January 3, 4, and 5, 2008) for failure to make a proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from first to fourth, which is a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

12/26/07³**RIDERS REVIEW RACE**

Jockeys David Flores and Alonso Quinonez appeared to review the seventh race from Hollywood Park on December 22, 2007. Both riders were cautioned to make better efforts to keep their mounts straight.

12/26/07⁴**JOCKS MEETING**

The Stewards, California Horse Racing Board Supervising Investigator Bill Westermann, and California Horse Racing Board Executive Director Ingrid Fermin ventured to the jockeys room for the traditional opening day meeting. The riders were reminded of the new “Super High Five” wager in the last race each day. The riders were cautioned to ride their mounts out to the finish for fifth money, especially in this race. The usual reminders were addressed and the riders concerns concluded the meeting.

12/26/07⁵**JOCKEY OBJECTION – NO CHANGE**

After the finish of the third race (six furlongs), the Stewards posted the objection sign at the request of jockey Patrick Valenzuela, aboard the sixth place finisher #2 No Lien Here. Valenzuela alleged interference by the second place finisher #5 Liberty Watch (jockey Aaron Gryder) at the five-sixteenth pole. After talking with the riders involved, hearing the patrol judge’s reports and reviewing the tape replays, the Stewards unanimously agreed to dismiss the objection. Replays failed to substantiate Valenzuela’s claim of foul as it appeared he always had room.

French apprentice jockey Aurelien Lemaitre, accompanied by agent Derek Lawson was approved for a license. The eighteen year old rider has won thirteen races in France, and will receive a 7 pound allowance.

Trainer JEAN PIERRE DUPUIS is fined THREE HUNDRED DOLLARS* (\$300.00) for violation of California Horse Racing Board rule #1698 (Failure to Start and Run – Medication), pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration).

12/29/07² **RIDER REVIEWS RACE**

Jockey Jose Valdivia, Jr. appeared to review yesterday's fifth race with the Stewards. The jockey was cautioned to be clear when altering course.

12/29/07³**RULING #03**

This ruling was issued after jockey Quinonez reviewed yesterday's second race with the Stewards. The Stewards are of the opinion the rider got careless when he made his own hole at the top of the stretch. Mr. Quinonez bumped his outside rival outward to create racing room for his own mount.

LATS #03

Jockey ALONSO QUINONEZ, who rode RIVERGRADE BOY in the second race at Santa Anita on Friday, December 28, 2007, is suspended THREE (3) racing days (January 5, 6, and 7, 2008) for altering course without sufficient clearance, which is a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

12/29/07⁴**FORMAL HEARING**

A formal hearing was conducted today to address California Horse Racing Board complaint #07DM023. The case concerns a class 2 drug positive involving trainer Mike Pender. The trainer agreed to a stipulated agreement of a thirty day suspension, fifteen of the days being stayed, and a \$7,500.00 fine. A ruling will be discussed today and probably issued tomorrow. At the request of the owner, a hearing regarding disqualification from purse money will be addressed at a later date.

Equine Medical Director Dr. Rick Arthur appeared as a witness. After testimony from both sides was heard and exhibits marked for identification, the hearing was adjourned. Decision will be determined at a later date.

LATS #04

Trainer MICHAEL PENDER, who started the horse "QUEEN OF THE DERBY" in the first race at Del Mar Thoroughbred Club on July 25, 2007, having entered into a stipulated agreement with the California Horse Racing Board, is suspended for thirty days (January 03, 2008 through February 01, 2008) and fined SEVENTY FIVE HUNDRED DOLLARS (\$7,500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1844 (A) (B) and (D) (Medication, Drugs, and other Substances); #1843.2 (Classification of Drug Substances – Guanabenz Class II).

Pursuant to the terms of the stipulated agreement, fifteen days (January 18, 2008 through February 01, 2008), shall be stayed provided that Respondent be placed on probation for a period of one year from the date of this ruling and not have any violations for Class 1, 2, or 3 drug substances.

LATS #05

For the first six days of racing, including today, there were nine Cal-Bred races.

01/01/08³**STEWARDS INQUIRY – NO CHANGE**

After the finish of the fourth race (El Conejo Handicap – 5 ½ furlongs) the Stewards posted the inquiry sign to review an incident in midstretch. Involved were the third place finisher #3 “Idiot Proof” (jockey David Flores) and the fifth place horse #1 “Barber” (jockey Richard Migliore). After talking with the riders, receiving the patrol judge’s reports and reviewing the tape replays, the Stewards unanimously agreed to make no change in the order of finish. Replays show #1 steady slightly in midstretch, as #3 puts him in tight quarters; however, the incident does not cost #1 a better placing.

01/01/08⁴**STEWARDS INQUIRY – DISQUALIFICATION**

After the finish of the ninth race (Monrovia Handicap – about 6 ½ furlongs on the grass) the Stewards posted the inquiry sign to review an incident at the sixteenth pole. Involved were the second place finisher #4 “Society Hostess” (jockey Jose Valdivia, Jr.) and the fifth place mare #1 “Strong Faith” (jockey Martin Garcia). After talking with the riders involved, receiving the patrol judge’s reports, and reviewing the tape replays, the Stewards unanimously agreed to disqualify #4

from second and place her fifth, behind #10 for interference in the stretch. Replays show #4 drift out into the path of #10, causing the latter to take up and lose the opportunity at a better placing.
