SANTA ANITA HEARING CASE #10SA038

With the permission of Vice President-General Manager George Haines III, this case went forward informally. Also in attendance were Director of Racing Mike Harlow and Director of Facilities and Grounds Jason Spetnagel. Safety Steward Luis Jauregui presented the case he filed involving CHRB rule # 1472(g) (Rail Construction and Track Specifications). Mr. Haines acknowledged even the smallest problem is important and stated Mr. Jauregui should contact Mr. Spetnagel directly when an issue arises. He also asked for a track inspection at least thirty days prior to the start of a meet, to secure large safety matters. Mr. Jauregui replied he would do so.

FILM REVIEW

Jockey Silvio Amador met with the Stewards to review the 4th race on Sunday (6 1/2 furlongs Pro-ride). Jockey Amador was on the outside of a four horse spread approaching the turn. He made a premature drift inward which applied pressure to horses to his inside. The Stewards felt this was not a punishable incident but told Mr. Amador it could be if

continued in the future. He was reminded only the outside horse can alleviate the squeeze. He agreed and accepted the advice.

FANNING HEARING CASE #10SA037

Trainer Jerry Fanning agreed to an informal setting to discuss his horse being tardy to the receiving barn for the sixth race on January 14th, 2010. He stated his groom failed to hear the call thus causing the eight minute late arrival to the holding area. Mr. Fanning has not been involved in a CHRB Rule 1852 (Reporting to Receiving Barn) violation since 2008. He was given an official warning.

JOCKEY/TRAINER/OBJECTION-2nd race (1 1/16 Pro-Ride)

Following the running of the race, Jockey David Flores aboard #1 Candy Arches (4th) along with assistant trainer L. Mora lodged a claim of foul against #2 One Shot (ARG) (1st.C.S.Reyes) for a possible infraction entering the first turn. After a review of all angles of the video, conversation with the Patrol Judges and both jockeys involved it was a unanimous decision to let the original order of finish stand. It was the Stewards' assessment that #1 had sufficient room entering the turn, stepped out generating the first contact which caused the necessity to take back.

INQUIRY / DISQUALIFICATION 5th race – 6 1/2 (hillside turf)

After the finish of the race the Stewards posted the inquiry sign to review a possible infraction near the eighth pole. Involved were #1 Tamerin (4th J. Rosario), #5 Triple Star (NZ) (8th M. Baze), and #8 Girl of Pangaea (GER) (7th M. Smith). Upon review of the video it was in the Stewards' opinion after conferring with the Patrol Judges and the jockeys involved that #1 be disqualified after drifting out in front of #5 and then drifting in, bumping #8, costing both horses the opportunity of a better placing.

ROSARIO RULING (Reference 02-19-10(6))

LATS #040

Jockey JOEL ROSARIO, who rode Tamerin in the fifth race at Santa Anita Park on February 18,2010, is suspended for three(3) racing days (February 26,27,and 28, 2010), for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount from fourth to eighth position. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-careless riding)
Term of suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Rosario and his agent Vic Stauffer met with the Stewards to evaluate his effort to correct his mount on Thursday.

PLETCHER SUSPENSION

The Board of Stewards was informed by CHRB Senior Special Investigator Sharyn Jolly that case number SAC 09-0040, which was a complaint filed against trainer Todd Pletcher regarding a post race procaine positive discovered in the test sample of Breeders' Cup participant Wait a While, had been finalized. Pursuant to the terms of the decision adopted by the CHRB, Mr. Pletcher will serve a ten day suspension beginning on Monday, February 22, 2010, and run consecutively. The decision also exacted a \$25,000 dollar fine which will presumably be paid to the CHRB before the suspension ends.
