WEEK 16-Sunday, April 8, 2012-Saturday, April 14, 2012**SUNDAY**04/08/12¹**FILM REVIEW**

Jockey Daniel Vergara met with the Stewards to review the 2nd race yesterday. Mr. Vergara was warned to have better control of his mounts as they tire. He promised a better effort in the future.

Kevin Krigger was in to review the 1st race and after a look of the 5/16ths camera angle, he refreshingly admitted he crossed in front of a horse to his inside with minimal clearance. This did not warrant a penalty and Mr. Krigger stated he would be more cautious moving forward.

Jockeys Martin Pedroza and Joel Rosario were directed to meet with the Stewards after the running of the eighth race yesterday. Coming off of the heels of the Santa Anita Handicap (2012) and a Pedroza penalty, the Stewards felt that both parties needed to be reminded that personal grievances will not be allowed on track and if necessary sanctions would be issued. The race yesterday was 1 1/8 (turf), wherein Mr. Pedroza stated he was told by trainer Carl O'Callaghan to make an easy lead if he could. Instead, he drove his horse to the lead after being passed by Mr. Rosario entering the first turn. His ride could have been described as a possible retaliation from the Big Cap when Mr. Rosario and Mr. Pedroza rode under fast early fractions resulting in both horses fading. The Stewards felt the videos from this race did not require any penalties (Steward Chaney voting for suspension days). Mr. Pedroza denied his sudden move was intentional but agreed to not let races from the past effect the future.

Mr. Rosario met with the Stewards to discuss his awareness of the issue and he was also advised not to let personal feelings affect rides on track. He promised not to be involved.

TWO JOCKEY OBJECTION FIRST RACE (5 ½ furlongs-dirt)/NO CHANGE

Following the running of the race jockey Daniel Vergara on # 4 Super Candy(4th) lodged a claim of foul against # 5 Forest Souvenir (R. Bejarano 1st) leaving the starting gate. Simultaneously apprentice jockey Eswan Flores aboard # 1 Sunny Superstition (3rd) claimed foul against # 2 Wise Guise (D. Flores 2nd) in the stretch. After a review of the videos and talking with the Patrol Judges and all jockeys involved it was a unanimous decision to make the original order of finish official. In the first incident the # 4 horse did get pinched at the start but in the Stewards' opinion it did not affect the order of finish. As for the second claim of foul in the stretch, the videos failed to substantiate Mr. Flores' claim that he was bothered.

JOCKEY OBJECTION SECOND RACE (6 furlongs-dirt)/NO CHANGE

Following the running of the race jockey Chantal Sutherland aboard # 4 Cut Fastball (4th) lodged a claim of foul against # 3 Floating Feather (A. Delgadillo 1st) approaching the quarter pole. After reviewing the videos and conversation with the Patrol Judges and both jockeys involved the Stewards were in agreement that even though # 4 was in tight quarters it was not compromised an opportunity of a better placing and the race was made official.

Trainer **JOHN SADLER** is fined **ONE HUNDRED DOLLARS (\$100.00)** for violation of California Horse Racing Board rules #1852 (Reporting to Receiving Barn) and #1894 (Duties of Trainer) with the horse "Picture Perfect" in the second race at Santa Anita Park on April 1, 2012.

The above ruling was issued after Mr. Sadler was notified of the amount of the fine.

04/14/12³**MOORE HEARING CASE #12SA115**

Trainer Robert Troeger filed a financial complaint against owner Dustin Moore in the amount of \$1,700.00 for training services. Mr. Troeger was present and Mr. Moore was available by telephone to give his testimony. Mr. Moore stated he was frustrated and surprised when his horse acquired career ending injuries. After Mr. Moore aired his grievances he agreed to pay Mr. Troeger the amount owed.

04/14/12⁴**INQUIRY/ACCIDENT NINTH RACE (5 furlongs-dirt)/DISQUALIFICATION**

Following the running of the race the inquiry sign was posted to review a spill involving #1 J Louie (A. Delgadillo 8th); #3 Loves My Girl (E. Flores DNF); #5 Courageousandbold (M. Pedroza DNF); #9 Dancing Jennifer (K. Stra 4th); #10 Whisky Talks (J. Medina 7th). After a review of the videos and conversation with the Patrol Judges in a unanimous decision #10 was disqualified from seventh position to unplaced. In the Stewards opinion #10 approaching the half mile pole drifted in without sufficient clearance, forced #9 inward causing #5 to clip the heels of #9. This chain reaction caused #3 to fall over #5. The # 1 horse had to alter course dramatically to avoid the accident. Accident reports attached.
