- Dates: Friday, September 28, 2012, through Sunday, November 4, 2012.
24 racing days. Racing Thursdays through Sundays, except special Monday racing on October 8, 2012 (Columbus Day).
- Races: Eight races weekdays, nine races Opening Day and nine races on weekends, unless otherwise designated.
- Post time: Opening Day, Friday, September 28, 2012-1:00 PM.; Weekdays- Thursdays through Fridays-1:00 PM.; Weekends-Saturdays, Sundays and Holiday Mondays-1:00 p.m., except Breeder's Cup Friday November 2, 11:15 AM & Saturday, November 3, 10:05 AM; Closing Day, November 4, 12:00 AM.
- Scratch time: Regular scratch time will be at 10:00 am the previous racing day, unless otherwise noted. The deadline for scratches for stakes races, with the exception of overnight stakes races will be prior to the 3rd race or 2 hours before post time, whichever is longer.
- Wagering: Minimum \$2 win, place and show wagering on every race; \$2 Rolling Doubles; \$1 Rolling Pick Threes; \$1 Exactas on all races; \$1 Trifectas; \$1 and 10 cent Superfectas on all qualifying races; \$1 Pick Four on final four races; \$1 Pick Five on final five races; \$2 Pick Six (with carryover) on final six races, and \$1 Place Pick All (no carryover) beginning with first race.

OPENING DAY JOCKEY MEETING

The Stewards met with the jockeys to review the policies pertaining to the routine practices expected of the colony. Some of the issues discussed were reporting weights, the sign sheet, asking for permission to be late, meeting with the Stewards when directed to review films and other issues of concern. Also in attendance were the Paramedics, Official Veterinarian Tim Grande and Racing Veterinarian Dana Stead, Jockey Guild Representative Darrell Haire, Fast Official personal Larry Gilligan, Safety Steward Luis Jauregui and President and General Manger George Haines. The concerns of the Paramedics were discussed at length, with hopes of understanding the procedures the Paramedics need to apply when an incident occurs on track.

FILM REVIEW

Apprentice jockey Juan Sanchez met with the Stewards to review the fifth race at Pomona. His drift in the lane was not penalty worthy but was discussed. Mr. Sanchez is fairly new to the southern California colony (arriving from northern California), he has thirty two wins which allows him the seven pound weight allowance. This will be reduced to five pounds after his fortieth win. Mr. Sanchez was informed of the Stewards expectations and policies.

Jockey Martin Pedroza who rode # 8 Via Villaggio (4th) lodged a claim of foul against # 4 Joyful Victory (2nd R. Napravnik) for possible interference near the 5/16 pole. After talking with both riders involved, the Patrol Judges and a review of the replays it was a unanimous decision to make the original order of finish official. Mr. Pedroza stated he was bumped and impeded; the videos did not substantiate his claim.
