03/01/13²**CHARLTON HEARING AND RULING**

We held a formal hearing into case number 13SA0059 which was a complaint filed by the CHRB against jockey CHERYL CHARLTON alleging a marijuana positive pursuant to the random drug testing conducted by the CHRB under the auspices of CHRB rule 1500.1. Before the hearing, the CHRB and Ms. Charlton agreed upon the terms of and signed a stipulated agreement. We opened the record, identified and entered the complaint and agreement into the record and brought the hearing to a close. We subsequently published the following ruling, which summarizes the terms of the agreement:
