25 racing days. Racing Thursdays through Sundays, except racing on Monday, Columbus Day, October 13, and Wednesday, October 29.
- Races:** Eight races weekdays, nine races Opening Day and nine races on weekends, unless otherwise designated.
- Post time:** Daily – 1:00 p.m. except Saturday, September 27, 12:30 p.m., Breeders' Cup, Friday, October 31, 11:25 a.m., Breeders' Cup, Saturday, November 1, 10:15 a.m., and closing day, Sunday, November 2, noon.
- Scratch time:** Regular scratch time will be at 10:00 a.m. the previous racing day, unless otherwise noted. The deadline for scratches for stakes races, with the exception of overnight stakes races will be prior to the 3<sup>rd</sup> race or one hour before post time, whichever is longer.
- Wagering:** Minimum \$2 win, place and show wagering on every race; Daily Double on races 1-2, 4-5 and the final two races on each card. \$1 Rolling Pick Threes; \$1 Exactas on all races; \$1 Trifectas; \$1 and 10 cent Superfectas on all qualifying races; \$1 Pick Four on final four races; \$1 Pick Five on first five races; \$2 Pick Six (with carryover) on final six races, and \$1 Place Pick All (no carryover) beginning with first race.

**STEWARDS' INQUIRY and DISQUALIFICATION**

The Inquiry sign was posted after the seventh race as the Stewards reviewed an incident near mid-stretch which involved #5 KESSABTSI (S. Arias) and #4 CONTRIBUTOR (J. Talamo), the second and sixth place finishers, respectively. After speaking with the riders involved, taking into account reports from the Patrol Judges and reviewing video of the stretch run, the Stewards voted unanimously to disqualify KESSABTSI from second to sixth position. Review showed that KESSABTSI drifted in near mid-stretch, taking the path of CONTRIBUTOR and forcing Talamo to check sharply. The interference also caused Talamo's mount to lose its action and break stride. The horse continued to close after the incident and was beaten three quarters of a length for fifth place. The incident, in the Stewards' opinion, cost Talamo and his mount a better placing.

**VIDEO REVIEW**

Jockey TYLER BAZE was in the office to review and discuss the ninth race from Friday, during which he attempted to squeeze his mount into a narrow space during the stretch drive. Baze was candid, stating that he thought he had ample room, but after viewing the video he realized that the space was not as large as he thought at the time.

**MALDONADO RULING - #216**

Having lost his appeal of LATS Ruling #172 dated May 1, 2014, jockey EDWIN MALDONADO is suspended for THREE (3) days (October 2, 3 and 4, 2014).

This ruling was issued after the Stewards received written confirmation to the effect that Mr. Maldonado had lost his appeal of a set of days issued in May of this year.

**ANTONGEORGI RULING - #217**

Having withdrawn his appeal of DMTD Ruling #026 dated August 15, 2014, jockey WILLIAM ANTONGEORGI is suspended

THREE (3) days (October 2, 3 and 4, 2014).

The foregoing ruling was issued after Mr. Antongeorgi's attorney, BING BUSH, withdrew the rider's appeal.

**RULINGS - #218 & #219**

#218

Exercise rider MANUEL LANDEROS is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board Rule #1437 (Conditions of a Race Meeting – working horse while warning lights were on).

#219

Jockey MIKE SMITH is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board Rule #1437 (Conditions of a Race Meeting – working horse while warning lights were on).

These rulings were issued as neither individual had an excuse for violating track rules.

**ARIAS RULING - #220**

Jockey SAUL ARIAS, who rode KESSABTSI in the seventh race at Santa Anita Park on September 26, 2014, is suspended for THREE RACING DAYS (October 3, 4, and 5, 2014) for failure to make the proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of his mount from second to sixth position. This constitutes a violation of California Horse Racing Board Rule #1699(Riding Rules). Pursuant to California Horse Racing Board Rule #1766(Designated Races), the term of suspension shall not prohibit participation in designated races.

Mr. Arias gave no plausible explanation for his failure to keep his mount straight. Refer: 9/26/14<sup>2</sup> DISQUALIFICATION

**ACCIDENT/INQUIRY/NO CHANGE**

The Inquiry sign was posted after the first race to review an incident at the start involving #5 ORIGINAL REX, ridden by apprentice jockey DRAYDEN VAN DYKE. After speaking with the Patrol Judges and reviewing video of the incident, the Stewards voted to make no change to the original placings. Video showed the horse stumbling sharply in the opening stride, causing Van Dyke to lose his balance and fall. He landed on his feet, but was struck by the horse to his outside. The contact spun Van Dyke to the ground. He was examined by the track physician and cleared to ride. Accident report attached.

**MINUS POOL**

A minus pool was created in the fifth race when #4 BEHOLDER, the prohibitive favorite at odds of 2/5, proved an easy winner. A total of \$87,302.47 was needed to balance.

9/27/14<sup>9</sup>

**ACCIDENT/INQUIRY/NO CHANGE**

The Stewards posted the Inquiry sign after the seventh race to review the circumstances which resulted in jockey MIKE SMITH being unseated as the field entered the stretch. After speaking with the Patrol Judges and reviewing video of the incident the Stewards voted unanimously to make no change in the placings. The horse likely caught the heels of a competitor, although the video was not definitive as to the cause of the accident. Mr. Smith was examined by the track physician immediately after the incident and was cleared to ride. Accident Report attached.

9/27/14<sup>10</sup>**MINUS POOL**

The second minus pool of the afternoon took place in the eighth race, as #4 SHARED BELIEF, the prohibitive favorite at odds of 1/5, proved victorious following a heated stretch battle. The minus pool amounted to \$64,348.85.
