FILM REVIEW

Four jockeys were directed to meet with the BOS to review videos of yesterday's races. Jockey Guild representative Darrell Haire represented all four. In the second race Rafael Bejarano on the #1 Hye I'm Jack, coming off the turn pushed his way out in the six furlong event. After a review with Mr. Bejarano it is was determined that his outward shift was not careless riding, but he was cautioned this style could trigger a penalty in the future. In the sixth race Drayden Van Dyke aboard #7 Molten Image was slow in dismounting after his horse became unsound returning to be unsaddled. He was warned he needs to dismount immediately when aware of the problem. Mr. Van Dyke was very humbled concerning his actions in this matter and now understands what is expected of him. In the seventh race Fernando Perez aboard #7 Cardiac was involved in an incident in the stretch. His mount ducked out and bumped a horse to its outside. After a review with Mr. Perez it was evident that he reacted quickly to correct his horse and left with a warning.

In the eighth race Joseph Talamo on the #7 Conquest Curlgirl broke inward leaving the gate bumping a horse to his inside. It appeared Mr. Talamo did try to correct but he had a long rein and was unable to guide his mount. Mr. Talamo was told that the jockeys wanted cleaner starts and for this to happen all had to participate. Mr. Talamo stated he would adjust his hold on the reins leaving the gates and be more in control.

6/21/15⁴**WORKOUT**

Trainer Keith Desormeaux received permission to work his trainee "Texas Red" on the main track between the fourth and fifth races. He worked in company going one mile and was clocked in 1:38.4.

6/21/15⁵**VOIDED CLAIMS**

After an inspection by Official Veterinarian Tim Grande, #1 Califo Cat who raced in the second race was placed on the Veterinarian's List and the claim was voided. The horse was returned to the stable of Armando Lage. In the sixth race Dr. Grande, after an inspection of #4 When We Met (Tr. Kristen Mulhall) and #6 My Jealous (Tr. Victor Fernandez) placed both horses on the Veterinarian's List thus voiding the claims and the horses were sent back to their original trainers.

6/25/15²**DEL MAR EMS SUPPORT PROCEDURES MEETING**

Director of Risk Management at Del Mar, Kim Jacobson and her assistant, Jeremiah Mendoza brought in eight Paramedics who will be working the summer meet at Del Mar to discuss the procedures for performing their duties on the race track. Out of the ordinary scenarios were discussed, questions were asked and answered and a few races were watched pertaining to accidents.

6-25-15³**MUNOZ RULING CASE 15SA175**

A financial complaint (CHRB rule 1876) was filed for trainer Robert Lucas against owner Javier Munoz in the amount of \$5,396.00 for services rendered. The following ruling was issued after Mr. Munoz failed to appear for the scheduled hearing.

RULING LATS #141

Owner JAVIER MUNOZ, having failed to respond to charges alleging violation of California Horse Racing Board rule #1876 (Financial Responsibility - \$5,396.00 to trainer Robert Lucas), is suspended for violation of California Horse Racing Board rule #1547(Failure to Appear). During the term of suspension, all licenses and license privileges of JAVIER MUNOZ are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), JAVIER MUNOZ is denied access to all premises in this jurisdiction.

6/25/15⁴**MILLER HEARING CASE 15SA179**

A financial complaint (CHRB rule 1876) was filed for San Luis Rey Equine Hospital against owner Myron Miller in the amount of \$11, 216.61 for services rendered. This complaint was dismissed when neither party appeared for the hearing.

6/25/15⁵**INQUIRY ACCIDENT FIFTH RACE NO CHANGE**

Following the running of the race the inquiry sign was posted to review an accident near the 3/16 marker. Involved was #4 She Sings Along (Fernando Perez) who went wrong and unseated the jockey. After a review of the race it was verified that no other horse was involved and the race was made official. Notification and Accident reports attached.

6/25/15⁶**SIXTH RACE REVIEW**

During the stretch run of the sixth race, we noticed the odd stretch run of #7 Sweet as a Rose (D. VanDyke) who eventually finished second. A review of the video both before and after we made the race official made it clear that Mr. VanDyke was unable to maintain a straight course or give his best effort because his horse was getting in so badly and was therefore unmanageable. We believed that it was so obvious that Mr. VanDyke made a superlative effort to keep his mount straight and therefore didn't feel the need to speak with him further.

6-26-15¹**BROCKLEBANK HEARING CASE 15SA0201**

A financial complaint (CHRB rule 1876) was filed for Veterinarian Karen Valko against trainer John Brocklebank in the amount of \$5,357.95 for services rendered. Present at the hearing were John Brocklebank, Karen Valko and her co-practitioner, Dr. Michael Steppe. After a lengthy discussion between the parties involved a financial agreement was reached and signed.

6/26/15²**GUTIERREZ FORMAL HEARING CASE 15SA0166**

The CHRB filed a complaint against trainer Jorge Gutierrez. The rules involved CHRB rule 1844 (c) (1) (Authorized Medication), 1887 (Trainer to Insure Condition of Horse) and 1843 (a)(d) (Medication, Drugs and Other Substances). Present were Jorge Gutierrez, and representing the CHRB, Investigator Philip Miyazaki. The proceedings were recorded by court reporter Michelle Dereig. Mr. Gutierrez's runner, "Warrens Tricia R" who ran third in the second race at Santa Anita on April 16, 2015, had a level of 2.64 ug/ml of the medication Penylbutazone in its system, exceeding the authorized medication level of 2.0 ug/ml. Mr. Gutierrez stated he felt the overage occurred when the horse in question received two consecutive treatments of the medication on April 14th and 15th. This is his normal procedure giving this medication to his runners. He has not had a medication violation since 2012, this makes him eligible for and he received a warning.

6/26/15³**FILM REVIEW**

Jockey Corey Nakatani met with the BOS to review the last race yesterday. In the stretch run of the 6 1/2 furlong turf race, Mr. Nakatani's mount drifted out and forced another horse to steady. The horse bothered stepped in at the same time, Mr. Nakatani did correct quickly and left the office with a warning.

6/26/15⁴**NBC MEETING**

Director of Broadcasting Amy Zimmerman brought an NBC television crew to discuss the logistics of the coverage of Saturday's "Gold Cup" at Santa Anita. NBC is broadcasting the eighth race, the "Royal Heroine" and ninth race, the "Gold Cup".

6/26/15⁵**INQUIRY SECOND RACE DISQUALIFICATION (6 1/2 dirt)**

Following the running of the race the inquiry sign was posted to review an incident in mid stretch. Involved were #4 Matriculate (Tyler Baze 3rd) and #6 London Legacy (Rafael Bejarano 2nd). After a review of the videos, conversation with the patrol judge and both jockeys it was a unanimous decision to disqualify #6 and place him third behind #4. In the Steward's opinion #6 tried to maneuver out from behind another horse and bumped #6 to his outside; #6 was beaten a nose for a better placing.

6/26/15⁶**INQUIRY FIFTH RACE NO CHANGE (6 1/2 turf)**

Following the running of the race the inquiry sign was posted to review an incident that occurred in the stretch. Involved were #4 Tirpitz (M. Pedroza 2nd), #5 Elegant Street (G. Nicolas 3rd) and #8 Perfectly Magic (K. Desormeaux 1st). After a review of the videos, conversation with the Patrol Judge and the three jockeys involved it was a unanimous decision to make no change. The Stewards blamed the #5 horse for the incident that occurred to #4, #5 finished behind #4, a change in the order of the finish was not necessary. #8 was not culpable in the incident.

6/26/15⁷**INQUIRY SEVENTH RACE NO CHANGE (6 1/2 turf)**

Following the running of the race the inquiry sign was posted to review an incident near the one eight pole. Involved were #1 Anytime Anyplace (Drayden VanDyke 1st), #2 Rocket Heat (Joseph Talamo 10th) and #4 Diamond Majesty (Flavien Pratt 2nd). After a review of the videos, conversation with the patrol judge and the three jockeys involved it was a unanimous decision that although #1 did shift in causing #2 and #4 to check, these two horses were not cost an opportunity for a better placing.

6/27/15²**FILM REVIEW**

Jockey Flavien Prat met with the Stewards to review the stretch run in the first race yesterday. He was on a horse that was trailing the field in the stretch in the mile event. Mr. Pratt continually slapped his horse on the shoulder throughout the stretch. He was warned this was not acceptable, he stated he understood and it would not happen again. Jockey Gonzalo Nicolas as directed also met with the Stewards to review the stretch run in the fifth race that involved an inquiry (ref 06-26-15⁶). After a review of the video it was apparent that Mr. Nicolas' mount was lugging out and he was making an effort to maintain a straight course. He left with a warning.

Jockey Rafael Bejarano met with the Stewards to review the second race in which there was an inquiry and a disqualification (ref 06-26-15⁵). After a review of the video the majority felt the contact was initiated when Mr. Bejarano guided his horse out from behind another horse. Mr. Bejarano was given a three day suspension (Ward dissent), the following ruling was issued.

LATS RULING #142

Jockey RAFAEL BEJARANO, who rode LONDON LEGACY in the second race at Santa Anita Park on June 26, 2015, is suspended for THREE (3) racing days (July 3, 4, and 5, 2015), for altering course without sufficient clearance and causing interference, which resulted in the disqualification of his mount from second to third position. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

Pursuant to California Horse racing Board rule #1766 (Designated Races) the term of suspension shall not prohibit participation in designated races.

6/27/15³**FERNANDEZ HEARING CASES 15SA185 and CASES**

A financial complaint (CHRB rule 1876) was filed for Veterinarian Melinda Blue against owner David Fernandez in the amount of \$2,933.00 for services rendered.

Also a complaint was filed for trainer Jeff Mullins against David Fernandez in the amount of \$15,079.00 for training.

Jockey Tyler Baze met with the Stewards to review the fourth race yesterday. In the stretch run approaching the 1/16 marker he pulled his horse out from behind another horse, bumped the horse to his outside and drifted out further, while not clear, causing that horse to check. Mr. Baze accepted the following penalty.

LATS RULING #143

Jockey TYLER BAZE, who rode I'LL WRAP IT UP in the fourth race at Santa Anita Park on June 27, 2015, is suspended for THREE (3) racing days (July 4, 5, and 9, 2015), for altering course without sufficient clearance and causing interference. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding). Pursuant to California Horse racing Board rule #1766 (Designated Races) the term of suspension shall not prohibit participation in designated races.

Jockey Drayden VanDyke met with the Stewards to review the seventh race on Friday which involved an inquiry (ref-06-26-15⁷). Mr. VanDyke's mount drifted inward in the stretch run causing interference. Mr. Van Dyke stated he thought he was clear, but realizes he was not. The following ruling was issued.

LATS RULING #144

Jockey DRAYDEN VAN DYKE, who rode ANYTIME ANYPLACE in the seventh race at Santa Anita Park on June 26, 2015, is suspended for THREE (3) racing days (July 3, 4, and 5, 2015), for failure to make the proper effort to maintain a straight course in the stretch, causing interference. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

Pursuant to California Horse racing Board rule #1766 (Designated Races) the term of suspension shall not prohibit participation in designated races.

JOCKEY/DRIVER ACCIDENT REPORT

Business and Professions Code Section 19481.3(e) provides that the stewards shall investigate and prepare a report regarding all on-track accidents involving jockeys that occur during the performance of the jockeys' duties. The investigation shall commence no later than the next live racing day and shall be completed expeditiously. Board Rule 1536, Stewards' Minutes, includes drivers in this requirement. **Upon completion of the report, it shall immediately be sent by facsimile or electronic mail to the Jockeys' Guild or California Harness Horsemen's Association (CHHA); the jockey/driver or his representative; the racing association; the horse owner; and the trainer of the horse the jockey/driver was riding/driving at the time of the accident.**
