11/3/16<sup>1</sup>

#### FILM REVIEW

Jockey RAFAEL BEJARANO came to the office to review his ride in the first race Sunday. His horse's actions were the subject of a Stewards' Review which did not result in an Inquiry. Leaving the starting from the #1 post position, a rival angled down in front of Mr. Bejarano's mount and although the horse was clear, Mr. Bejarano chose to angle his horse out. In so doing, he interfered with two horses causing them both to steady sharply. Mr. Bejarano blamed the young, green horse for the interference but video clearly showed that he directed his mount to the outside. We therefore issued the following ruling:

#### **LATC #033**

Jockey RAFAEL BEJARANO, who rode KONA DREAMS in the first race at Santa Anita Park on October 30, 2016, is suspended for THREE (3) RACING DAYS (November 13, 17, and 18, 2016) for altering course without sufficient clearance after the start and causing interference. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding). Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races in California.

We have not scheduled hearings this week as it is typically filled with Breeders' Cup related issues. Today was no exception: we entertained paddock requests from horsemen, and had visits from Chief MCHARGUE, Big Events coordinator MIKE KILPAC, Kenyan Steward DAVID SUGDEN and others.

As referenced in the minutes Sunday, the following ruling was issued:

**LATC #034**

Jockey IGGY PUGLISI is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688 (b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the sixth race at Santa Anita Park on October 29, 2016.

**FRIDAY**11/4/16<sup>1</sup>**FILM REVIEW**

Jockey FLAVIEN PRAT came to the office to review his ride in the fourth race yesterday during which he may have violated the whip rule. A quick review of the video confirmed that he used his crop four times in succession without giving the horse a chance to respond. He agreed and accepted the following ruling:

**LATC #037**

Jockey FLAVIEN PRAT is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the fourth race at Santa Anita Park on November 3, 2016.

11/4/16<sup>2</sup>**TRACK VIOLATIONS**

The morning outriders along with Safety Steward JAUREGUI directed security to issue two citations to licensees who were using their cell phones while mounted on a horse. They resulted in the following rulings:

**LATC #035**

Exercise Rider MARTIN RUIZ is fined FIFTY DOLLARS (\$50.00)\* for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to follow instructions of outrider – cell phone on track).

**LATC #036**

Trainer THOMAS R. BELL is fined FIFTY DOLLARS (\$50.00) for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to follow instructions of outrider – cell phone on track).

11/4/16<sup>3</sup>**HESS RULING**

Trainer BOB HESS was fined when he inadvertently named a jockey who didn't want to ride his horse and called to request a change well after wagering had started:

**LATC #038**

Trainer ROBERT HESS, Jr., is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1894 (Duties of Trainer – late jockey change) in the sixth race at Santa Anita Park on October 28, 2016.

11/4/16<sup>4</sup>**BREEDERS' CUP**

Today is the first day of the Breeders' Cup program. We held our traditional meeting with the jockey colony to review expectations and policy.

11/4/16<sup>5</sup>**INQUIRY/NO CHANGE**

Following the running of the fourth race we posted the Inquiry sign to examine an incident in which #4 MACH ONE RULES (T. Pereira) and #6 CAUTIOUS GIANT (T. Baze) both steadied near the 5/16 pole. Video revealed that the two horses were both attempting to enter a space in which there was only sufficient room for one horse. Therefore we voted unanimously to make no change to the original order of finish.

**SATURDAY**11/5/16<sup>1</sup>**FILM REVIEW**

Jockey FLORENT GEROUX came to the office as directed this morning to review his ride in the first race yesterday. We felt that he shifted his mount out while not being entirely clear of rivals to his outside. He explained that he was trying to avoid a rival in front of him who was racing somewhat erratically. While we agreed with the assessment, we nevertheless felt that he could have ridden more carefully. He agreed. Warning.

Jockey GARY STEVENS came to the office to discuss his taking off of his last mount yesterday, 15 minutes before post time. He explained that he was exhausted and was having trouble getting back to the Jockeys' Room after winning the Breeders' Cup Distaff aboard BEHOLDER. We felt that while a physical excuse can be legitimate, that it was not the entire explanation, negatively impacted the wagering public, delayed the last race and therefore warranted a penalty:

**LATC #039**

Jockey GARY STEVENS is fined FIVE HUNDRED DOLLARS (\$500.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) for the tenth race on November 4, 2016, at Santa Anita Park.

Jockeys KENT DESORMEAUX and CHANTAL SUTHERLAND came to the office to review their rides in the fifth race yesterday. We felt that each played a role in squeezing a rival and causing him to steady in the stretch. Mr. Desormeaux was more to blame but both accepted their responsibility in the incident. Warnings.

We issued the following ruling after jockey agent NELSON ARROYO erred in naming jockeys during the draw:

**LATC #040**

Jockey Agent NELSON ARROYO is fined TWO HUNDRED DOLLARS (\$200.00) pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations – failure to conduct business in a proper manner).

Jockey BRICE BLANC came to the office as directed to review his ride in the eighth race Thursday; specifically, the start. We felt he could have made a better effort to correct his horse who broke out sharply. He agreed. Warning.

Jockey JULIEN LEPAROUX was represented this morning by Jockeys' Guild representative DARRELL HAIRE regarding his ride in the fourth race yesterday. Video revealed that he pushed his way out a bit as the field was turning for home. While the move wasn't that dramatic, he did cause two horses to steady, the outside of which overreacted a bit. Warning.

Jockey DRAYDEN VAN DYKE was represented this morning by Jockeys' Guild representative Darrell Haire regarding his ride in the sixth race on Thursday. Specifically, we wanted to examine his whip use in the stretch. We felt that he used his whip four times in succession without giving the horse a chance to respond. Therefore the following ruling was issued:

**LATC #044**

Jockey DRAYDEN VAN DYKE is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the sixth race at Santa Anita Park on November 3, 2016.

11/6/16<sup>2</sup>**JOCKEY RULING**

We issued a ruling when Mr. ALBARADO took off a mount after scratch time, but before wagering had begun:

**LATC #041**

Jockey ROBBY ALBARADO is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) for the eighth race on November 4, 2016, at Santa Anita Park.

11/6/16<sup>3</sup>**DOLLASE RULING**

We issued the following when trainer MICHELLE DOLLASE'S runner came to the receiving barn with toe grabs for a turf race, requiring the Horseshoe Inspector to grind them off:

**LATC #043**

Trainer MICHELLE DOLLASE is fined two hundred dollars (\$200.00)\* pursuant to California Horse Racing Board rule 1853 (Examination Required – improperly shod for the turf) for the fourth race at Santa Anita Race Track on November 3, 2016.

11/6/16<sup>4</sup>**LOWE RULING**

We issued the following ruling when owner WAYNE LOWE failed to appear for his financial hearing:

**LATC #042**

Owner WAYNE LOWE, having failed to respond to charges alleging violation of California Horse Racing Board rule #1874 (Financial Responsibility – trainer JORGE PERIBAN, \$5,904.00) is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of WAYNE LOWE are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), WAYNE LOWE is denied access to all premises in this jurisdiction.

11/6/16<sup>5</sup>**INQUIRY/DISQUALIFICATION**

Following the running of the first race, we posted the Inquiry sign to examine an incident in which fourth place finisher #3 FRIENDLY REQUEST (T. Baze) clipped heels shortly after the start. Video revealed that the winner #6 LOFTY CAUSE (R. Bejarano) crossed over in front of her rival, causing that horse to clip heels and nearly fall. After speaking with patrol judges and riders involved, we voted unanimously to disqualify the winner and place her fourth. We believed that #3 was cost the one length she was beaten for third.
