Mr. Ayarza claimed foul against #3 MOUNTAIN MISS (Otto Arriaga), the winner, alleging a whip violation.

The stewards dismissed the claim of foul unanimously as the review of the tapes failed to substantiate the objection.

07-18-07⁴ **INQUIRY – NO CHANGE – Second Race**

The stewards posted the inquiry sign following the second race in order to review an incident near the wire involving the mules finishing second and third.

The tapes show #3 BAR JF FLYING J (Robert Bryce), second, ducks out sharply near the finish into the path of #5 RTR LOST IN THE FOG (Otto Arriaga) who finished third.

The stewards decided unanimously to make no change as the incident did not affect the placings.

The stewards posted the inquiry sign following the first race for a review of the stretch run.

The tapes show #6 DREAM WANDER (Otto Arriaga, 5th) shifts off the heels of #5 SPLENDIDD (Angel Felix), the winner.

The incident had no bearing on the outcome and the stewards decided unanimously to make no change in the original order of finish.

07-19-07⁵ **INQUIRY – NO CHANGE – Seventh Race**

The stewards conducted a review of the running of the seventh race and decided unanimously to make no change in the original order of finish.

The tapes show #7 TUFFACT'N (Roberto Gonzalez) first, bore out near the wire into the path of #6 BEYOND REALITY (Luis Contreras) third, and made contact with #10 NO ONE LIKE YOU (Catalino Martinez) second, just pass the wire. Neither incident altered the outcome, therefore disqualification was unwarranted.

07-20-07³ **RULING NO. 1 – AYALA**

Jockey **ANTHONY M. AYALA** is fined the sum of three hundred dollars (\$300.00) for failure to make the required weight for the second race on Wednesday, July 18, 2007, necessitating the late declaration of **BAR JF SPEED-N-TICKET** -- a violation of California Horse Racing Board rule #1683 (Maximum Overweight) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration).

The foregoing ruling was issued as Mr. Ayala was over the seven pound maximum overweight, resulting in a declaration, as there were no other mule riders available. Mr. Ayala waived his right to a hearing and accepted the penalty.

07-20-07⁴ **RULING NO. 2 – GONZALEZ** (Refer -7-19-07⁵)

Jockey **ROBERTO GONZALEZ**, who rode **TUFFACT'N** in the seventh race at the Sonoma County Fair (Santa Rosa) on July 19, 2007, is suspended three (3) racing days (July 27, 28 and 29, 2007) for failure to make a proper effort to maintain a straight course in the stretch and causing interference – a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after Mr. Gonzalez and the stewards reviewed the tapes of the seventh race from July 19, 2007.

Mr. Gonzalez acknowledged he erred in allowing his mount to drift out near the finish causing interference.

07-20-07⁵ **RULING NO. 3 – CONTRERAS**

Jockey **LUIS CONTRERAS**, who rode **CONSIDERATE SWISS** in the fourth race at the Sonoma County Fair (Santa Rosa) on July 19, 2007, is suspended three racing days (July 27, 28 and 29, 2007) for altering course without sufficient clearance and causing interference – a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued following a film review with jockey Luis Contreras.

Mr. Contreras acknowledged he wasn't clear when he altered his course and accepts his penalty.

07-20-07⁶ **RULING NO. 4 – VALLEJO**

Jockey **AGUSTIN VALLEJO** is fined the sum of fifty dollars (\$50.00) for failing to report to the jockey's room at least one hour before post time of the first race on Thursday, July 19, 2007 – a violation of California Horse Racing Board rule #1680 (Jockeys and Drivers to Report).

The above ruling was issued after Mr. Vallejo apologized for reporting late and accepted the penalty.

07-20-07⁷ **RULING NO. 5 – GONZALEZ** (Case 07GG058)

Trainer **RAMON G. GONZALEZ**, who started the horse **VALIANT COMIC**, first place finisher in the sixth race at the San Joaquin County Fair (Stockton) on June 14, 2007, is fined the sum of five hundred dollars (\$500.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843 (a) & (d) (Medication, Drugs and Other Substances: Phenylbutazone, in excess of permitted level – 5.62 ug/ml).

The foregoing ruling was issued after Mr. Gonzalez appeared, waived his right to a formal hearing and accepted the penalty imposed.

07-20-07⁸ **GENERAL MANAGER JIM MOORE**

Sonoma County Fair Manager **Jim Moore** met with the stewards for a general discussion regarding the three week meet to be conducted here at Santa Rosa.

Mr. Moore anticipates a successful fair and echoed earlier reports about the excellent condition of the main track and the turf course.

07-20-07⁹ **ACCIDENT – First Race**

Following the running of the first race the mule BAR JF MR. BELLE unseated rider Otto Arriaga. Mr. Arriaga was not seriously injured but was excused from his one remaining mount.

07-20-07¹⁰ **BREAKDOWN – Seventh Race**

#7 TALKING GUNS went wrong near the ¼ pole and was pulled up by jockey Catalino Martinez.

State Veterinarian Don Dooley reported the four-year-old gelding was euthanized.

The above ruling was issued after Mr. Martinez informed the stewards that his horse, EUBACCAL, who was inadvertently entered in the wrong race by a jockey agent, would not be participating.

Mr. Martinez was advised that his horse was obligated to run as scratch time for today's card was Thursday, July 19, 2007.

Mr. Martinez indicated his horse was not ready for the mile race and accepted the three hundred dollar fine imposed for the late declaration.

07-22-07³ **RULING NO. 7 – URIBE** (Case 07GG071)

Exercise Rider and Assistant Starter **JESUS E. URIBE**, having failed to respond to written notice to appear before the Board of Stewards at Sonoma County Fair in Santa Rosa on or before July 22, 2007, is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

During the term of this suspension, all license privileges of **Jesus E. Uribe** are suspended and pursuant to California Horse Racing Board rule #1958 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

The foregoing ruling was issued as Mr. Uribe failed to appear for a scheduled hearing regarding an alleged violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

According to the complaint, on July 13, 2007 Mr. Uribe tested positive for cocaine and morphine on a Roche Laboratories field test. That test was allegedly confirmed by Quest Laboratories in a report dated July 17, 2007.

07-22-07⁴ **RULING NO. 8 – COFFEE**

Trainer **CANDICE COFFEE** is fined the sum of three hundred dollars (\$300.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration) for failure to have the mule **MANDYS TURN** treated with lasix in a timely fashion, necessitating a late declaration in the third race on Saturday, July 21, 2007 – a violation of California Horse Racing Board rule #1845 (Authorized Bleeder Medication).

The above ruling was issued after Ms. Coffee waived a hearing and accepted the penalty for failing to insure that her mule, **MANDYS TURN**, was treated with lasix.

07-22-07⁵ **OBJECTION – NO CHANGE – Fourth Race**

The stewards posted the objection sign following the fourth race at the request of jockey Modesto Linares, who finished third on #8 **ATSASHANARAY**.

Mr. Linares lodged claim of foul against #6 **ZORRA ROJA** (Alfredo Miranda), the winner, alleging interference near the 3/8 pole.

After interviewing the riders involved and reviewing the tapes, the stewards decided unanimously to disallow the claim of foul, as the tapes of the race failed to substantiate the allegation.
