07-29-09¹ **ENTRY DAY**

Entries were taken this morning for Saturday, August 1. One (1) mule, one (1) Arabian and nine (9) thoroughbred races for a total of eleven (11) will be contested. One hundred horses/mules are slated to face starter Todd Stephens.

07-29-09² **REED SALDANA FILM REVIEW**

Apprentice jockey **Reed Saldana** appeared in the stewards' office to review his ride in the eighth race on Sunday, July 26, 2009 at the Solano County Fair (Vallejo). Apprentice Saldana was aboard #1 DIAMONDSFOREVER, who finished ninth in this five and one half furlong event.

Apprentice Saldana lodged an objection in this race (Ref: 07-26-09⁴) for alleged interference against the first place finisher #5 GENERAL BUFFET (Russell Baze). Saldana steadied at the 3/8 pole and was in a half in half out position while entering the turn. The stewards advised apprentice Saldana to use better judgment and anticipate the turns earlier in future races.

07-29-09³ **INQUIRY / DISQUALIFICATION – Seventh Race**

The stewards posted the inquiry sign to view an incident at the 1/8 pole in this one (1) mile turf event. In this race fourth place finisher #2 HOLD FAST (Chad Schvaneveldt) bumps and steadies from between horses. Third place finisher #6 SONNY'S TORNADO (Michael Martinez) was roughly a length in front and racing to his inside. Second place finisher #7 HOT CHACO (Frank Alvarado) was along his outside. Contact between all three (3) of these rivals took place near the 1/8 pole. The majority of the stewards felt #6 SONNY'S TORNADO was responsible for this incident by stepping outward thereby causing the foul. The stewards voted (Baker dissenting) that #6 SONNY'S TORNADO be disqualified and placed fourth.

Jockey **Michael Martinez** was ordered to film review.

07-29-09⁴ **LATE SCRATCHES – Ninth Race**

Prior to the start of this race post time favorite #3 BIG WAVE RIDER (William Antongeorgi) reared and was temporarily hung up in the gate prior to dispatch. #4 REALLY INDIAN (Chris Russell) was also affected by this incident.

Track Veterinarian Robert Connolly recommended the late scratches of both #3 BIG WAVE RIDER (odds 1/2) and #4 REALLY INDIAN (odds 6/5). A three (3) minute delay took place before the race went off.

07-30-09¹ **ENTRY DAY**

Entries were taken today for racing on Sunday, August 2. A total of eleven (11) races were filled. One (1) Quarter Horse, one (1) mule, one (1) Arabian and eight (8) thoroughbred races were filled. Eighty seven (87) horses/mules are scheduled to go postward.

07-30-09² **APRIL BOAG FILM REVIEW**

Jockey **April Boag** appeared in the stewards' office to review her ride aboard #3 TOBEE who finished second in yesterday's first (mule) race. Jockey Boag misjudged the finish line in this race and acknowledged doing so to the stewards.

The stewards felt this incident did not cost jockey Boag's mount a better placing. After she stood up in the saddle and then went back to riding at the finish. No penalty was issued in this matter as the stewards feel this is not likely to happen again.

07-30-09³ **ALFREDO MIRANDA FILM REVIEW**

Jockey **Alfredo Miranda** appeared in the stewards' office to review his ride in the Solano Derby (Quarter Horse – 400 yards) on Sunday, June 28 at Vallejo. Jockey Miranda was aboard #4 JESSA GOODTIME GAL (sixth place) who drifted out in mid-

stretch. There was no inquiry in this race and Jockey Miranda understood the stewards' reason for concern. The stewards all agreed that no suspension be levied for this ride.

07-30-09⁴ **MICHAEL MARTINEZ FILM REVIEW – RULING NO. 1**

Jockey **MICHAEL MARTINEZ**, who rode **SONNY'S TORNADO** in the seventh race at the Sonoma County Fair on Wednesday, July 29, 2009, is suspended three (3) racing days (August 6, 7 and 8, 2009) for failure to make the proper effort to maintain a straight course at the top of the stretch and causing interference resulting in the disqualification of his mount from third to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

Jockey Michael Martinez appeared in the stewards' office today with interpreter Augustine Regalado. Jockey Martinez viewed yesterday's (July 29) fifth race and his ride on fifth place finisher #3 LADY AMANDA. In another matter, Martinez was summoned to the stewards' office to view his ride aboard #6 SONNY'S TORNADO who finished third but was disqualified (Ref: 07-29-09³) and placed fourth in yesterday's seventh race. In that race jockey Martinez shifted out at the 1/8 pole.

During the first three fairs (Stockton, Pleasanton and Vallejo) Martinez was ordered to film review (with patrol judge or stewards) three (3) times.

07-30-09⁵ **INQUIRY – DISQUALIFICATION – First Race**

This race was for Quarter horses going three hundred and fifty (350) yards. The stewards posted the inquiry sign after viewing an incident involving four (4) horses in the final eighty (80) yards. At this juncture second place finisher **#1 DASH DECISION (Anthony Ayala)** drifts out significantly causing three (3) horses to steady while being forced off their straight course. Third place finisher #3 CARPINTERIA (Carlos Villalobos), fourth place finisher #5 BF GAMELADY (Gregorio Arriaga) and fifth place finisher #4 NO JOSHIN were all affected by this incident. The stewards unanimously voted to disqualify #1 DASH DECISION and place him fifth.

Jockey Anthony Ayala was ordered to the stewards' office tomorrow for film review.

07-31-09¹ **ENTRY DAY**

The racing office was open today with entries being taken for Wednesday, August 5. One (1) mule, one (1) Arabian and eighth (8) thoroughbred races make up the ten (10) race card. Eighty nine (89) horses/mules are scheduled to go postward.

07-31-09² **RULING NO. 2 – OLIVIO MALDONADO**

Jockey **OLIVIO MALDONADO**, who was scheduled to ride MI TEQUILLA in the first race at the Sonoma County Fair on Thursday, July 30, 2009, is hereby fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1683 (Maximum Overweight) causing a late rider change.

The foregoing ruling was issued after Assistant Clerk of Scales Danny Winick informed the stewards that jockey **Olivo Maldonado** weighed one hundred and twenty five (125) pounds today. His assigned weight for the first race yesterday (July 30) was one hundred fourteen (114) pounds.

07-31-09³ **ANTHONY AYALA FILM REVIEW – RULING NO. 3**

Jockey **Anthony Ayala** appeared in the stewards' office to review his ride in yesterday's (July 30) first race. Jockey Ayala was aboard #1 DASH DECISION who was disqualified and placed fifth for interference in deep stretch. (Ref: 07-30-09⁵) Jockey Ayala was candid with the stewards stating he felt he could have done a better job keeping his horse straight in this race. The stewards unanimously voted to issue the following ruling:

Jockey **ANTHONY AYALA**, who rode **DASH DECISION** in the first race at the Sonoma County Fair on Thursday, July 30, 2009, is suspended three (3) racing days (August 7, 8 and 9, 2009) for failure to make the proper effort to maintain a straight course near

the finish and causing interference resulting in the disqualification of his mount from second to fifth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-31-09⁴ **ADDITIONAL DESIGNATED RACE**

The stewards added an additional race to their list of 'designated races' that was put out on opening day. THE MULE CHAMPIONSHIP (Purse \$7,500) to be run on Sunday, August 9th now gives all breeds at least one 'designated race' here at Santa Rosa.

07-31-09⁵ **SMOOTH CARD**

Today's ten (10) race card went well as it was free of stewards' inquiries and/or jockey objections.

ENTRY DAY

Entries were taken today for racing on Thursday, August 6. One (1) mule, one (1) Arabian and eighth (8) thoroughbred events make up the ten (10) race card. Eighty five (85) horses/mules are scheduled to start.

08-01-09² **DAN MORGAN COMPLAINT** (Case No. 09GG257)
Groom **GARY VICKERY** appeared in the stewards' office today to present his side of a complaint he filed against trainer **Dan Morgan** for alleged past due wages of six thousand two hundred (\$6,200) dollars. Four thousand four hundred (\$4,400) of these alleged past due wages were incurred in the actual one (1) year prior to the July 9, 2009 filing date. This was the total amount the stewards would address per California Horse Racing Board rule 1876 (b) (Financial Responsibility).

Trainer Dan Morgan was present as was his witness/father **Hugh Morgan**. Supervising Investigator Anne Glasscock appeared for the CHRB in this informal hearing. Groom Vickery testified he worked 'off and on' for trainer Morgan in both Arizona and Pleasanton, California. Trainer Morgan stated that he 'settled' with Vickery on January 31, 2009, by paying him the sum of one thousand (\$1,000.00) dollars.

The stewards were unable to work out any sort of compromise in this matter. More to follow.

08-01-09³ **OWNERS FILM REVIEW**
Owners **Chris** and **Humberto Covarrubias** (d.b.a. Covarrubias Brothers LLC) appeared in the stewards' office to view race replays of the seventh race opening day, Wednesday, July 29. Their horse, **SONNY'S TORNADO**, finished third in this race, however, he was disqualified and placed fourth. These owners were not happy with the disqualification; however, the film review was very civil in nature.

08-01-09⁴ **MICHAEL MARTINEZ FILM REVIEW – RULING NO. 4**
Jockey **Michael Martinez** appeared in the stewards' office today to review his ride in the eighth race on Thursday, July 30. In this race jockey Martinez was aboard fourth place finisher #10 **FEELINGS**. Jockey Martinez shifted inward sharply under right handed whip at the 3/16 pole. This incident forced ninth place finisher #9 **YASMIN'S SONG** (Omar Figueroa) to steady sharply. This ruling comes on the heels of a ride Martinez was suspended for (Refer: Sonoma Co. Fair Ruling #1) on July 29.

The stewards determined the following ruling was warranted.

Jockey **MICHAEL MARTINEZ**, who rode **FEELINGS** in the eighth race at the Sonoma County Fair on Friday, July 31, 2009, is suspended five (5) racing days (August 9, 12, 13, 14 and 15, 2009) for altering course without sufficient clearance and causing interference; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

Today's eleven (11) race card went well as it was free of stewards' inquiries and/or jockey objections.

08-02-09¹ **ENTRY DAY**

Entries were taken today for racing on Friday, August 7. Ten (10) races filled for this day. One (1) Arabian, one (1) quarter Horse and eight (8) thoroughbred races were drawn. Eighty-five (85) horses are scheduled to go postward.

08-02-09² **DAN MORGAN COMPLAINT** (Case No. 09GG257)

Trainer **DAN MORGAN** and groom **GARY VICKERY** were both contacted by the stewards today via telephone. This case (Ref: 08-01-09²) was dismissed due to lack of evidence and both parties were informed via telephone.

08-02-09³ **REED SALDANA FILM REVIEW**

Apprentice jockey **Reed Saldana** appeared in the stewards' office to review his ride in yesterday's (August 1) fourth race. Saldana was aboard second place finisher #3 PLAZA QUEEN, who drifted out in this race from the 1/8 pole to the finish under right handed whipping.

This apprentice was told to use his riding reins when attempting to straighten out a horse drifting out. Warning issued.

08-02-09⁴ **RIGOBERTO FLORES - RULING NO. 5** (Case No. 09GG248)

Groom **Rigoberto Flores** did not have a current CHRB license when paddocking a horse for trainer **Willie Whitehouse** at Stockton on June 26, 2009. The stewards issued a ruling (Ref: Alameda County Fair Ruling #23) to Willie Whitehouse regarding this same matter. The stewards issued the ruling below in this matter:

Groom **RIGOBERTO E. FLORES** is fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1481 (a,c) (Occupational Licenses and Fees) for working without a current license at the San Joaquin County Fair in Stockton.

08-02-09⁵ **MINUS SHOW POOL**

Quarter horse #4 **SNATCH THE CASH** won the first race today at the odds of 1/9. The total show pool in this race was \$172,876. The amount bet to show on this Elmer January trained winner was \$166,302. Mutuel Manager **Bryan Wayte** reported to the stewards that there was a minus pool of \$36,525.17 in this race. Mr. Wayte reported that the majority of this money was bet 'out of state' and through advance deposit wagering (ADW) accounts.

08-02-09⁶ **INQUIRY / ACCIDENT / NO CHANGE – Seventh Race**

The stewards posted the inquiry sign to review an accident at the 1/16 pole. #2 PAPOOSE LA MOOSE was injured at the 1/16 pole on the turf course. This horse was closing well and racing in second position when the injury took place and jockey **Russell Baze** fell to the turf. This horse did not finish the race and the stewards made 'no change' in the order of finish after a film review was made.

An accident report of this race will be attached to these minutes.

08-02-09⁷ **INQUIRY / OBJECTION / INTERFERENCE / DISQUALIFICATION – Ninth Race**

The stewards posted the inquiry sign after viewing first place finisher #3 **ONE ROYAL STAR (Michael Martinez)** drift out from the 1/8 pole to the finish. The jockey on #6 LATE NITE DEVIL (**Frank Alvarado**) also lodged an objection in this race against #3 ONE ROYAL STAR and jockey Martinez.

#6 LATE NITE DEVIL was attempting to close on the outside but was taken off his straight course for approximately one hundred (100) yards. He was beaten about ¾ of a length for the 'win'. All film angles were reviewed by the stewards. Patrol Judge Cheryl White filed a patrol judge report. The stewards spoke with both riders involved. In a unanimous decision the stewards disqualified #3 ONE ROYAL STAR and placed him second. Jockey Michael Martinez was ordered to film review with the stewards.
