RULING # 51

ACTING UPON A REPORT FROM UNIVERSITY OF CALIFORNIA, DAVIS, AN OFFICIAL LABORATORY FOR THE CALIFORNIA HORSE RACING BOARD, THAT THE POST RACE SAMPLE #CE-09534, TAKEN FROM THE HORSE "SUES DESTROYER", THE FIRST PLACE FINISHER IN THE FOURTH RACE ON JULY 24, 2008, AT CAL-EXPO, TESTED POSITIVE FOR THE PROHIBITED DRUG "HYDROMORPHONE" (CLASS 1), IT IS ORDERED THAT "SUES DESTROYER" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE, IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST FINDING).

IT IS FURTHER ORDERED THAT THE OWNER OF "SUES DESTROYER" (JUDY WALTEBURGH) RETURN ALL PURSE MONIES (\$1,672.00) TO THE PAYMASTER OF PURSES AT CAL-EXPO FOR REDISTRIBUTION IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE HELD).

IT IS FURTHER ORDERED THAT DRIVER ROCKY D. STIDHAM (\$88.00) RETURN ALL PURSE MONIES TO THE PAYMASTER OF PURSES AT CAL-EXPO FOR REDISTRIBUTION IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE HELD).
