TRAINER **FRANK PETRELLI**, WHO STARTED THE HORSE “**CHARTLEYSMONALISA**” IN THE FIFTH RACE AT CAL EXPO HARNESS ON JULY 25, 2009, HAVING ENTERED INTO A STIPULATED AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD, IS FINED THREE THOUSAND (**\$3,000.00**)\* DOLLARS AND **SUSPENDED\*\*** FOR THIRTY (30) DAYS (DECEMBER 20, 2009 THROUGH JANUARY 18, 2010) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #**1887** (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #**1843.6 (D-1)** (TOTAL CARBON DIOXIDE – 39.0 MILLIMOLE PER LITER – EXCEEDS PERMITTED LEVEL - CLASS III) AND CALIFORNIA HORSE RACING BOARD RULE #**1890** (POSSESSION OF CONTRABAND).

PURSUANT TO THE TERMS OF THE STIPULATED AGREEMENT, FIFTEEN DAYS OF THE SUSPENSION ARE STAYED PENDING THE PASSAGE OF ONE YEAR FROM THE DATE OF THIS AGREEMENT, DURING WHICH TIME THE SUBJECT IS PLACED ON PROBATION AND SHALL NOT HAVE ANY VIOLATIONS FOR CLASS I, II, OR III SUBSTANCES. ACTUAL DAYS OF SUSPENSION SERVED WILL BE DECEMBER 20, 2009 THROUGH JANUARY 03, 2010.

\*California Horse Racing Board rule #1532 states that all fines shall be paid to the paymaster of purses within seven (7) days of imposition or the license of the person upon whom the fine was imposed shall be suspended.

\*\*During the term of suspension all licenses and license privileges of Frank Petrelli are suspended and pursuant to California Horse Racing Board Rule #1528 (Jurisdiction of Stewards) Frank Petrelli is hereby denied access to all premises in this jurisdiction.
