RULING # 34

ACTING UPON A REPORT FROM UNIVERSITY OF CALIFORNIA, DAVIS, AN OFFICIAL LABORATORY FOR THE CALIFORNIA HORSE RACING BOARD AND DISPOSITION OF CASE 09SW-0221, THAT THE POST RACE SAMPLE #TC-200195, TAKEN FROM THE HORSE “**SPLIT TICKET**”, THE FIRST PLACE FINISHER IN THE SECOND RACE ON DECEMBER 19, 2009, AT CAL-EXPO, WAS FOUND TO CONTAIN A LEVEL OF TOTAL CARBON DIOXIDE OF 37.9 MILLIMOLES PER LITER, WHICH IS IN EXCESS OF PERMITTED LEVELS PER CALIFORNIA HORSE RACING BOARD RULE #1843.6 (D-1), IT IS ORDERED THAT “SPLIT TICKET” BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE, IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST FINDING).

IT IS FURTHER ORDERED THAT THE OWNERS OF “SPLIT TICKET” (RICHARD MORITA, KAITON WONG, DAVID OHARA AND DAVID YAMADA) RETURN ALL PURSE MONIES (\$3,160.00) TO THE PAYMASTER OF PURSES AT CAL-EXPO FOR REDISTRIBUTION IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITHHELD).

IT IS FURTHER ORDERED THAT DRIVER STEVE WISEMAN (\$170.00) AND TRAINER LIBERIO PACHECO (\$170.00) RETURN ALL PURSE MONIES TO THE PAYMASTER OF PURSES AT CAL-EXPO FOR REDISTRIBUTION IN ACCORDANCE WITH CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITHHELD).
