

**LOS ALAMITOS QUARTER HORSE RACING ASSOCIATION**

**RULING # 207**

ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD AND HAVING BEEN CONFIRMED BY IOWA STATE UNIVERSITY, THAT BLOOD SAMPLE# LA07967, TAKEN FROM THE HORSE "FIGHTER ON FIRE", THE FIRST PLACE FINISHER IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON APRIL 11, 2008, TESTED POSITIVE FOR CLENBUTEROL (CLASS III) IN EXCESS OF PERMITTED LEVEL, IT IS ORDERED THAT "FIGHTER ON FIRE" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE (\$76,692.00) EARNED BY OWNER RANCHO EL ALACRAN, TRAINER ADAN FARIAS AND JOCKEY RODRIGO ACEVES BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)
