ACTING UPON A REPORT FROM THE UNIVERSITY OF CALIFORNIA DAVIS, AN OFFICIAL TESTING LABORATORY OF THE CALIFORNIA HORSE RACING BOARD THAT URINE SAMPLE# LA24326, TAKEN FROM THE HORSE "ZOOMDASHER", THE SECOND PLACE FINISHER IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 29, 2013, TESTED POSITIVE FOR CLENBUTEROL (CLASS III). IT IS ORDERED THAT "ZOOMDASHER" BE DISQUALIFIED FROM ALL PURSE MONIES EARNED IN SAID RACE IN ACCORDANCE WITH THE CALIFORNIA HORSE RACING BOARD RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST).

IT IS FURTHER ORDERED THAT ALL PURSE MONIES (\$25,500.00) EARNED BY OWNERS GUSTAVO AND JOSE DE LA TORRE, TRAINER JOSE DE LA TORRE AND JOCKEY CARLOS M. HUERTA BE RETURNED TO THE PAYMASTER OF PURSES AT LOS ALAMITOS RACE COURSE BY DECEMBER 9, 2013 FOR REDISTRIBUTION PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1760 (PURSE AWARD OR PRIZE TO BE WITH HELD)
