RULING # 6

TRAINER SILVERIO MARTINEZ, WHO STARTED THE HORSE "DRAGON DANCE" IN THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON JULY 10, 2015, IS FINED THREE THOUSAND DOLLARS (\$3,000)* AND SUSPENDED SIXTY (60) DAYS (JANUARY 8, 2016 THROUGH MARCH 7, 2016) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A & D) (MEDICATION, DRUGS AND OTHER SUBSTANCES-CLENBUTEROL-CLASS III) #1843.1 (PROHIBITED DRUG SUBSTANCES) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING).

THIRTY(30) DAYS OF SUSPENSION ARE STAYED. ADDITIONALLY, SILVERIO MARTINEZ IS PLACED ON PROBATION FOR A PERIOD OF ONE (1) YEAR (MARCH 6, 2017) AND SHALL NOT HAVE ANY VIOLATIONS FOR CLASS I, II OR III SUBSTANCES DURING THAT PERIOD. IF SILVERIO MARTINEZ VIOLATES THE CONDITION OF HIS PROBATION, THE THIRTY (30) DAY STAY OF SUSPENSION SHALL BE LIFTED AND THE REMAINING SUSPENSION DAYS SHALL BE IMPOSED AFTER NOTICE AND HEARING. ACTUAL DATES OF SUSPENSION SHALL BE JANUARY 8, 2016 THROUGH FEBRUARY 6, 2016.

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF SILVERIO MARTINEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), SILVERIO MARTINEZ IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

*California Horse Racing Board Rule #1532 states that all fines shall be paid to the paymaster of purses within seven (7) days of imposition (01/08/16) or the license of the person upon whom the fine was imposed shall be suspended.
