MINUTES

Chairman Licht asked for approval of the minutes of the Regular Board Meeting of March 27, 2003. Vice-Chairman Harris **motioned** to approve the minutes. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**. Chairman Licht asked for approval of the minutes of the Regular Board Meeting of April 24, 2003. Vice-Chairman Harris **motioned** to approve the minutes. Commissioner Granzella **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE DEL MAR THOROUGHBRED CLUB (T), AT DEL MAR, COMMENCING JULY 23 THROUGH SEPTEMBER 10, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Del Mar Thoroughbred Club (DMTC) proposed to run 43 days, the same number of days as in 2002, for a total of 372 races. Ms. Wagner stated the first post time would be 2:00 p.m. daily; 12:30 p.m. on August 24; 3:30 p.m. on August 22 and August 29; and 4:00 p.m. on July 25 and August 1, 8 and 15. DMTC would use

CHRB regulations for its wagering program. Ms. Wagner said the only outstanding item on the application was the fire clearance. She stated staff recommended approval of the application conditioned upon receipt of any missing items noted in the analysis. Vice-Chairman Harris asked if DMTC would accept mule races. Craig Fravel of DMTC said his organization worked with the stewards to modify the wagering formats to avoid the problem of minus pools, so the 2002 incident with the mule Black Ruby would not be repeated. Vice-Chairman Harris asked if the application showed which advance deposit wagering (ADW) entities had a contractual agreement with the track. Mr. Fravel said TVG and YouBet were listed on the application as ADW providers. Commissioner Sperry **motioned** to approve the application for license to conduct a horse racing meeting of DMTC. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE SOLANO COUNTY FAIR (F) AT VALLEJO, COMMENCING JULY 9 THROUGH JULY 20, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Solano County Fair (SCF) proposed to run 10 days, one day less than in 2002, for a total of 114 races. Ms. Wagner stated the first post time would be 12:15 p.m., and SCF would utilize CHRB regulations for its wagering program. She said there were no items missing from the application, and staff recommended approval of the application as presented. Vice-Chairman Harris asked how advance deposit wagering (ADW) worked with a fair that did not offer early wagering. Chris Korby of the California Authority of Racing Fairs said when the East Coast hubs opened for wagering the ADW operators were fully operational. Any individual with an ADW account could place a wager at that time.

Marv Fortman of Autotote said the Bay Meadows hub opened at 8:45 a.m., so SCF would open at 8:45 a.m. for ADW wagering. He stated the same was true for Southern California hubs. Commissioner Granzella **motioned** to approve the application for license to conduct a horse racing meeting of SCF. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE SONOMA COUNTY FAIR (F), AT SANTA ROSA, COMMENCING JULY 23 THROUGH AUGUST 4, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Sonoma County Fair (SCF) proposed to run 12 days, the same number of days as in 2002, for a total of 134 races. Ms. Wagner stated the first post time would be 12:45 p.m. daily. SCF would use CHRB regulations for its wagering program. Ms. Wagner said there were no items missing from the application, and staff recommended approval of the application as presented. Vice-Chairman Harris said he noted many associations were raising their admission by 10 to 20 percent, which seemed illogical to him as on track attendance was in decline. He stated he hoped the associations took note of the decline in on-track attendance and considered any ramifications on wagering and concession sales at the track. Commissioner Moretti **motioned** to approve the application for license to conduct a horse racing meeting of SCF. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF SAN MATEO COUNTY FAIR (F), AT BAY MEADOWS, COMMENCING AUGUST 6 THROUGH AUGUST 18, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the San Mateo County Fair (SMCF) proposed to run 12 days, the same number of days as in 2002, for a total of 124 races. Ms. Wagner stated the first post time would be 1:15 p.m. daily. SMCF would use CHRB regulations for its wagering program. Ms. Wagner said the name of the general manager and the fire clearance were missing from the application. She stated staff recommend approval of the application conditioned on the receipt of any missing items noted in the analysis. Vice-Chairman Harris asked why SMCF felt a later post time to coincide with Del Mar was not desirable. Mike Zeigler of SMCF said his organization determined it would do well with the out-of-state signal on Fridays when Del Mar was running at 4:00 p.m. Commissioner Sperry **motioned** to approve the application for license to conduct a horse racing meeting of SMCF. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE HUMBOLDT COUNTY FAIR (F), AT FERNDALE, COMMENCING AUGUST 7 THROUGH AUGUST 17, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Humboldt County Fair (HCF) proposed to run 10 days, the same number of days as in 2002, for a total of 76 races. Ms. Wagner stated the first post time would be 1:55 p.m. Mondays, and Wednesdays; 2:25 p.m. Thursdays; and 2:55 p.m. Fridays. HCF would use CHRB regulations for its wagering program. Ms. Wagner said the fire clearance was the only item missing from the application. She stated staff

recommended approval of the application conditioned on the receipt of the missing item noted in the analysis. Commissioner Granzella **motioned** to approve the application for license to conduct a horse racing meeting of HCF. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE CALIFORNIA EXPOSITION AND STATE FAIR (F), AT CAL-EXPO, COMMENCING AUGUST 20 THROUGH SEPTEMBER 1, 2002, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the California Exposition and State Fair (CESF) proposed to run 12 days, the same number of days as in 2002, for a total of 132 races. Ms. Wagner stated the first post time would be 1:00 p.m. daily, and 2:30 p.m. Fridays. CESF would use CHRB regulations for its wagering program. Ms. Wagner said the name of the placing judge and the fire clearance were missing from the application. She stated staff recommended approval of the application conditioned on receipt of any missing items noted in the analysis. Commissioner Landsburg said the fairs had a unique opportunity to capitalize on the release of Seabiscuit the movie. He stated he wished to complement the California Authority of Racing Fairs (CARF) for ensuring the fairs would capitalize on the movie in many ways. Chris Korby of CARF said his organization had a co-promotion agreement with Universal Studios which included tickets to advanced screenings. Mr. Korby said the fairs would use the tickets to promote the film and build enthusiasm among patrons. He stated CARF was also working with local theaters to cross-promote track attendance. Craig Fravel of Del Mar Thoroughbred Club spoke about Seabiscuit promotional activities planned by the National Thoroughbred Racing Association. Vice-Chairman Harris **motioned** to approve the

application for license to conduct a horse racing meeting of CESF. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

PUBLIC HEARING BY THE BOARD ON THE ADOPTION OF THE PROPOSED REGULATORY AMENDMENT TO CHRB RULE 1867 – PROHIBITED VETERINARY PRACTICES.

Jacqueline Wagner, CHRB staff, said the proposed amendment to Board Rule 1867, Prohibited Veterinary Practices, would add the possession and or use of snake and snail venom on a facility under the jurisdiction of the CHRB to the list of prohibited substances. Ms. Wagner stated no comments were received during the 45-day public comment period, and staff recommended approval of the amendment as presented. Vice-Chairman Harris **motioned** to approve the amendment to Board Rule 1867. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

PUBLIC HEARING BY THE BOARD ON THE ADOPTION OF THE PROPOSED REGULATORY ADDITION OF CHRB RULE 1979.5 – BEAT THE ODDS.

Jacqueline Wagner, CHRB staff, said the proposal would add Rule 1979.5, Beat the Odds (BTO), to the Board's rules. Ms. Wagner stated the BTO wager would require the selection of a first place finisher that was a non-favorite in three or more races on the card for a single performance. The proposed rule was heard at the January 2003 Pari-Mutuel Operations Committee meeting with the endorsement of the Los Angeles Turf Club. Ms. Wagner said staff received comments from the Southern California Horse Racing Industry Fans Committee (SCHRIFC) during the 45-day public comment period. The SCHRIFC endorsed the proposal.

Ms. Wagner said staff recommended the Board adopt the proposal as presented. James Quinn, the author of the BTO wager proposal, spoke about the wager and how he perceived it would be accepted by horse racing fans. Commissioner Landsburg asked about the proprietary element of the wager. Mr. Quinn said he held the trademark for "Beat the Favorite." If an association offered the wager under the name, "Beat the Favorite," they would have to negotiate with him. However, If an association used BTO, there would be no proprietary element. Vice-Chairman Harris said he thought the proposed wager was a good idea. He said the industry needed innovative ideas that offered the chance to win big without investing much money. He asked if the wager was being used in another jurisdiction. Mr. Quinn said the BTO would be unique to California. Bill Hoge, a racing fan and former State Assemblyman spoke in favor of the proposed BTO wager. Commissioner Landsburg asked how new fans might react when they heard the wager's rules. Mr. Hoge said expert handicappers would take immediately to the wager. He stated it would take new racing fans a period of time to learn the rules of the wager, but once they realized a lot of money could be won with little investment, they would participate. Commissioner Landsburg asked if the industry was anxious to introduce a new wager that would drain money out of the churn as well as out of their take. Rick Baedeker of Hollywood Park said he agreed the wager was probably too complicated for new fans. He said, however, new fans should not be the entire focus. The industry needed to focus on keeping existing fans, whom he believed would be interested in the BTO. Vice-Chairman Harris asked what was the denomination of the wager. Mr. Quinn said it was \$1 per combination. If one played three races, two horses in one, one in another and three in another, it would be six combinations and cost \$6. If one used one horse in each of three races, the wager would cost \$1. Frank DeMarco representing Santa Anita said his

organization endorsed the proposed wager. He stated the wager could generate new interest and should be tried. It was the wagering public that would ultimately decide if the wager was a success. Chairman Licht said he believed the wagering menu was already too confusing, with too many exotic wagers where the winnings went to too few people. He stated a \$50,000 payoff was not a good thing as it meant there were 49,999 losers and only one winner. Chairman Licht said the BTO gave an inherent advantage to big tickets if the favorite wins the first few races on a card. He stated large tickets could bombard the pool on the last few races and have an unfair advantage. Mr. Quinn said when favorites win the early races larger wagers and syndicates would enter into the pool. However, if the favorite wins any of the subsequent races the wagers were dead, so there was risk to such players. Mr. Quinn said if a large wager paid \$100,000 it would knock any of the fans out of the box as it would be constituted by literally thousands of relatively small wagers. Mr. Quinn stated such a pay out would only encourage fans to return the next day. The wager was analogous to the lottery: when a \$55 million lottery was paid, it was constituted by millions of small wagers. Mr. Quinn said the wagering public liked wagers with large pay outs. He stated the public's preference had been demonstrated empirically for years. The most popular wager in California was the Pick 6. Chairman Licht said racing was losing fans every day. He stated he believed it was because too many fans were leaving the track broke. The average lottery wager was between \$5 and \$7, but at racetracks fans were wagering over \$200 a day. When fans left the track without any of their \$200, it was a big problem. Chairman Licht asked if the Pari-Mutuel Employees Guild (PMEG) had any comments on the proposal. Ron Liccardo of the PMEG said he was not prepared to speak about the proposed wager. He stated mutual clerks often heard from new fans that they found wagering confusing. Mr. Liccardo said fans who

placed small wagers typically thought the industry was crooked. He said he saw potential for manipulation of the pools with the BTO wager, as large players could load up on a horse to make it the favorite over a horse that would have otherwise been in that position. Mr. Liccardo said he believed the wager would tie up money in the pool just like the Pick 6 – which did not have much churn. Vice-Chairman Harris said if the proposed wager was adopted by the Board, the associations must still decide if they wished to use it. He stated he believed the Board should allow tracks the opportunity to try new wagers. David Pascale of SCHRIFC said he found the learning curve on the BTO wager was short. He stated he talked to people with no knowledge of wagering and found they understood the wager after only one or two questions. Mr. Pascale said the wager was an experiment that offered a chance to bring new fans to horse racing. He stated experimentation was important and he suggested the BTO be tried. Commissioner Landsburg asked how long it would take Autotote to program the BTO. Dave Payton of Autotote said he would guess it could take a few months to program the wager. He stated Autotote's contract with California had a clause in it for programming hours, so it would not be a huge expense. The cost would come in the implementation of the wager in the system, not the programming, and would be borne by the tracks. Vice-Chairman Harris **motioned** to adopt Rule 1979.5, Beat the Odds. Commissioner Moretti **seconded** the motion, which was **not carried**. Commissioners Moretti and Granzella, and Vice-Chairman Harris voted “**aye**” and Commissioners Landsburg and Sperry, and Chairman Licht voted “**opposed**.” Chairman Licht said the proposed wager would be heard again at the next Pari-Mutuel Operations Committee meeting.

DISCUSSION AND ACTION BY THE BOARD ON THE APPROVAL OF SERVICE, OFFICIAL VETERINARIAN AND STEWARD'S CONTRACTS.

Roy Minami, CHRB staff, said the service contracts, the Teal Data Center, the Health and Human Services Data Center and the three contracts with the University of California Davis were all three-year contracts. The dollar amounts for each contract would be divided by three to arrive at the annual costs. Mr. Minami said Peter Tommila would not be a part of the Steward Services Contract. Mr. Tommila was the executive director of the California Thoroughbred Horsemen's Foundation and would no longer work as a steward unless there was an emergency. Vice-Chairman Harris asked if each individual had a contract with the Board. Mr. Minami said each individual had a contract with the Board, and that the dollar amount of the contract was encumbered in the Board's budget. Each of the individuals with contracts were not guaranteed a certain number of work days. The contract amount before the Board was based on the annual schedule for that particular racing year. The second and third years of the contracts were projected based on the current year assignments. Mr. Minami added the assignments could change at the direction of the Executive Director or the Board at any time. Commissioner Sperry **motioned** to approve the service, official veterinarian and steward's contracts. Commissioner Granzella **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF GOLDEN GATE FIELDS TO DISTRIBUTE CHARITY RACING DAY PROCEEDS IN THE AMOUNT OF \$62,500 TO 9 BENEFICIARIES.

John Reagan, CHRB staff, said staff found the request of the Pacific Racing Association doing business as Golden Gate Fields to distribute charity racing day proceeds to be in order and recommended approval. Commissioner Granzella **motioned** to approve the request of Golden Gate Fields to distribute charity racing day proceeds. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE OAK TREE CHARITABLE FOUNDATION TO DISTRIBUTE CHARITY RACING DAY PROCEEDS IN THE AMOUNT OF \$94,500 TO 22 BENEFICIARIES.

John Reagan, CHRB staff, said staff found the request of the Oak Tree Charitable Foundation to distribute charity racing day proceeds to be in order and recommended approval. Commissioner Landsburg **motioned** to approve the request of the Oak Tree Charitable Foundation to distribute charity racing day proceeds. Commissioner Sperry **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE LOS ANGELES TURF CLUB TO DISTRIBUTE CHARITY RACING DAY PROCEEDS IN THE AMOUNT OF \$259,121 TO 24 BENEFICIARIES.

John Reagan, CHRB staff, said staff found the request of the Los Angeles Turf Club (LATC) to distribute charity racing day proceeds to be in order and recommended approval. Commissioner Landsburg **motioned** to approve the request of the LATC to distribute charity racing day proceeds. Commissioner Granzella **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON AUTOTOTE'S EFFORTS ON THE DEVELOPMENT AND IMPLEMENTATION OF SOFTWARE THAT WILL ALLOW THE "ALTERNATE RUNNER" OPTION FOR MULTIPLE LEG WAGERS IN CALIFORNIA.

Dave Payton of Autotote said the Pick 6 scandal of 2002 resulted in the loss of the alternate runner selection. He stated in restoring the selection, Autotote worked with the industry to ensure the pools were dealt with in a manner that would be agreeable to all concerned. Autotote was working with the Tote Standards Committee of the Association of Racing Commissioners International. Specifications for the alternate runner selection were prepared and submitted to the committee for review. Mr. Payton said the review would allow Autotote to receive the approval from the regulators on the committee and the other totalizator companies. He commented the review would take three to four weeks to complete. Another four to six weeks would be needed to program and test the system, as well as another week or two to deploy the program. Mr. Payton said the software should be in place for Oak Tree's opening. Chairman Licht said the Board was told in January 2003 the software would be up and running by March at the latest. He stated a six or seven month delay was discouraging. Mr. Payton said the implementation was delayed by the work on the leg scan for the Pick 6. Chairman Licht asked if any of the tracks could say there had been a fall of in Pick 6 wagering due to there being no alternate runner. Rick Baedeker of Hollywood Park said there had been only sporadic complaints. He stated the Pick 6 was difficult to evaluate because in 2003 there had been fewer carryovers compared to 2002.

DISCUSSION BY THE BOARD ON THE WAYS TO IMPROVE THE LICENSE APPLICATION AND TO REVIEW THE CURRENT REQUIREMENTS NECESSARY FOR CONDUCTING A RACE MEETING.

Commissioner Landsburg said the committee was looking at what could be included in the license application to better protect, and ensure the survival of racing. He stated the license application had become traditional and the committee was concerned that there might be much in it that was not necessary, and not enough of what was necessary for the Board to effectively carry out its constitutional mandate. Commissioner Landsburg said the committee asked the industry for input regarding the content of the application, however, not a single response has been received. Commissioner Landsburg outlined the committee's concerns regarding the license application - including a requirement that associations align themselves with any advance deposit wagering entity to increase handle. There were also concerns about the television presentation at the track, the adequacy of the totalizator boards, and the level of backside video cameras for security purposes. Vice-Chairman Harris said it was disappointing that the tracks had yet to provide any type of commentary, as the committee had hoped to make the license application review an interactive process.

PRESENTATION BY WINNERS FOUNDATION STAFF.

Nora Lee of the Northern California Winner's Foundation (WF) spoke about the WF in Northern California, its purpose, and how it functioned at the various racetracks. Mike Zeigler of Bay Meadows and Golden Gate Fields said three days prior to the national release of the Seabiscuit movie a pre-release screening would be held in Alameda with the proceeds benefiting the WF. Chairman Licht asked how large the WF staff was in Northern California

and how many employees were involved. Ms. Lee said there were two staff persons in Northern California. The staff covered the major tracks and the fairs. The permanent WF offices were located at Golden Gate Fields, Bay Meadows and Pleasanton.

GENERAL BUSINESS

Chairman Licht said the Daily Racing Form (DRF), in line with much of what the Board requested, had virtually eliminated the off-shore gaming advertisements. He stated it was a major plus for the industry and the DRF deserved recognition for its action. Chairman Licht stated people might have read about the ongoing investigation that was being conducted on Hollywood Park's backside. He stated the Board's investigators had done a tremendous job and Hollywood Park was very cooperative. Chairman Licht said Del Mar had indicated it would be as cooperative. Commissioner Landsburg said he was concerned with how horse racing marketed itself. He stated there was a California Marketing Committee in which the Board had input, but he believed there needed to be a broader view of the way in which California racing marketed itself. Commissioner Landsburg said he would request an ad-hoc committee be formed to review all the marketing. He stated he thought it was time a committee which was not necessarily all racing related personnel get together to make some reasonable recommendations to the Board and to the industry in general. Chairman Licht said he would be pleased if Commissioner Landsburg would chair such a committee. Vice-Chairman Harris said he would serve on the ad-hoc committee. Ed Halpern of California Thoroughbred Trainers said his organization would hold a Seabiscuit premier in Southern California with the proceeds going to the McBeth Fund and the Gregson Fund. John Van de

Kamp of Thoroughbred Owners of California (TOC) said he would like to commend the industry for coming together to put a workers' compensation package together for 2003. He stated the program was working well, and it looked like it would be in place for a second year. Mr. Van de Kamp said TOC received a memorandum from the Race Dates Committee that asked for recommendations for the 2004 racing calendar. He stated the deadline for recommendations was July 7, 2003. Mr. Van de Kamp said TOC's Board would not meet until July 11, and asked for an extension of the deadline until July 15, 2003. Chairman Licht said July 15 was fine. Rick Baedeker of Hollywood Park said the Hollywood Park Gold Cup would run July 13, 2003. Mr. Baedeker said Lafit Pincay would also receive recognition on July 13 in honor of his career and his retirement.

Dear Chairman Phillips:

I am in receipt of a letter sent to your attorney Jeremiah Blair from Mr. Dale Campbell, a copy of which is enclosed for your review. In short, his analysis of state law indicates that Cal Expo's action to rescind contract 1986 was appropriate, and concludes that Cal Expo has no exposure in the present litigation instituted by Capital Racing Association. The law on this issue is quite clear. As Mr. Dale Campbell states in his letter:

“One dealing with public officers is charged with the knowledge of, and is bound at his peril to ascertain, the extent of their powers to bind the state for which they seem to act and, if they exceed their authority, the state is not bound thereby to any extent. (*Mullan v. State of California* (1896) 114 Cal. 578, 587; see also *Bear River Sand and Gravel Corporation v. County of Placer, supra*, 118 Cal.App.2d at 690.) Therefore, not only should Capital Racing not prevail in its action, Capital Racing should be compelled to disgorge to Cal Expo all revenue it receives under any illegal [contract]. (*Id.* At 411-412; see also *Pac. Inter-Club Yacht Assn. v. Richards* (1961) 192 Cal.App.2d 616, 619-620.)”

It should also be noted that Capital Racing is presently operating under an illegal contract. Under the terms of the original RFP that awarded the contract to Capital Racing, the contract could not be extended beyond December 31, 2002. Consequently the extension to July 2003 may be void.

It would appear that a reasonable approach to this dilemma is to notify all known interested parties and request bids to conduct the meet for one (1) year to commence after the existing contract terminates in July. You could simplify the bidding process by using

the existing contract and simply having the interested parties enter the amount they will pay Cal Expo on a daily basis. In my opinion, that amount may very well reach Twenty Thousand Dollars (\$20,000.00) daily which is a Fourteen Thousand Dollar (\$14,000.00) daily increase over the existing agreement.

I would hope you would consider this suggestion.

I am aware of the problem you are having with the existing contract at Cal Expo, and the litigation filed by Capital Racing Association. I recently received a copy of an opinion letter from Mr. Campbell of the law firm of Weintraub Genshler Chideak Sproul regarding Cal Expo's contract with Capital Racing Association and I am enclosing a copy for your review. I also have been informed that Capital Racing request for a ex party Temporary Restraining Order was denied by the court.

You are very familiar with my background in harness racing, my qualifications as an operator, know I have successfully conducted harness race meets at Cal Expo and Los Alamitos, and that I was a part owner of Los Alamitos Race Course. In light of the multitude of problems, including those with the present operator, I believe that the best thing for Cal Expo and the harness industry is for Cal Expo to conduct the fall harness meet. Having said that, I would be willing to operate the harness racing meet on an interim basis, until Cal Expo can get into a position to put out a RFP or Cal Expo being able to conduct the race meet. I would donate my services for that short period of time. All profits generated would be made available to charitable institutions. It is my hope that you would also consider alternatives interm operators including Mr. Coffee, Mr. Kouretas, Magna Corporation, Los Alamitos Race Course, Rick Caine or anyone else who has exhibited an interest.

I do not think it appropriate to enter into a new lease with the existing operator simply because Cal Expo is being sued by Capital Racing. Let the court decide if their lawsuit as merit. Based on the enclosed opinion I do not think it has merit. If Cal Expo made an inadvertent mistake at a cost of millions of dollars, don't you think this should be investigated by the Little Hoover Commission, and if so, those responsible should be terminated by Cal Expo. If this happened in the business community, heads would be rolling.

If you decide to extend Capital Racing's contract, you should fight the litigation. If Capital Racing loses the lawsuit it will be required to return all profits to Cal Expo earned


I have indicated to your Board that I am interested in conducting the harness racing meet at Cal Expo. I would be responsive to entering into a contract with the Board for the fall meet of 2003. The contract could be for just the Fall meet or for an extended period, at your discretion. There have been indications in the press that you are going to advertise, immediate, for the Request for Proposals for the 2004 meets. If that is the case, my organization would be willing to enter into a sole source contract with you to fill the void until a contract is awarded as a result of the Request for Proposals.

I am familiar with the Capital Racing Association lease and would be willing to operate under the same terms. If given the opportunity to operate under that lease, in addition to the rent, I would be willing to contribute One Million Five Hundred Thousand (\$1,500,000) Dollars to Cal Expo's homeless program. BACKGROUND

Business and Professions (B&P) Code Section 19440 provides that the responsibilities of the Board shall include adopting regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. B&P Code Section 19590 states the Board shall adopt rules governing, permitting, and regulating mutuel wagering on horse races under a system known as the pari-mutuel method of wagering.

At the April 23, 2003 Pari-Mutuel Operations Committee meeting, a proposal to amend Rule 1979.1, Superfecta, was heard. The industry requested that the Board delete the requirement that the entire Superfecta pool be refunded if less than five wagering interests finish the race. At the April 24, 2003, Regular Board Meeting, staff was directed to initiate a 45-day public comment period for the amendment of Rule 1979.1.

ANALYSIS

The amendment to Rule 1979.1 will eliminate the requirement that if less than five wagering interests finish the race, the entire Superfecta pool will be refunded. The industry requested this provision be eliminated as it has, on occasion, caused confusion and disappointment among horse racing fans. In cases where only four horses finish the race, persons holding tickets correctly selecting the four finishers may think they have won the wager, but find instead the wager has been canceled. In January of 2002 a similar requirement was deleted from Board Rule 1979, Trifecta. To date there have been no adverse incidents as a result of the change in the rule.

During the 45-day public comment period the Southern California Horse Racing Industry Fans Committee (SCHRIFC) endorsed the amendment to Rule 1979.1.

RECOMMENDATION

The proposal to amend Rule 1979.1 was presented and approved for notice at the April 23, 2003, Pari-Mutual Operations Committee Meeting. Comments were received from the SCHRIFC during the 45-day public comment period.

Staff recommends the Board adopt the amendment to Rule 1979.1 as presented.

1979.1. Superfecta.

(a) The Superfecta is a separate pari-mutuel pool established on a single race. The pool consists of amounts wagered on horses to finish first, second, third, and fourth in that exact order. It is not a parlay and has no connection with other pools conducted by the association or to rules governing the distribution of other pools.

(b) A valid Superfecta ticket is evidence of a binding contract between the holder of the ticket and the association and constitutes acceptance of Superfecta provisions and rules contained in this article.

(c) No Superfecta pool shall be established for a race with less than eight wagering interests scheduled to start when the Superfecta pool opens for wagering in California. A wager on a coupled entry or field is considered a wager on the remaining part of the coupled entry or field if any part of the entry starts for pari-mutuel purposes under Rule 1974 of this division.

(d) After the stewards' official order of finish is posted, the association shall distribute the net pool to holders of valid tickets that select the first, second, third, and fourth finishers.

(e) In a dead heat for first, second, or third position, only tickets selecting the correct order of finish for the first four finishers shall be winning tickets; that is, two horses in a dead heat for first shall be first and second, in either position; two horses in a dead heat for second shall be second and third, in either position; and two horses in a dead heat for third shall be

third and fourth, in either position. In a dead heat for fourth, tickets with the correct first, second, and third selection and one of the two horses in the dead heat for fourth shall be winning tickets. In a triple dead heat for first, tickets selecting the three horses in the dead heat, regardless of the order of selection, and the horse finishing fourth shall be winning tickets. In a triple dead heat for second, tickets with the correct first selection and all three horses in the dead heat shall be winning tickets. In a triple dead heat for third, tickets with the correct first and second selection and two of the three horses in the dead heat shall be winning tickets. In a triple dead heat for fourth, tickets with the correct first, second, and third selection and one of the horses in the dead heat shall be winning tickets.

(f) If no ticket selects the first, second, third, and fourth position, the net pool shall be paid for tickets that select first, second, and third. If no ticket selects first, second, and third position, the net pool shall be paid for tickets that select first and second. If no ticket selects first and second, the net pool shall be paid for tickets that select first. The association shall refund the entire pool if no ticket selects first ~~or if less than five wagering interests finish the race.~~

(g) If the stewards scratch a horse before wagering is closed, the association may exchange any ticket that includes the scratched horse. After wagering is closed, tickets selecting a scratched horse or a horse the stewards declared a nonstarter shall be eliminated from the pool and the purchase price refunded.

BACKGROUND

Business and Professions (B&P) Code Section 19440 provides that the California Horse Racing Board (Board/CHRB) shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of the Horse Racing Law. Assembly Bill (AB) 471, Chapter 198, Statutes of 2001, became effective January 1, 2002. AB 471 amended B&P Code Section 19481.5 to provide that the Board adopt emergency backstretch worker housing regulations within 120 days of the effective date of the statute. In response to AB 471, the Board adopted as emergency regulations Article 28, Backstretch Worker Housing, and amended Rule 1928, Fire Regulations.

ANALYSIS

Article 28 and the amended Rule 1928 have been in effect since May 7, 2002. During that time staff has inspected California's backstretch housing with the emergency housing regulations as a guide. All racing facilities have been found to be in compliance with the provisions of the Article. AB 471 provided that the Board had 18 months following the implementation of emergency regulations in which to make such regulations permanent. In keeping with the statutory time frame, Article 28, and the amendment to Rule 1928, were noticed to the public for a 45-day comment period. During that time no comments were received.

RECOMMENDATION

Staff recommends that the Board adopt the proposed regulations as presented.

- (c) “Damaged” means property in a condition in which its worth or usefulness is impaired. Damage includes, but is not limited to backstretch worker housing whose components are split, buckled, sagging, rotting, broken or defective.
- (d) “Substandard housing” means backstretch worker housing or a habitable room, or any portion thereof, which through lack of maintenance or repair there exists any of the following conditions to an extent that endangers the health, safety or welfare of the occupants.
- (1) Lack of toilet or privy structure, bathtub or shower, or hot and cold running water.
 - (2) Plumbing fixtures and piping which have become unsanitary or damaged.

- (3) Lack of exterior wall or roof covering adequate to protect the occupants from the elements.
- (4) Damaged exterior wall or roof coverings.
- (5) Damaged windows, exterior window coverings, or doors.
- (6) Lack of natural light and ventilation.
- (7) Damaged interior walls, ceilings or floors.
- (8) Lack of interior flooring adequate to protect occupants from the elements.
- (9) Dampness of habitable rooms.
- (10) Lack of garbage and rubbish removal as required under Rule 2105 of this article.
- (11) Infestation of insects, rodents or other vermin.
- (12) Lack of smoke detector in working order, or other fire alarm system as required under Rule 1927 of this division.
- (13) Lack of emergency evacuation plan as required under Rule 1928 of this division.

This subsection shall expire December 31, 2003.

(a) Associations and racing fairs that provide backstretch worker housing shall, at least annually, submit to an inspection of such housing. The inspection shall be conducted by a designated representative of the Board with assistance from the California Department of Housing and Community Development or a local housing authority for the jurisdiction in which the track is located. This subsection shall become operative January 1, 2004.

(b) Racing Fairs with race meetings of 19 days or less shall comply with this section contingent upon the provisions of Business and Professions Code Section 19481.5(b)(3).

(c) No license to conduct a horse racing meeting shall be issued unless the applicant association's backstretch worker housing is found to be in compliance with the standards established in this article. This subsection shall become operative January 1, 2004.

- (a) Habitable rooms used for sleeping shall have natural light by means of at least one exterior window that, if it can be opened, has screening with a tight fitting frame. Natural ventilation shall be provided by exterior openings that can be opened, or in lieu of exterior openings a mechanical ventilating system.
- (b) Habitable room exterior doors shall be tight fitting and outfitted with door sweeps.
- (c) Interior walls, ceilings and floors of habitable rooms may not be damaged or cause exposure to outside elements or exposed earth.
- (d) Habitable rooms shall be provided with electrical switches, outlets and at least one electric light. Electric components in a habitable room shall be installed to state or local building codes and maintained in a manner that does not endanger the health or safety of the occupants.
- (e) Habitable rooms used for sleeping shall be provided with a battery operated smoke detectors which shall be maintained in working order, or any other approved fire alarm system as provided under Rule 1927 of this division. Fire regulations and an emergency evacuation plan shall be posted in backstretch worker housing areas as provided under Rule 1928 of this division.

(f) The dimensions of a habitable room shall not be less than seven feet in any direction and shall provide not less than 50 square feet of space per person.

(b) ~~Such~~ The notices shall be in English and Spanish, and posted no more than 100 feet apart or as approved by the local fire authority.

(c) No person shall violate the posted fire regulations.

BACKGROUND

In 1993 and 1997 Breeders' Cup, Ltd. requested exceptions to or waivers of a variety of Board's rules and regulations. Over time, some of the Breeders' Cup concerns have been addressed by amending or repealing various rules, or by the Board authorizing staff to take administrative action. In anticipation of a request by the Breeders' Cup, staff recommends three rules be waived.

ANALYSIS

- A. Issue: **Rule 1481, Occupational Licenses and Fees.** In previous years, Breeders' Cup has requested that the Board authorize a special license of reduced duration and cost for the event. Since 1986 the Breeders' Cup has requested that any such license be effective for at least 30 days and cost no more than one-third of the normal license fee.

Rule and application: Rule 1481 establishes the duration and fees of occupational licenses for persons desiring to participate in California racing on an ongoing basis; however, it is silent on special events such as Breeders' Cup. Historically, the Board has approved a special Breeders' Cup license which is valid through December 31 of the event year, and costs one-third of the fee specified in Rule 1481. Due to its past experience in California, the Breeders' Cup has already indicated that an owner or trainer license, valid through December 31, 2003, would cost \$50.00.

RECOMMENDATION

Staff recommends the Board approve a waiver of Rule 1481 for the 2003 Breeders' Cup.

- B. Issue: **Rule 1554, Duties of Horse Identifier.** Breeders' Cup has previously requested that all horses shipped from Europe to participate in the Breeders' Cup event be allowed to race without an identifying tattoo.

Rule and application: Rule 1554 provides that any horse within the inclosure, which has not been identified in California, shall be properly identified prior to competing. The rule also states that the horse identifiers shall supervise the tattooing or branding of any horse

within the inclosure. In previous years the horse identifier has requested that, prior to racing, arrangements be made for a horse to be identified and photographed without bandages if it is permitted to race without being tattooed.

RECOMMENDATION

Staff recommends the Board approve a waiver of Rule 1554 for the 2003 Breeders' Cup.

- C. Issue: **Rule 1693, Control of Horses and Jockeys on Entering the Track**. Breeders' Cup has previously requested that human attendants escort horses onto the track until the finish of the post parade and, if requested, the attendants be allowed to be present at the starting gate.

Rule and application: Rule 1693 prohibits attendants once the horses are on the track. In previous years, racing secretaries and starters have agreed to allow human attendants to accompany horses until the close of the post parade, but have opposed any attendants being present at the starting gate. The main concern is safety. In California there are sufficient assistant starters who are trained to deal with horses in the starting gate.

RECOMMENDATION

Staff recommends the Board approve a waiver of Rule 1693 for the 2003 Breeders' Cup.

MERGER OF OUT-OF-STATE POOLS

REGULAR BOARD MEETING
JULY 24, 2003

Background:

In the recent past there have been several occasions when large, last minute wagers from some out-of-state simulcast sites have caused significant drops in the odds at California host tracks. One notable example was the first race on opening day at Hollywood Park in April 2002. A last minute wager of approximately \$110,000 on the winning runner from the Racing and Gaming Services (RGS) offshore simulcast site caused a sharp drop in the odds on the winning runner just as the race began. The drop in odds (from 5-1 to 2-5) became evident as the race progressed and was very sensational leading to an investigation of the matter. It was determined that the wager had been placed prior to the commencement of the race but had arrived "late" in the Hollywood Park pools due to the time required to process the wager through the interstate totalizator hub system. This technological built-in delay in processing last minute wagers via the tote hub system was the subject of a public service video recently produced by Commissioner Alan Landsburg and presented at the April 2003 Board meeting.

More recently, the Shoemaker Mile in May 2003 suffered some noticeable drops during the final odds cycle when large wagers from the Oregon wagering hub and RGS hit the California pools. Once again, a review of the matter showed that the wagers were made prior to the commencement of the race and were only "late" due to the processing time required. In between these two examples were other cases such as the one on December 19, 2002 when the odds on the winning runner in Race 6 went from 24-1 to 12-1 during the final odds cycle. The resulting review indicated that once again late money from out-of-state sites (mostly RGS) caused this late shift in the odds.

The perception that this issue creates among certain racing fans is that money is being wagered after the race commences. Numerous "solutions" to the problem have been suggested. From the extreme action of dropping some simulcast sites that regularly are involved in these incidents to requiring those and other selected sites to close their wagering on California pools early (one minute before post or when the first horse enters the gate, etc.) to doing nothing have all been suggested as courses of action with regard to this matter.

The Pari-mutuel Operations Committee has discussed this issue on several occasions. In fact, during those discussions, staff has proposed temporarily suspending the wagering at some sites and evaluating the results after an appropriate period of time has passed. The Board may wish to hear from the Committee as well as industry representatives with regard to this matter.

BACKGROUND

Board Rule 1663, Entry of Claimed Horse, Currently provides that a horse claimed out of a claiming race is eligible to race at any racing association in California immediately after being claimed. The rule also provides that a horse claimed out of a claiming race is not eligible to start in another claiming race for 25 days for less than 25% more than the amount for which it was claimed. No horse is eligible to race in any state other than California until the close of the meeting where it was claimed, except in a stakes race. Only standardbred horses are exempt from the 25-day, 25% provision.

In July 2000, the Security and Licensing Committee heard a proposal to amend Rule 1663. California's racing secretaries, with the support of Capitol Racing Association and the California Harness Horsemen's Association, requested that Rule 1663 be amended to provide that a horse claimed out of a claiming race is ineligible to race in any other state until 60 days after the close of the meeting at which it was claimed. The object of the proposed amendment was to keep claimed horses in California. The proponents of the amendment maintained that horses claimed in California were being shipped to other jurisdictions, which resulted in fewer horses and short fields in California.

At that time, the Thoroughbred Owners of California (TOC) opposed the amendment on the grounds that it would restrict an owners ability to use his property to his best advantage. The TOC representative stated that if an owner wished to claim a horse in California and send it out of state, he should be able to do so. Additionally, the 60-day "jail time" could be a violation of the interstate-commerce clause of the constitution. The industry continues to be concerned about claimed racehorses being shipped to other jurisdictions at the end of the meeting where they were claimed as the practice may contribute to a shortage of horses at subsequent race meetings.

BACKGROUND

Board Rule 1682, Weighing Out, provides that a jockey shall be weighed out by the clerk of scales no more than one hour preceding the time fixed for the race. The jockey must declare any overweight in excess of one pound to the clerk of scales. Such information and any change to jockeys must be posted for public information and announced over the public address system. Board Rule 1683, Maximum Overweight, states that no horse shall carry more than two pounds overweight without consent of the owner, his agent, or representative. Nor shall a horse carry more than seven pounds overweight in any race. Board Rule 1684 provides that a jockey's weight includes riding clothing, saddle and pad. A jockey's weight shall not include safety helmet, safety vest, whip or the horse's bridle. Board Rule 1701 states that when a jockey weighs in after a race, he shall not weigh less than one pound of his proper weight, nor two pounds over; however, the stewards may take into account any excess weight caused by rain or mud.

Recent observation of jockeys weighing out and weighing in has raised questions regarding the accuracy of traditional scales. Unless one is familiar with the use of traditional scales they can be difficult to read and cumbersome when attempting to determine the weight of items such as safety vests. The issue was last discussed at the Regular Board Meeting of October 17, 2002. Board staff presented a report that included the results of a three week audit of jockey scales at Del Mar Race Track. Although the results of the audit showed compliance in the established and accepted procedures, staff recommended that all tracks consider the use of digital scales. Staff reported digital scales were easier to read than traditional scales, and were just as accurate. Staff cautioned, however, that no research had been completed regarding the adaptability in all types of weather of electronic digital scales on the track.




















